1           **WHEREAS**, pursuant to Section 603 of the Howard County Charter and Section 22.404  
2 "Contents of the Capital Budget and Capital Program and the Extended Capital Program" of the  
3 Howard County Code, the County Executive has submitted a Capital Budget Detail for Fiscal Year  
4 2027, a Capital Program for Fiscal Years 2028 through 2032 and an Extended Capital Program for  
5 Fiscal Years 2033 through 2036, indicating the plan of the County to receive and expend funds for  
6 capital projects, and specifically listing, for each capital project, the information required by  
7 Section 603(b) of the Howard County Charter and Section 22.404(e) of the Howard County Code.

21 ending June 30, 2028, 2029, 2030, 2031, and 2032 and the Extended Capital Program for the fiscal  
22 years ending June 30, 2033, 2034, 2035, and 2036, attached to this Resolution, all subtotals, totals,  
23 and other calculated figures shall be corrected to accommodate amendments to this Resolution.
