Howard County Council,

I urge you to adopt bills CB16-2026 & CB17-2026.

My high school Chemistry Teacher was fond of telling us when presented with a particularly hard problem to "find the concrete" - What's concrete? Stuff you put in to make a problem harder. Once we identified the extraneous, the problems were easier to identify and solve.

Immigration is a problem that has been filled with "concrete", and I believe I can simplify.

To whit, that which is abhorrent to be done to you, do not subject to another.

Are there any circumstances where you would assent to you or a family member to be taken at an unexpected time, rendered without due process, separated from your home and community, and cast out to an unfriendly foreign land?

The answer is of course no. So those who wish to do it anyway resort to labeling some other group as somehow subhuman or inhuman.

In the abrahamic religions it is stated that the original sin is Adam & Eve eating from the tree of knowledge; I contend that the original sin, or "fundamental problem of humanity" is better expressed in the story of Cain and Abel. Cain convinced himself that he had no obligation to protect and care for his brother, and in doing so found it easy to murder him. Dehumanizing others, and abandoning our responsibility to them is the fundamental flaw of humans and one we must overcome.

Therefore the danger is, when you start dehumanizing some you create the mechanisms that will eventually be used to dehumanize you. When dehumanization is invoked, the immediate necessary action is to circle the wagons around all of humanity. None of us are free unless all of us are free. An attack on the humanity of any group, represents an imminent attack on the humanity of all.

Therefore, we cannot participate in Stephen Miller's inhumane campaign on our neighbors. All children are our children. All families are our family.

A common thought exercise when learning about the Holocaust is to confront how easy it was for German citizens to go along with the genocide, in an attempt to save themselves, or just not deal with reality. We are being given an unwelcome (but it seems, necessary) opportunity to find out what we would have done.

I stand for humanity, our neighbors, and in opposition of those who would set us upon our brothers and sisters. ICE detention centers have no place in Howard County. Never Again means everyone, and Never Again is now!

Dear Howard County Council Members,

I'm writing as a long-time resident of [REDACTED] and a small business owner in Howard County to express my strong support for Bill 16-2026 and Bill 17-2026 -- I understand you will vote on these bills tomorrow as part of emergency legislation.

After reviewing the text of both bills, I appreciate the Council's proactive approach to protecting the health, safety, and welfare of Howard County residents.

Bill 16-2026 appropriately amends the Howard County Building Code to ensure that Institutional Group I-3 facilities -- such as detention centers -- may only be permitted, owned, or operated by government entities, and not private actors. Given the serious oversight, safety, and humanitarian concerns associated with the existing ICE detention facilities, I feel that it is both reasonable and necessary that decisions regarding their permitting and operation remain under local governmental oversight rather than private or for-profit control, as the bill provides. This approach ensures accountability, transparency, and community safety while preventing the establishment of privately operated detention centers in Howard County.

Bill 17-2026 further strengthens county protections by requiring clear guidance for county employees regarding immigration enforcement activities, limiting ICE access to non-public county facilities without a judicial warrant, prohibiting the use of county property for civil immigration enforcement, and declaring contracts supporting such enforcement void as against public policy. The bill's findings regarding rising detention numbers, deaths in custody, and the disproportionate impact on individuals without criminal records are deeply concerning and warrant immediate local action.

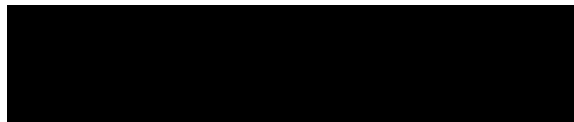

I strongly urge the passing and implementation of both bills, CB16-2026 and CB-17-2026, to protect our neighbors and community from the lawless acts of ICE and its seeking to open private detention centers in Howard County.

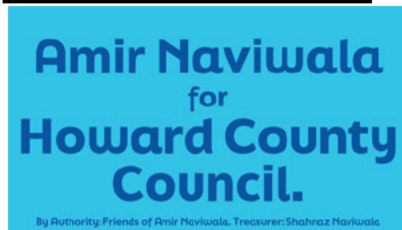

# Testimony in Support of Council Bill 17–2026

Good evening Chair, Councilmembers, and County Executive.

My name is Amir Naviwala. I'm a candidate for Howard County Council District 3, and I'm here in strong support of Council Bill 17.

CB17 is not about defying federal law. It's about **clarity, boundaries, and responsible governance** at a time when immigration enforcement activity has intensified rapidly—nationally and here in Howard County.

The facts matter. Detentions are at record highs. Deaths in ICE custody have increased. And locally, arrests have risen sharply, with many involving people who have no criminal record. That creates real fear and uncertainty for families, workers, and communities.

CB17 responds in a careful and lawful way.

First, it requires the County Executive to publish **clear guidance** for county staff. That protects frontline employees from having to make legal decisions on the spot and reduces liability for the County.

Second, it sets firm rules for **county facilities and property**—making clear that non-public areas are not open to civil immigration enforcement without a valid judicial warrant, and that county-owned property cannot be used as staging areas unless legally required.

Third, it declares contracts that directly support civil immigration enforcement **void as against public policy**, ensuring county resources are not used beyond what the law requires.

Importantly, CB17 respects federal and state preemption and does not interfere with criminal law enforcement.

This bill strengthens public trust, protects public health, and provides consistency where confusion currently exists. Given the pace of recent enforcement activity, treating this as an emergency measure is appropriate.

For these reasons, I urge your support of Council Bill 17.

Greetings.

I wish to express my support for the emergency council bills 16 & 17. At the same time, both bills are woefully insufficient, and very late. Having had knowledge of the intent to convert a warehouse into a concentration camp as early as August of last year, such a thing should have been rejected far earlier. I'm disappointed, but not surprised at the emphasis on procedure rather than protecting the residents of the county. ICE, CBP, and DHS have been responsible for the murder of multiple people for most of their existence, through multiple administrations. There are documented cases of rape, sexual abuse, medical neglect, disappeared people, physical abuse, and unexplained deaths of detainees by ICE and the like. This information can be found in various corporate media outlets, from MSN to ABC, as well as organizations like the ACLU. There are also several cases of people impersonating ICE agents to abduct people, making the existence of such shady organizations even more dangerous for everyone.

This is not just a Trump issue, as images of Border Patrol agents on horseback, assaulting Haitian migrants occurred under the Biden administration. This is a human issue. Nobody deserves to be warehoused in a concentration camp for a minor civil violation. For a county that loves to tout that it was once voted "Best County," the willingness to work with repressive, reactionary organizations speaks to the hollowness of such an award. It is an embarrassment. These are dangerous agencies with well documented human right abuses, and these bills fail to address the threat these agencies pose to the people. 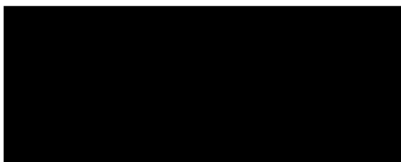

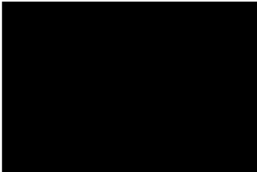

Thank you for supporting the CB16 initiative and for supporting the revocation permits for a private ICE detention facility in HC.

Regarding CB17, I have some concerns / questions. I think it puts too much pressure and onus on county employees to deal with potential ICE interactions. I'm imagining any of the employees at the Roger Carter Center where I swim having to fulfill the obligations set forth in the bill and refuse to cooperate with ICE. As an employer myself, I can't imagine forcing my employees to do such a thing. To not cooperate with armed Federal agents? It's one thing on your own time but if you're not wearing a uniform yourself and you're at work at the front desk of the pool or any other county facility - I think this is too much to ask of most County employees. Even with a designated ICE liason at each facility / public building - what if that person is on vacation or out sick and someone else has to manage the matter? The amount of training involved in this would be extremely intense. Employees would also have to report to their supervisors and higher ups if they see ICE activity on county property - what if they have reason to be concerned about getting involved - would their non-compliance would be punitive? I agree with posting signage saying ICE is not welcome at identified public buildings and parking lots but a lot of the remaining part of the bill doesn't seem feasible to enforce and makes me concerned for the county employees that would need to abide by it.

Good evening,

I hope it's not too late to be sending this and I hope that you are having a great day.

My name is Stephanie Greco and I'm a single mother to a 7-year old girl. We live less than 2 miles from where ICE was attempting to build a facility.

I sincerely hope that the emergency legislation that was proposed on Monday is passed and that the facility cannot be built. I am deeply concerned and worried about the damage that could be caused to the community on so many different levels. I worry about my safety, my daughter, and all of her friends. Devastating loss and damage occurs everywhere that ICE goes and it leaves destructive wakes in its path that can be felt all across the nation. I have friends that are scared to leave their homes and this is without the facility in Elkridge. I cannot fathom what it will be like if the facility is built.

I am a Licensed Behavior Analyst and work with Autistic children, primarily under the age of 5 and are nonverbal. Most of my client base is within 15 minutes of Elkridge and a lot are minorities. I worry about them on a daily basis for many different reasons, but knowing that ICE has a history of using children as bait by kidnapping them and holding them hostage ([example](#), the 5 year old girl with ASD in MA last September) makes everything worse. As a professional, I should not have to be working with my families to create emergency cards and contingencies in case ICE takes their children. I should not have to be creating behavior protocols designed to keep nonverbal children as compliant as possible so that they do not get harmed by aggressive and violent ICE agents. If this facility comes to our community, my clients will not be safe. My daughter will not be safe. Rockburn Elementary School is less than 2 minutes from the proposed site. I'm not sure if you are aware, but many children with IEP's in the area get sent to Rockburn instead of their home schools because it has more resources and staff to better assist the children. This increases the danger risk to these children and their families.

Unfortunately, I cannot attend in person today to aide the community in protesting the construction of this facility. I've asked dozens of people within Howard County, out of the county, and out of the state to aid in making sure the facility does not get built.

I will happily provide any additional support to make sure our community stays safe and free of a facility, as well as anywhere else in Maryland.
