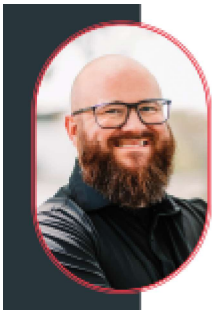

We are writing to express strong support for the development of a new indoor ice rink in Howard County. This project represents a timely and strategic investment in community recreation, youth development, and local economic vitality. A new rink is an investment in the quality of life for Howard County. Specifically, we strongly urge you to move forward with the capital budget plans to make this new rink a reality.

Howard County is losing money due to the lack of sufficient ice time within the county. Currently, Howard County only has a single ice rink owned by Columbia Association to serve a growing and diverse population of skaters. While the Columbia Ice Rink offers figure skating, demand outstrips the availability of ice. As such, figure skaters and the Columbia Figure Skating Club buy ice and supports businesses in Anne Arundel County (Piney Orchard Ice Rink) and in Prince George's County (Garden's Ice House.)

[We are anecdotally aware that the ice hockey programs in Howard County similarly spend money outside of Columbia Ice Rink to meet the needs of their programs.]

The figure skating community in Howard County is strong and robust. With every hour of ice time purchased outside of Howard County, there are purchases made at restaurants, small shops, and grocery stores by the family members of skaters. Over 50% of the members of Columbia Figure Skating Club do

not live in Columbia; they reside in western Howard County and Ellicott City. There is an unmet need. Meeting this need within the county supports the quality of life for residents – both within Columbia and elsewhere in Howard County.

Beyond recreation, the proposed rink would provide meaningful benefits to the broader community. Expanded ice capacity would strengthen local youth sports programs, support healthy and active lifestyles, and create a welcoming space for families and community gatherings. In addition, a new rink would generate positive economic impacts by attracting regional tournaments and competitions – both hockey and figure skating, increasing local spending, and creating both construction and ongoing operational jobs.

Investing in a new indoor ice rink is an investment in Howard County's quality of life. Thus, we urge you to support the planning and development of this project.

Dear Council Members,

I am writing to express my enthusiastic support for the proposed Meadowbrook Ice Rink facility. Specifically, I urge the Council to approve the Meadowbrook Ice Rink project.

Howard County is currently experiencing a significant deficit in recreational ice compared to our neighbors. While we have grown into one of the premier counties in the state, our infrastructure for ice sports has not kept pace. To illustrate the gap, consider the number of ice sheets available in our

surrounding jurisdictions:

Montgomery County: 6

Prince George's County: 6

Anne Arundel County: 3

Baltimore County: 3

Baltimore City: 2

Frederick County: 2

Howard County: 1 (closed in the summer)

The Howard County Youth Hockey Club (HCYHC), for example, has outgrown its local infrastructure. Currently, the club must split its operations between the Columbia Ice Rink and The Gardens Ice House in Prince George's County. By building two rinks, the county would immediately secure an anchor tenant that currently spends hundreds of thousands of dollars outside our borders. A second sheet of ice allows our county to "reclaim" that revenue, ensuring local sports dollars stay within Howard County to support our own infrastructure and services.

Furthermore, the economic benefits extend far beyond hockey registration fees. The HCYHC already hosts a massive annual tournament bringing over 2,500 players to the region. Currently, the majority of the tournament games and local hotel options are outside of Howard County. With a premium, dual-sheet facility located near I-95 and BWI, Howard County would become a premier destination for professional tournament organizers. This means more families staying in our hotels, dining in our restaurants, and shopping in our local businesses throughout the year.

Beyond youth sports, a two-rink facility addresses a long-standing deficit in adult recreation. The Columbia Ice Rink has been at capacity for years, leaving hundreds of Howard County adult league players with no choice but to commute to other counties or find other recreation. Additionally, a larger facility fosters a professional ecosystem for skating coaches, clinic organizers, and camp directors, creating jobs and specialized athletic opportunities right here at home.

Investing in two rinks is a fiscally responsible decision that transforms a recreational project into a high-yield community asset. I strongly encourage the Council to support the full two-rink proposal for the Meadowbrook facility.
