2	2013 ("CR 64") that sets forth the Fiscal Year 2014 Operating Budget of the Board of Education;

6	\$725,280,030; and

8	WHEREAS, since the adoption of CR 64, the Board wishes to transfer a total amount of	
9	\$3,813,460 within categories and from undesignated fund balances; and

11	WHEREAS, this transfer will result in an increase in the total general fund expense	
12	budget for Fiscal Year 2014 and will amend the amounts adopted in CR 64 in the Maintenance	
13	of Plant category and Fixed Charges category; and	
14		
15	WHEREAS, Section 5-105 of the Education Article of the Annotated Code of Maryland	
16	provides that a transfer between major categories of the budget of a County Board of Education	
17	shall be made only with the approval of the County Council; and	
18		
19	WHEREAS, Section 5-105 further provides that if a County Council fails to take action	
20	on a written request for a transfer between major budget categories within 30 days of receipt or	
21	the request, the failure to take action constitutes approval thereof; and

23	WHEREAS, on or about June 26, 2013 the County Council received a request from the	
24	Board of Education to transfer, in the Fiscal Year 2014 expense budget, a total of \$3,813,460	
25	between categories; and

27	WHEREAS, the reasons for this transfer include the receipt of additional Pay-Go	
28	funding in the capital budget for systemic renovations, additional funding from the General Fund	
29	undesignated fund balance, and reduced State revenue; and
