A RESOLUTION declaring that a total of approximately 0.215 acres of real property owned by Howard County, Maryland located off of MD Route 216 and commonly shown as Parcel 288 on Tax Map 46 is no longer needed for a public purpose and authorizing the County Executive to waive the advertising and bidding requirements of Section 4.201 of the Howard County Code in order to sell the property to the owner of the adjacent property; and providing that the County Executive is not bound to sell the property if he finds that the land may have a further public use.



1	WHEREAS, Howard County, Maryland (the "County") is the fee simple owner of
2	certain real property known as Parcel 288 on Tax Map 46 containing a total of 10.383 acres of
3	land as acquired by deed dated July 8, 1982 and recorded among the Land Records of Howard
4	County in Liber 1798, folio 120 and by deed dated September 8, 1993 and recorded among the
5	Land Records of Howard County in Liber 2991, folio 567 (the "County Property"); and
6	
7	WHEREAS, Route 216, LLC, a Maryland limited liability company ("Route 216") owns
8	11274 and 11268 Scaggsville Road, adjacent to the County Property; and
9	
10	WHEREAS, the County has received a request to sell 0.215 acres of the County Property
11	(the "Property to be Sold") to Route 216; and
12	
13	WHEREAS, the Property to be Sold consists of Areas B and C as shown in the attached
14	Exhibit A; and

16	WHEREAS, the Department of Public Works has reviewed and approved the proposed
17	disposal of the County Property; and
18	
19	WHEREAS, Section 4.201, "Disposition of Real Property", of the Howard County Code
20	authorizes the County Council to declare that property is no longer needed for public purposes
21	and also authorizes the County Council to waive advertising and bidding requirements for an
22	individual conveyance of real property upon the request of the County Executive; and

24	WHEREAS, the County Council has received a request from the County Executive to
25	waive the advertising and bidding requirements in this instance for the conveyance in the form of
26	the sale of approximately 0.215 acres of County Property to Route 216.

28	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
29	Maryland, this
30	consisting of approximately 0.215 acres and shown as Areas B and C on the attached Exhibit A

is no longer needed for a public purpose and may be sold to Route 216, LLC, a Maryland limited liability company.

AND BE IT FURTHER RESOLVED that, having received a request from the County Executive and having held a public hearing, the County Council declares that the best interest of the County will be served by authorizing the County Executive to waive the usual advertising and bidding requirements of Section 4.201 of the Howard County Code for the sale of approximately 0.215 acres of the County Property to Route 216, LLC, a Maryland limited liability company.

AND BE IT FURTHER RESOLVED that, if the County Executive finds that the County Property may have a further public use and that the Property to be Sold should not be conveyed, he is not bound to sell the Property to be Sold in accordance with this Resolution.

The Department of Public Works has been designated coordinator for preparation of testimony relative to conveyance of a 0.215 acre portion of County property located off of MD Route 216.

The County is the fee simple owner of certain real property shown as Parcel 288 on Tax Map 46, containing a total of 10.383 acres acquired by deed dated July 8, 1982 and recorded among the Land Records of Howard County, Maryland in Liber 1798, folio 120 and by deed dated September 8, 1993 and recorded among the aforesaid Land Records in Liber 2991, folio 567.

Route 216, LLC owns 11274 and 11268 Scaggsville Road, surrounded by the County property described above, and would like to purchase portions of the County Property.

Route 216, LLC will obtain an appraisal for the 0.215 acres, and compensate the County with the fair market value.
