LOUISE B. RIEMER

PROFESSIONAL EXPERIENCE

Library Administrator, Howard County, Maryland. A system recognized as one of the finest and technically progressive in the nation.

- Assisted architectural and interior design firms on three major new facilities and one special service facility
 built between 1990 and 1994 Savage Branch Library, Elkridge Branch Library, East Columbia Library and
 the Howard County Detention Center Library. Prepared conceptual service plan for each facility, working
 with public service and technical staffs. Interacted extensively with respective Howard County
 government departments to monitor all phases of construction. Possessed a working knowledge of
 county guidelines and regulations.
- •Served as a principal on planning team for the development of the Long Range Plan to direct the Howard County Library's service and facilities into the year 2000.
- •Worked with architectural firm in the complete renovation of the original Miller Library, Ellicott City. Helped redesign its existing space including signage, lighting, accessibility and other issues important to attractive and efficient operation.
- •Served as a principal on the planning team for the Central Library. Developed a service plan to present to the architect in 1979. Continued to be active in succeeding renovations and alterations over the ensuing years.
