Dear Councilman Fox,

I'm concerned that a piece of legislature such as CB9-2017, an act to make Howard County a sanctuary area, is being put forth within our county.

It is clearly a premature, knee-jerk reaction by Democrats against our President-elect, who hasn't even spent a single day in office. Yet Council Vice Chair Bell and Councilwoman Terrasa are trying to create law that clearly would violate federal law (p. 3 line 24-26; p. 4 line 9) and create a legal loophole which can be exploited by illegal immigrants (p.4 line 20).

Dear Mr. Fox,

Although I am not a resident in your district, I am taking the liberty to write you concerning the sanctuary measure introduced for adoption by Calvin Ball and Jen Terassa. I have been weighing the pros and cons of this debate. Saturday's editorial on the subject in *The Baltimore Sun* crystallized my position (http://www.baltimoresun.com/news/opinion/editorial/bs-ed-howard-sanctuary-bill-20170107-story.html).

I attended December 3rd's One Howard event. As a native born Caucasian, perhaps I am not the most qualified person to comment, but I was struck but one rather obvious fact:

African-American, Muslim, and undocumented residents of Howard County are absolutely terrified by what may happen after the Inauguration. Not concerned, Not worried. *Terrified*. And they are turning to their elected leaders for protection.

Now there are a lot of criticisms one can raise about Ms. Terrasa's and Dr. Ball's motion. One can argue that the sanctuary measure is too strong or too weak. Certainly politics are involved (Republicans would never resort to that, yes?), but we also do not know what kind of pressures Ms. Terrasa and Dr. Ball may be feeling from their constituents. A sanctuary designation would not affect anything the county currently does. However, we have no idea of what the incoming Administration may or may not do, so the designation is meant to address potential problems, not present ones. There is a threat of losing federal funding, but, as *The Sun* points out, the 10th Amendment provides protections against this. In short, today's editorial convinced me that a sanctuary designation would be good so "that people of whatever immigration status should have no fear of cooperating with police, going to the library, getting a building permit or engaging in any other way with the Howard County government. It doesn't mean undocumented immigrants in Howard County are immune from deportation or that they are being given special rights, just that Howard's government is codifying its commitment to leave immigration enforcement in the purview of the federal government, where it belongs."

I would urge you to retract your veto promise, or, if this is not possible, to at least address and acknowledge more specifically the concerns of those who may be affected by future changes to immigration law and enforcement. In any event, my best wishes for you in the upcoming New Year. Unfortunately, all of us-the County Executive, the Council, and county citizens-are now being whipsawed by the federal government's neglect of immigration policy and by the scourge of demagoguery that has swept the nation during 2016's election.





Dear Council Members,

I write to voice my support for CB9. This bill is important because it sends a clear message to HoCo's residents that cultural / ethnic diversity are a cornerstone of what makes Howard County a great place to live, work and visit.

When my husband and I moved to Howard County six years ago, we rented a house to make sure we would feel comfortable and safe as a mixed race family. When we saw that our neighbors and local school reflected a rich cultural, religious and political diversity, we decided to plant our roots here and raise our family. We haven't regretted that decision yet, but we fear that growing intolerance (vividly put on display during this past presidential election) will fundamentally change what makes Howard County a great place to live for families like ours.

This bill will go far to combat the rise of dangerous hate speech and intolerance that is affecting our children's mental and physical well-being. We urge you not to pass up an opportunity to stand and join the growing number of communities that are speaking up for families, like ours.

We want to also address Executive Kittleman's concerns about how passing this bill would affect law enforcement's ability to protect and serve.

Contrary to what he stated, nothing hurts law enforcement more than the erosion of trust between themselves and the community they serve. Our security is compromised when immigrant communities are forced into the shadows for fear of deportation. These are the conditions that lead to a rise in abuse and crime and law enforcement will be undermined if that is the climate we allow ourselves to create in Howard County.

Instead, by passing CB9, immigrant communities in Howard County will have the support they need to trust our law enforcement and that leads to proactive communities that report crimes and cooperate with law enforcement. Passing CB9 will make us all safer.

Good Morning,

I am writing to share my support for the CB-9 Sanctuary Bill introduced by Council Members Dr. Calvin Ball and Jen Terrasa. I am an immigrant who was brought to this country when I was two years old by my parents, I have lived in Maryland for over 47 years, and bought my homes in Howard county over twenty years ago. I have a strong commitment to our community.

At the #StandupHoward event I was deeply moved by the stories of the students bravely speaking out about their immigration status and working so hard to continue their education, support their families, and make a better future for themselves. I see in them, my own family and struggles. One piece of paper should not change the opportunities between our families.

Xenophobia, Islamophobia, and just tolerating differences is not new. When I was six years old and attending a public elementary school in Maryland, an assistant principal called me out of class and asked me if I had a Green Card. I that time, I honestly did not know what that was. At first I said I did not know, then he asked again, and I became scared and said "no" because I didn't now if it was a good or a bad thing to have a Green Card.

When I went home and told my Dad what happened, he became angry with me and went to his desk to show me the Green Cards for our family and said I was to always answer "yes" to that question. Behind his anger, I could see fear. The fear that we did not belong and that we were always under suspicion. Fear that all that he hoped for our family, when he accepted a scholarship to complete a masters in engineering, to uproot my mom and myself to come to a country just a few years past the passage of the Civil Right movement that was still not accepting of all of her people.



Please RSVP so that we can have an accurate headcount.

At the last Clergy Caucus before the holidays, a broad group of PATH clergy expressed a desire to work on creating a sanctuary for undocumented immigrants in Howard County. Almost immediately afterwards, County Councilman Calvin Ball and Councilwoman Jen Terrasa proposed CB 9, which would make Howard County a Sanctuary County (read here). Today, County Executive Kittleman promised to veto the bill if it is passed (read here). In conversation with Council members today, they made clear that if the Sanctuary Bill is going to pass, PATH turnout, PATH actions, and PATH emails will be critical.





I am an immigrant who was brought to this country when I was two years old by my parents, I have lived in Maryland for over 47 years, and bought my homes in Howard county over twenty years ago. I have a strong commitment to our community.

At the #StandupHoward event I was deeply moved by the stories of the students bravely speaking out about their immigration status and working so hard to continue their education, support their families, and make a better future for themselves. I see in them, my own family and struggles. One piece of paper should not change the opportunities between our families.

Xenophobia, Islamophobia, and just tolerating differences is not new. When I was six years old and attending a public elementary school in Maryland, an assistant principal called me out of class and asked me if I had a
