My name is Rabbi Seth Bernstein and I reside at 4737 Hallowed Stream, Ellicott City, and I am writing in support of Bill No. 9-2017. I do so for the following five reasons, the last of which is most important.

1. This bill is a declaration of the warm and welcoming atmosphere of our diverse county that stands for civility, decency and acceptance and to be free of prejudice, bigotry and hate —*values* that the citizens of Howard County expect our county to uphold.

2. This bill insures a *safe* environment for people to share information without fear of potential detention or deportation for anyone who communicates with school or government workers or officials. For county employees to inquire about a person's national immigration status is not a function of *county* government or *county* law enforcement.

3. This bill abides by all county, state and federal law and does not break or condone breaking any laws. This bill clearly states that county resources should not be expended in enforcing federal laws of the Immigration and Custom Enforcement agency. There are federal law enforcement officials whose task it is—not our county's task—to enforce such laws.

4. As a Rabbi, I could quote at length about the "cities of refuge" in the Bible, but those cases involved people who committed capital crimes and that is not the case with undocumented individuals in our community. I could wax on about the most repeated commandment and teaching in all of the Torah is none other than "Treat the stranger well for you were strangers in the land of Egypt." It is not only a coincidence that the commandment is repeated thirty-six times in Torah, more than any other commandment. The moral and ethical component behind this bill is more than salient. However, the following reason is by far the most compelling.

5. Howard County law enforcement officers and government officials and workers might be too heavily influenced by the threat of lost federal revenue. However, when weighing the injustice that most certainly will come to individuals if bill No. 9-2017 should not pass, consider the *unfortunate and harmful precedent* that the Council would be establishing. For individuals who break *criminal* laws, Howard County law enforcement officers and government officials have in the past and should in the future aid state and federal law enforcement officers and agencies find those suspected of breaking criminal laws. However, counties, cities and states do not have a history or track record for enforcing the federal *CIVIL* laws. Our federal government has the agencies, personnel and resources to ensure that federal civil laws

are enforced. That is not in the purview, nor is it the duty, of county government officers and officials to enforce federal civil law.

My name is Feng Ouyang and I am a resident and voter in Howard County.

I was recently informed of your intention of introducing Bill No. 9-2017, which declares Howard County a Sanctuary county. I have read the bill and plan to go to the public hearing to learn more and to express my opinion. Meanwhile, I would appreciate it very much if you could clarify some background information for me.

Most importantly, could you highlight a few points where the proposed bill would change any of the current laws, ordinances and common practices? Or is the bill a preemptive affirmation of status quo, in anticipation of policy changes from the Federal Government?

Also, could you discuss any similar measures taken or under consideration in neighboring counties and in the MD-DC-VA area? Would the passage of this bill make Howard County a different environment from the neighboring counties, concerning immigrants?

I also have a technical question. In Section 12.2103, a number of exceptions was listed, where county employees are permitted to as ask about citizenship, nationality or immigration status. The exceptions do not include application of social assistance. The fact is some Federal and State social assistance programs are managed by Howard County Department of Social Services. Some of the services (such as Food Stamp) require US citizenship to be eligible (with some exceptions). Perhaps social services should be included as the exception in Section 12.2103 of the bill.

Thanks in advance for your assistance in understanding the bill, and I look forward to your response.

Most importantly, could you highlight a few points where the proposed bill would change any of the current laws, ordinances and common practices? Or is the bill a preemptive affirmation of status quo, in anticipation of policy changes from the Federal Government?

Also, could you discuss any similar measures taken or under consideration in neighboring counties and in the MD-DC-VA area? Would the passage of this bill make Howard County a different environment from the neighboring counties, concerning immigrants?

I also have a technical question. In Section 12.2103, a number of exceptions was listed, where county employees are permitted to as ask about citizenship, nationality or immigration status. The exceptions do not include application of social assistance. The fact is some Federal and State social assistance programs are managed by Howard County Department of Social Services. Some of the services (such as Food Stamp) require US citizenship to be eligible (with some exceptions). Perhaps social services should be included as the exception in Section 12.2103 of the bill.





Concerning County Bill No. 9-2017 Feng Ouyang

Respected Council Members:

My name is Feng Ouyang, residing at 15154 Sapling Ridge Drive, Dayton, MD 21036. Today I would like to state my position of AGAINST County Bill No. 9-2017. I consider "sanctuary county" as an issue inappropriate for the County Council to consider.

After learning about the above-mentioned bill, I wrote to Dr. Ball on 12/27/2016 and, having received no reply, to the county council on 1/12/2016. Since I have not received any reply so far, I would like to repeat the email below, and expand further on one point.

The email reads:

Dear Dr. Ball:

My name is Feng Ouyang and I am a resident and voter in Howard County.

I was recently informed of your intention of introducing Bill No. 9-2017, which declares Howard County a Sanctuary county. I have read the bill and plan to go to the public hearing to learn more and to express my opinion. Meanwhile, I would appreciate it very much if you could clarify some background information for me.

Most importantly, could you highlight a few points where the proposed bill would change any of the current laws, ordinances and common practices? Or is the bill a preemptive affirmation of status quo, in anticipation of policy changes from the Federal Government?

Also, could you discuss any similar measures taken or under consideration in neighboring counties and in the MD-DC-VA area? Would the passage of this bill make Howard County a different environment from the neighboring counties, concerning immigrants?

I also have a technical question. In Section 12.2103, a number of exceptions were listed, where county employees are permitted to ask about citizenship, nationality or immigration status. The exceptions do not include application of social assistance. The fact is some Federal and State social assistance programs are managed by Howard County Department of Social Services. Some of the services (such as Food Stamp) require US citizenship to be eligible (with some exceptions). Perhaps social services should be included as the exception in Section 12.2103 of the bill.

Thanks in advance for your assistance in understanding the bill, and I look forward to your response.

I would like to expand on the first point in the email. So far I do not see any evidence that Bill 9-2017 will change any practice of the County Government and its employees. Therefore, I consider it a political gesture in response to the recent presidential election result.

In my view, it is inappropriate for the County Government to make a political statement on behalf of the Howard County residents. The County Council is elected to manage daily business and welfare of the County, not as our political representative. If the People do feel necessary to express an opinion, they should do it through referendum or other channels. I believe that this bill will not make Howard County safer and our community more harmonious. Instead, it will make it worse in these aspects.

I am a new immigrant, living in the United States for decades. When I first arrived as a student, I had \$500 in my pocket and did not know anyone personally. I am very grateful to people who helped me to settle and thrive in this new land, and vow to help others to do the same. Instead of being distracted by politics, I believe Howard County can make our community a more welcoming place to immigrants through solid actions. For example, the county can provide language assistance to immigrants using county services, provide transportation options to people without cars, and provide more diverse world culture and language programs in our schools.

Hello, my name is Ron Meservey, and I live at <u>9447 Brett Lane, Columbia, MD 21045</u>. My wife and I have lived in the Village of Oakland Mills since 1983. I am a member of PATH and I support making Howard County a Sanctuary County, and here is why:

Last Spring the Southern Poverty Law Center, which tracks hate groups, asked its subscribers who were teachers whether they had noticed any repercussions of the Presidential campaign in their classrooms. They reported an alarming increase in bullying directed at minority and immigrant students, leaving many terrified of being deported, or worse. I had hoped that Howard County was an exception, that our multi-ethnic community had been spared such forms of bigotry and fear. Sadly, I was wrong. Members of the County Council Testimony on CB9 After reading the Bill I found this to be another example of our representatives putting their head in the sand and not willing to address the real issue of undocumented residents in our county and country. The desire to ignore the status of undocumented residents only pushes them into the shadows and deprives them of the all the opportunities our country has to offer. For as long as the undocumented are enabled by our leaders to live this way it reinforces suspicion, mistrust and dislike on both sides of the issue only making the shadows they are forced to live in darker and larger. This Bill provides no solution for the undocumented and only insults those that respect and appreciate the law of the land by injecting phrases and labels of diversity hate and is hate bate. If you are an undocumented resident, then you are not here legally and you will always be looking over your shoulder or be at the behest of someone to keep your secret for you or hope a friendly government will be in power to manage your plight. Yes I suggested the government is managing this issue to help constituents, to either keep the undocumented in subservient working and possibly living condition. Enabling this behavior is only keeping our undocumented residents from living the full American experience of freedom. Yes the undocumented live much better here than where they came from and many of them are participating in our society. They work, attend places of faith, their kids are in public schools but the spector of deportation hangs over them and cripples their potential. Let me present a simple example of what is to live in the shadows. My group offers a soccer skills competition and we invite all to attend and compete. The competition is often held at churches Message: and we held this one at a church with a large Hispanic and Latino population. We were exited at the turn out by all the families and many of the best performers were Latino. When it came time to present awards and record their information to move on to the next level of competition, they were gone, could not be found on the grounds. At first I did not understand but I discovered that some of these families did not want to be known or be on list or have a record of address. It is a small thing and just soccer skills, but this sort of opportunity is left on the table every day because of fear. This fear is real and did not start in the past year, it has always been with us, it was there when many of our ancestors came over and were kept at Ellis Island until they were deemed healthy, have some way to be taken care of (friends or family) or take care of themselves and not a threat to our society. How do we move beyond the fear? How do we bring the undocumented from the shadows? We ask for legislation to work within the laws of the land and ask that we have a process in place to offer documentation to all those that want to come out from the shadows. I am not talking amnesty but a way to provide identification that this person is allowed to be in this country after

they have been vetted. Yes there would be conditions, one would have to check in every 6 months to a year until they have achieved citizenship if they like. Legislation should also be presented in the county to work with State and Federal officials offer or create a less expensive and less time consuming process to citizenship. I cannot support this bill I want a real solution to help not hide the undocumented residents in the county. Howard Johnson
