Dear Howard County Council,

My name is Chiara D'Amore and I am a resident of Ms. Sigaty's district. I have called Howard County home since I was in the 4th grade. After leaving the area for college, graduate school, and my early career, my husband and I moved back to Columbia in 2008 in order to raise our children, who are now 7 and 3.

One of the primary reasons I wanted to return to this area to raise our family is because of the diversity that is intentionally supported and deeply valued in this community. In designing Columbia, James Rouse truly wanted to create a better place for people--all people--to live. Mr. Rouse believed we are at our best in communities where there is a sense of responsibility to one's city and to one's neighbor. He imagined and designed Columbia, the heart of Howard County, to be a place that fostered economic, racial, and cultural harmony. CB9 helps to codify this vision in the midst of tumultuous times in our county and country.

As a scientist, I believe firmly in the importance of facts and truth. In honor of Dr. Martin Luther King Jr. I agree with his assertion that "Nothing in this world is more dangerous than sincere ignorance and conscientious stupidity." Unfortunately we have seen a rise in both in recent times, as evidenced by a political culture of false information being passed as fact in order to use fear to garner power. We are seeing this from detractors of CB9. With this context, the reasons I support CB9 are as follows:

• Across the US there are nearly 400 sanctuary cities and municipalities that offer a variety of policies and protections for residents. While there is no legal definition that spans all of these locals, essentially the term refers to a locality that has chosen not to use its local resources to enforce federal immigration law. If the CB9 legislation passes in Howard County, it would legally direct county employees and police not to inquire about a resident's immigration status unless required by law (for example, checking legal authorization to work during the hiring process). The benefits of making what has been a policy position into law are that it prevents discrimination; ensures county resources are prioritized for local law enforcement efforts; and protects the county from exposure to potential liability. Importantly, it also reflects our values as a welcoming and diverse community and promotes trust between our community and government/police.

• This bill would not interfere with our police's ability to investigate crimes and enforce local and state law. Additionally, it does not interfere with ICE's ability to carry out deportation. Our local police would still be required to comply with any federal warrants for arrest. Separating local policing from immigration enforcement promotes public safety and promotes family unity and human dignity.

• Congress appropriates and authorizes the spending of federal funds, not the President. Nothing in this bill violates federal law, so Howard County should not be under any threat of losing federal funds. There is not transparency around any federal funding that Howard County receives that would be threatened if additional steps would be taken to further bolster the County as an inclusive, supportive, compassionate community.

• I have the privilege of being a Caucasian, able-bodied, straight, able-bodied, educated, upper middle class, U.S. citizen, of a non-threatened faith. I have MANY friends and colleagues who do not fit one or more of these categories. As I wrote in my November 20th Op Ed in the Baltimore Sun regarding Governor Hogan's lack of leadership around the rise of hate speech and actions, "There are children in Maryland who are now living in fear due to circumstances around which they have no control — the color of their skin, their accent, their religion, their disability, and so on. Friends of mine have been called the N-word for the first time in the diverse and inclusive community of Columbia. Other friends are afraid to wear any public indication of their religion due to harassment."

Hello, my name is Monique Ellison and I live at 6060 Charles Edward Terrace. I am a member of PATH and I support making Howard County a Sanctuary County, and here is why:

This bill is a declaration of the warm and welcoming atmosphere of our diverse county that stands for civility, decency and acceptance and to be free of prejudice, bigotry and hate—*values* that the citizens of Howard County expect our county to uphold.

This bill insures a **safe** environment for people to share information without fear of potential detention or deportation for anyone who communicates with school or government workers or officials. For county employees to inquire about a person's national immigration status is not a function of *county* government or *county* law enforcement.

This bill abides by all county, state and federal law and does not break or condone breaking any laws. This bill clearly states that county resources should not be expended in enforcing federal laws of the Immigration and Custom Enforcement agency. There are federal law enforcement officials whose task it is—not our county's task—to enforce such laws.

I am an Episcopal priest, and as follower of Jesus Christ I feel compelled to care for the most vulnerable among us. Surely, those without documentation are highly vulnerable, especially if they feel unsafe working with or contacting local law enforcement or their local government.

Some have expressed that this bill would somehow make Howard County a beacon for undocumented people to flock to Howard County. Testimony In Favor of Sanctuary Bill CB9

People of faith, are called on by their sacred texts and faith traditions, to love their neighbors, welcome immigrants and protect those who are most vulnerable. War, conflict, economic hardships and persecution have forced people to leave their homes, creating more refugees, asylum seekers and internally displaced people than at any other time in history.

We are all immigrants, unless we are indigineous people, we are all descendants of economic or forced migrants, or we may have recently arrived in Howard County. We may have formal documents proving US citizenship, or we may be undocumented. Those who have citizenship may find it hard to imagine the fears, uncertainty and anguish that the undocumented face every day. We find ourselves in a political landscape that has fostered "xenophobia" targeting anyone considered to be an "other." Undocumented immigrants are exploited for their labor and economic contribution to the United States. They are denied their rights to collectively bargain for livable wages and safe working conditions, and they are shut out of access to the social services of which they support through their difficult labor.

Howard County has a moral responsibility to be a place of sanctuary for undocumented immigrants who are trapped in an immigration system that is broken and has created a perpetual second class of immigrant workers. Throughout the Hebrew Scriptures the people of God are commanded to give the immigrants in their midst the same rights as native-born: In Leviticus 19: 33-34 *When a foreigner resides among you in your land, do not mistreat them. The foreigner residing among you must be treated as your native-born. Love them as yourself, for you were foreigners in Egypt. I am the Lord your God.*

There is frustration on all sides about the state of our immigration laws. We must work to channel that frustration into advocacy for the passage of a federal comprehensive immigration reform bill rather than contributing to the fear, ignorance and debate over immigration which has generated dangerous racial dynamics that have led to racial profiling and intolerance toward immigrants.

Immigration enforcement is the purview of the Federal Government and state and local law enforcement should not have the added burden of functioning as immigration agents. The Howard County police are effective at ensuring public safety in the county because they have worked and continue to work on building trust between police and the residents of the county. High levels of trust between law enforcement and local communities is essential for effective policing and study after study has shown that when local police are used as immigration agents their ability to ensure public safety is greatly diminished.

When all individuals can report dangerous situations without fear of being deported and separated from their families, safety is increased for all community members. This bill will have a practical and meaningful impact on the lives of the most marginalized in Howard County, undocumented children, who should be safe regardless of their parentage.

It is important in a political climate of xenophobia that cities and counties declare themselves to be places of sanctuary for immigrants. To stand by in silence while families are separated, individual freedoms are ignored, and the immigrant community in the United States is demonized is complicity to sin.

Voting for this bill means that the people of Howard County denounce and oppose the rise of xenophobic, racist, and violent reactions against immigrants in the United States, support all efforts to build relationships between people, instead of building walls, between diverse ethnicities and cultures.

Dear Mr. Kittleman,

Your stated opposition to Council Bill 9 does a great disservice to our community. Undeniably, Council Bill 9, seeking to declare Howard County a "sanctuary" for non-citizens, suffers from poor draftsmanship. Rather than address the Bill's flaws, you rejected the Bill with an appeal to the basest of human instincts.

Traditionally, legislation, at every level of government in America, consists of a declaration of the policy addressed and the provisions implementing the policy. Unfortunately, the current version of Council Bill 9 contains as many clauses objecting to offensive speech as affirmative declarations of purpose. The language of the Bill indicates a hastily constructed counter to the bigotry revealed during the most recent Presidential campaign.

Plainly, much of the Bill involves a fruitless attempt to circumvent the law of Federal preemption. The Constitution dictates that immigration laws are exclusively the purview of the U.S. Government, and many of the Bill's provisions represent little more than a failed attempt to circumvent this basic tenet of Federalism.

The Bill does succeed, and thereby merits your support, in precluding County officials from aiding Federal authorities in the enforcement of immigration laws. Whether based on high-minded principle or an assessment of resources, such a limitation is consistent with federalism and thus fully enforceable.

While Bill breaks from certain procedural norms, its clear purpose fulfills our Nation's highest traditions. Council Bill 9 follows the greatest precedent in defining the American character. More than 150 years ago, Congress passed the Fugitive Slave Act to appease Southern slaveowners and their allied monied interests. The Act created a Federal crime, punishable by six months in jail, for interfering with the capture of a runaway slave.

In response, fifteen States officially declared their refusal to comply with the Act. The Northern States' defiance of Federal law established the legal fiction of States' Rights; led the Slave States to argue that the Union was nullified; and motivated the forming of a new political party, composed of people whose values compelled them to demand that America provide equal rights to all of its residents. This new party held its first convention in 1860, and its nominee, Abraham Lincoln, became the first Republican President of the United States.

Like the Free States' refusal to aid in enforcing slavery, Council Bill 9 is an official declaration that Howard County will not assist in enforcing our Nation's universally detested immigration laws. The reality is that, for thirty years, Maryland and Howard County officials have unofficially adopted this same practice. In essence, Council Bill 9 merely discloses this traditional response to immigrants in need of assistance.

In stark contrast, your declared opposition presents no new information and no competing principle. First, you claim that the Bill would give a "false sense of security" to those with dubious immigration status. In fact, strict enforcement of immigration laws has always impeded the investigation by law enforcement officers of horrific crimes. Fear of deportation constricts the willingness of immigrants to respond to requests for witnesses. Removing that fear may produce a sense of security, but only if the public goal is to prevent violent crimes.

Second, your stated opposition suggests that Federal law enforcement officials would no longer aid County police in bringing criminals to justice. In the precise case you cited, the truth is that Federal authorities aided the police in Montgomery County, a jurisdiction that has already declared itself a "sanctuary".

It is your third argument that most threatens our community. Your final attempt to justify your opposition to Council Bill 9 speculates that the Federal Government may respond by not funding certain programs. You have thus reduced a debate over principle to a money grab. Anyone sincerely concerned about threats to our American culture must accept that the greatest danger to the American Civilization is not the influx of strangers but our disregard for our fundamental values.

Since time of the Puritans' immigration to New England, Americans have been exceptional because of their choice to follow a moral code. Although rarely of material benefit, Americans feel commanded to welcome the stranger, to provide him with food and shelter, and to treat him justly. Council Bill 9 is an imperfect attempt to declare the County's official adherence to these values. Your stated opposition rests on a willingness to exchange these values for monetary gain. Our Nation's Founders, fully aware of the financial stakes, made the choice of creating a nation of principles.

We now must decide whether to reject or affirm the fundamental moral commandments that activated our Nation. It is my hope that you will reconsider your current position, work to improve the proposed legislation, and demonstrate the leadership that your office demands.

My husband and I are seriously against CB9 for these reasons:

We live in a country of laws. Some of the major problems that we are currently experiencing in our country stem from the fact that some of these laws are not being enforced. Frankly, we need to return to a law and order society. American people value the rule of law above all. It would be nice to return to a society that respects the men and women that wear the badge. This bill is a slap in the face to our local police and to our constitution. The language in the preamble of this bill is a slap in the face to Howard County, that prides itself on civility. These statements are anything but.

In the discussion on immigration, I would like to quote our past Democrat President, Theodore Roosevelt where he stated that:

"In the first place, we should insist that if the immigrant who comes here in good faith becomes an American and assimilates himself to us, he shall be treated on an exact equality with everyone else, for it is an outrage to discriminate against any such man because of creed, or birthplace, or origin. BUT, this is predicated upon the person's becoming in every facet an American, and nothing but an American ... There can be no divided allegiance here. Any man who says he is an American, but something else also, isn't an American at all. We have room for but one flag, the American flag ... We have room for but one language here, and that is the English language ... and we have room for but one sole loyalty and that is a loyalty to the American people."

"The immigrant who did not become in good faith an American "is out of place" in the United States. He has got to consider the interest of the United States or he should not stay here. He must be made to see that his opportunities in this country depend upon his knowing English and observing American standards. We must in turn insist upon his showing the same standard of fealty to this country and to join with us in raising the level of our common American citizenship." This includes following all of our laws.

This bill strains the resources of the legal citizens of Howard County. The undocumented immigrants are already accepted, and given many benefits available in HoCo. They already have equal access to many County benefits and services including hospitals, public schools, libraries and welfare, etc. Yet, unfortunately some of our own legal citizens are being denied these very same benefits. My own daughter, who has disabilities has been denied medical help, even though she had three surgeries last year, and \$20,000 worth of medical bills. She is only able to work part time as she is a college student with disabilities. Why isn't my legal daughter afforded the same benefits as 'Illegals'? My tax dollars are supporting these benefits.

This bill undermines the hard work of immigrants who have obtained citizenship legally. We have a legal immigration process for many reasons. This process controls the amount of people that enter our country and the type of job skills they bring with them. It protects the legal citizens of the United States. By people entering the country illegally circumventing this process you end up with large numbers of people who the government knows nothing about, which in this age of terrorism and limited resources we cannot afford to ignore.

This bill invites devisiveness. If you cannot honor the laws of this land, you need to step down from your jobs. Below are more interesting thoughts that you ought to take the time to read.

Sanctuary policies defy federal laws to which state and local governments are bound. 8 U.S. Code § 1373 states that "a Federal, State, or local government entity or official may not prohibit, or in any way restrict, any government entity or official from sending to, or receiving from, the Immigration and Naturalization Service information regarding the citizenship or immigration status, lawful or unlawful, of any individual." [5] The Department of Justice requires that most recipients of federal grant money certify their compliance with all federal laws. [4] [6] Sanctuary cities, by not asking about, recording, and submitting to the federal government the immigration statuses of residents, are violating federal law and the rules for getting federal grant money. Just why, Calvin and Jen, are you suggesting that we defy the law? Isn't that contrary to your oath of office? If we do not follow our own laws, how are we to expect immigrants to respect our laws?

Our Howard County Police Department has made This bill compromises community safety: successful progress working with U.S. Immigration and Customs Enforcement, in combating drug activity, child pornography and human trafficking over the last several years. This bill causes serious concern that the County's effort in cooperating with ICE may be compromised. This leads to a community more susceptible and vulnerable to crimes conducted by alien criminals. This bill makes Howard County a beacon for illegal immigrants. Sanctuary cities harbor criminals, creating a dangerous environment for US citizens. Juan Francisco Lopez-Sanchez, an undocumented immigrant, had seven felony convictions in the United States and had been deported from the country five times. Yet, the city of San Francisco declined to detain him for Immigration and Customs Enforcement Officials officials and released him into the community. In July 2015, Lopez-Sanchez was charged with murdering Katie Steinle in San Francisco. [8] [9] Of 8,145 undocumented immigrants released from detention requests between Jan. 1, 2014 and Aug. 31, 2014, 5,132 (63%) had previous criminal convictions or were marked a public safety concern; 2,984 (36.6%) had felony charges or convictions; 1,909 (23.4%) had misdemeanor convictions or charges related to violence, assault, sexual abuse, weapons, or drug distribution; and 239 (2.9%) had three or more misdemeanor convictions. [18] Why would we bring this to Howard County?

Sanctuary policies prevent local and state police officers from doing their jobs. Sanctuary policies prevent police from investigating, questioning, and arresting people who have broken federal immigration law. Many crimes, violent and otherwise, could be prevented if local law enforcement in sanctuary cities could arrest undocumented immigrants for their first crime on US soil—illegal entry into the country—and turn them over to federal law enforcement. [14]

According to Heather Mac Donald, JD, Thomas W. Smith Fellow at the Manhattan Institute, many Salvadorian gang members living in Los Angeles entered the United States illegally, but because of sanctuary policies, LA police officers cannot arrest the undocumented immigrants for illegal entry. Instead, law enforcement has to wait for a second crime to be committed to get the criminals off the street. [14]

According to Immigration and Customs Enforcement records, from Jan. 1 to Aug. 31, 2014, more than 8,100 immigrant offenders who were sought by ICE in sanctuary jurisdictions were released instead of turned over for deportation.

Just in this eight-month period, approximately 1,900 of these deportable convicts offended 4,300 more times, racking up 7,500 new charges. The subsequent crimes included murder, sexual assault on young children, violent rape, burglary, assault, dangerous drug offenses and drunken driving. More than 1,000 are still at-large in our communities.

Some will argue over whether immigrants commit more or fewer crimes than Americans (there's no solid evidence either way). That's irrelevant; the more important policy issue at hand is how we handle those immigrants who have committed crimes. ICE agents do not patrol the streets looking for illegal aliens; they depend on local officers to find out about those who are committing crimes.

If local officers will not turn over illegal immigrants who have already been arrested for something else, that means ICE agents have to go get them where they live and work — a much more resource-intensive process that also puts the agents and the public at risk if something goes wrong.

It is up to Congress and state lawmakers to take prompt action against sanctuaries. States can enact laws prohibiting sanctuary policies and direct agencies to notify ICE when they are aware of deportable offenders.

Congress must clarify that sanctuary policies are not only unwise but contrary to law. They need to specify that local agencies must not obstruct, but assist when ICE seeks custody of a deportable offender, and provide legal protection to local officers who assist in enforcement. In addition, those state and local governments that persist in sanctuary policies must be barred from receiving federal homeland security and law enforcement funding.

This bill undermines the hard work of immigrants who have obtained citizenship legally. We have a legal immigration process for many reasons. This process controls the amount of people that enter our country and the type of job skills they bring with them. It protects the legal citizens of the United States. By people entering the country illegally circumventing this process you end up with large numbers of people who the government knows nothing about, which in this age of terrorism and limited resources we cannot afford to ignore. It appears the number of immigrants the U.S. permits each year is to be defined by how many foreigners choose to ignore immigration law and live here illegally. When a politician says any immigration reform must include a path to citizenship for all illegals who are currently living in America they are in effect granting foreign nationals the authority to determine how many people are permitted to enter the U.S.

Realistically, if we open our borders and everyone on Earth who wished to live in America were permitted to with no delay or regulation our population would double, maybe triple, very quickly. That might be a very good thing, then again it might not. I do believe the U.S. should welcome people who want to come here and build a better life. But I also believe we must manage the flow of immigrants to ensure they can be properly assimilated to American culture. Our resources in this country are not endless and unfortunately we can't help everyone or solve all of the world's problems, no matter how hard we try. Many people in this category are honest, hard working people looking for a better life. But that doesn't change our laws. We cannot begin to pick and choose which laws we will or will not obey, or enforce.

Reasons to enforce our immigration laws:

It's time to raise the American standard of living. The real minimum wage has been declining for over a decade. Why has the market value of unskilled labor declined? Supply and demand. For years we have been artificially modifying the supply side by tolerating a massive influx of unskilled workers across our borders. We can reverse the trend by enforcing current immigration laws.

Conservative estimates place the number of illegal aliens in the U.S. at 10,000,000. Taking into

account minor children and the aged, that's still millions of people who are flooding our labor force. Remove them, and opportunities will abound for Americans. There's no job an American can't or won't do for a living wage. It is a cruel joke on the American worker to allow illegals to depress wages for many jobs below poverty level, and then to mock Americans for being reluctant to participate in the poverty.

Breaking the law is crime. Lawbreakers are criminals. Out of deference to the PC crowd, many like to use the term "undocumented workers"--as if illegals were merely missing a piece of bureaucratic paperwork. By the same logic, we can call a car thief an "undocumented driver." Our immigration laws exist for good reasons: to protect our safety, our national sovereignty, our standard of living, our health, and our culture. Those who break them may "want a better life for themselves," but then again, so do all who enrich themselves by disregarding the law. Many people who wish to immigrate honestly are waiting patiently. Granting privileges like driver's licenses and social security cards to illegals is a slap in the face to law-abiding citizens and immigrants alike. It's like opening an express window to give titles and owner's cards to car thieves, while making legitimate owners stand in line!

Open borders threaten our safety. Since the attacks of September 11, 2001, two things have become clear. First, we have enemies, and they are vicious and without conscience. Second, our enemies obviously believe that an attack from within is more feasible than an attack from without.

Even before the horrid events of September 11, our immigration laws had the primary purpose of protecting us. The use of visas and passports allows our government to monitor, and control who enters our country, and why.

Few illegal aliens are terrorists. But it only takes one! More importantly, the creeping ideology of open borders--the (usually unspoken) belief that treating foreigners who enter our country differently than we treat our own citizens is somehow "discriminatory" or "racist"---is creating a terrible dilemma: Either we cease to monitor the aliens (and open ourselves up for even worse attacks), or we create the "equality" of the police state by casting aside constitutional protections for citizens and monitoring everyone. The more resolutely we protect our borders against threats from without, the safer, and freer, we can live within them.

American culture is worth preserving. Culture is more than operas and Shakespearian plays-it's the sum total of the customs, beliefs, artistic creations, attitudes, goals, and norms that make a society what it is. It is passed down, as a treasure, from grandparent to parent to child. In other words, culture is what gives us our identity.

Some advocate "multiculturalism"---creating a society in which multiple cultures exist side by side, and believe that "diversity"---having as many cultures as possible, with none dominant----is desirable.

The majority of the media elite believes that we need more multiculturalism and diversity; the majority of the population doesn't. Regardless of how anyone stands on this issue, the fact is that our society is already multicultural and diverse. Anyone who wishes to enjoy, and celebrate, the many cultures now coexisting in America need only visit any American city. We're a nation of 300 million; the Third World population is in the billions. Do the math. Our country seems large, but its population is tiny compared to that of the Third World. China and India alone have seven times our population.

For whatever reasons, our society has succeeded in creating immense wealth where many others have created only poverty. An American welfare recipient would still be "rich" by the standards of most of the world.

One can't blame the citizens of countries who produce much less wealth per capita than we for wanting to reap the benefits our forefathers have sown for us. But if we open the borders, our island of productivity and prosperity will soon disappear beneath a flood of Third World squalor.

It's not your father's immigration. Previous generations romanticized immigration. The images are still with us: Starry-eyed Irish, Italian, Jewish, and Polish arrivees toting their bags and trunks onto shore at Ellis Island... The tablet at the base of the Statue of Liberty exhorting other nations to "Give me your tired, your poor..." The native-born American learning to love pizza and bagels.

That was then. This is now.

Yes, there are still many people in foreign lands who harbor the "American dream," and who seek to come here to realize it.

Millions of illegal aliens, however, have attitudes and motives very different from those of the immigrants in the fading black-and-white photos of yesteryear. It's not fashionable to speak the truth about this group. But the truth must be spoken.

What makes this new breed of "immigrants" different? To begin with, they're not "immigrating" at all--they're sneaking in. They don't have an "American dream" of building this country; rather, though still loyal to their home nations, they want to exploit ours economically. Many even dream of taking over regions of our country, and displacing us. There's already a word for this goal: Reconquista of Aztlan. If the members of this group don't intend to return home, yet have no loyalty to America, what should we call them? Certainly not "immigrants."

A 'colonist' is a better term. Today's colonists, like those of the past, want to build enclaves on American soil from which they can expand their own wealth and power, and that of their homeland, while drawing on the resources that were created by the native population. How can we welcome legitimate immigrants while keeping out colonists? By knowing who is coming here, and why, and only admitting those whose presence is in our country's best interests. In other words, by enforcing immigration laws.

It's an issue we can all come together on. Conservatives, traditionally, aim to preserve the valuable legacy of the past, and to protect freedom by limiting the power of government. Liberals seek to provide all citizens, even the most disadvantaged, with the opportunity to realize their full potential. Both have worthy goals, but often squabble over how to realize them.

Removing illegal aliens can give us the best of both worlds. We can preserve our traditional culture. And without resorting to costly and intrusive government programs, we can give our poor a genuine "hand up": as the glut of cheap labor dries up, those at the bottom rung of the economic ladder will suddenly find themselves able to climb higher without ruinous competition.

People of good will on the left and the right can only smile approvingly as the free market provides our unskilled and uneducated with a decent wage, and with a job market that welcomes instead of marginalizes them.

We can "live better than we did four years ago" and have a rebirth of national pride, as President Reagan wanted for us. And we can have a "New Deal" for our poor, a society where no American is left out, which were the ideals of President Roosevelt.

At last, we can come together. That's what patriotism is all about.

We either face tough issues now, or tougher ones later. Immigration issues are complex. We need a national debate--which, judging by the 2004 primary and general Presidential campaigns, isn't happening. Most Americans, when confronted with the facts, will probably continue to want what they want now: strict enforcement of our immigration laws. It won't be easy. We'll have to find workable ways to deport illegal aliens without creating unnecessary hardships for those who have broken our immigration laws, and without creating severe dislocations for the unscrupulous employers who have benefited from their presence. And, of course, we'll have to counter, with quiet reason, the voices of those who scream "discrimination" or "racism."

Some cringe at the challenges that await us.

These challenges, however, pale in comparison to those that future generations will face if we fail to act. Imagine an overcrowded, impoverished America with shrinking wages and expanding burdens on the social service system. Imagine an America where millions of Americans have been driven out of their neighborhoods by throngs of foreign colonists who neither speak our language nor understand the culture that created American prosperity--but who deeply resent the poverty that inevitably results from their own unwillingness, or inability, to live as true Americans.

Will Americans be forced to tax away their own shriveling wealth, and to transfer it to the aliens within our borders, if they wish to appease the colonists' anger? Will the shrinking American middle class merge with the alien underclass to form a new "peasant culture" while a tiny American elite trembles behind the walls of heavily policed gated communities? Or will full-scale cultural and racial war break out? None of these possibilities is appealing. Nonetheless, a society is a reflection of the population that comprises it. If we, as an advanced society with a low birthrate, continue to import a Third World population with a high birthrate, we will become a Third World society, and will face the problems, which other Third World societies face as well.

Isn't it better to face the issue of illegal immigration now--and to do something about it?

... and the number one reason is:

We owe it to our kids and grandkids. Our children and grandchildren will marvel at the digitized archives of the TV shows of the 1950s and 1960s. They'll see a prosperous, free, united America— the envy of the world, a place anyone would be happy and proud to call home. This, they'll realize, was the legacy our grandparents and parents left us, the American citizens of the early 21st century.

How will the America we leave to our children stack up against the America our parents left to us? What will future generations think of us? Will we be known as the preservers and expanders of the beautiful legacy, or as its destroyers? By our actions or inactions, we're deciding which it will be. Right now.

Garrison gave us the most powerful and compelling reasons I have seen for each one of us to take actions for preserving our country. It behooves each of you to use your computer, telephone, radio station, TV station, letters to the editor of your newspaper and calls to every senator and congressman every week relentlessly to gain national focus on this immigration invasion. Democracy is not a spectator sport. This nation is in danger of becoming a Third World nightmare with all the corruption, disease, illiteracy, violence and balkanization known all over the world. We need a 10-year moratorium on all immigration to catch our collective breath and we need deportation of over 10 million illegal aliens in a slow and orderly fashion. My family and I support CB 9-2017, the "Santuaries Bill" for Howard County. We believe it is important to demonstrate continued support for immigrants, documented or undocumented, and their families in our community. Today there is a climate of hostility and even hatred toward people of different races, religions and immigration status unleashed during the past 18-months by the rhetoric of the president-elect and many of his followers.

In Howard County, we pride ourselves on our "Choose Civility" campaign and our policies and practices that make us a "welcoming, inclusive and safe community." Rightfully, we pride ourselves on the fact that our police and public employees do not routinely inquire about the documentation of immigrants they interact with. The sanctuary bill reinforces this policy and does not require police or public employees to act any differently toward undocumented immigrants than we are told they do now, nor does it require them to violate state or federal law.

We are operating in a climate where the mass deportation of 11 million people is discussed seriously. My name is Chiara D'Amore and I am a resident of Ms. Sigaty's district. I have called Howard County home since I was in the 4th grade. After leaving the area for college, graduate school, and my early career, my husband and I moved back to Columbia in 2008 in order to raise our children, who are now 7 and 3.

One of the primary reasons I wanted to return to this area to raise our family is because of the diversity that is intentionally supported and deeply valued in this community. In designing Columbia, James Rouse truly wanted to create a better place for people--all people--to live. Mr. Rouse believed we are at our best in communities where there is a sense of responsibility to one's city and to one's neighbor. He imagined and designed Columbia, the heart of Howard County, to be a place that fostered economic, racial, and cultural harmony. CB9 helps to codify this vision in the midst of tumultuous times in our county and country.

As a scientist, I believe firmly in the importance of facts and truth. In honor of Dr. Martin Luther King Jr. I agree with his assertion that "Nothing in this world is more dangerous than sincere ignorance and conscientious stupidity." Unfortunately we have seen a rise in both in recent times, as evidenced by a political culture of false information being passed as fact in order to use fear to garner power. We are seeing this from detractors of CB9. With this context, the reasons I support CB9 are as follows:

• Across the US there are nearly 400 sanctuary cities and municipalities that offer a variety of policies and protections for residents. While there is no legal definition that spans all of these locals, essentially the term refers to a locality that has chosen not to use its local resources to enforce federal immigration law. If the CB9 legislation passes in Howard County, it would legally direct county employees and police not to inquire about a resident's immigration status unless required by law (for example, checking legal authorization to work during the hiring process). The benefits of making what has been a policy position into law are that it prevents discrimination; ensures county resources are prioritized for local law enforcement efforts; and protects the county from exposure to potential liability. Importantly, it also reflects our values as a welcoming and diverse community and promotes trust between our community and government/police.

• This bill would not interfere with our police's ability to investigate crimes and enforce local and state law. Additionally, it does not interfere with ICE's ability to carry out deportation. Our local police would still be required to comply with any federal warrants for arrest. Separating local policing from immigration enforcement promotes public safety and promotes family unity and human dignity.

• Congress appropriates and authorizes the spending of federal funds, not the President. Nothing in this bill violates federal law, so Howard County should not be under any threat of losing federal funds. There is not transparency around any federal funding that Howard County receives that would be threatened if additional steps would be taken to further bolster the County as an inclusive, supportive, compassionate community.

• I have the privilege of being a Caucasian, able-bodied, straight, able-bodied, educated, upper middle class, U.S. citizen, of a non-threatened faith. I have MANY friends and colleagues who do not fit one or more of these categories. As I wrote in my November 20th Op Ed in the Baltimore Sun regarding Governor Hogan's lack of leadership around the rise of hate speech and actions, "There are children in Maryland who are now living in fear due to circumstances around which they have no control — the color of their skin, their accent, their religion, their disability, and so on. Friends of mine have been called the N-word for the first time in the diverse and inclusive community of Columbia. Other friends are afraid to wear any public indication of their religion due to harassment."

Now more than ever we need thoughtful, courageous leadership to protect our communities where state and federal leaders will not. I am appreciative that Dr. Ball and Ms. Terrasa put this bill forward and hopeful that both Ms. Sigaty and Mr. Weinstein will support it, making County Executive Kittleman's premature veto determination moot.

Testimony for CB9-2017 January 17, 2017

My name is Chris Krupiarz and I am a resident of Ellicott City.

On July 1st, 2015, Kathryn Steinle was shot and killed by Juan Lopez-Sanchez on Pier 14 in San Francisco. Mr. Lopez-Sanchez was an undocumented immigrant from Mexico who had been deported five times. He had also been arrested for crimes including heroin possession and manufacturing narcotics.

I mention this tragic event because it represents a primary fear of this legislation. Take a group of people from any country, county, city, or state and there is a risk someone will commit terrible acts. This includes crimes, potentially, against my own family. If we act to remove that entire group of people, we remove the risk.

While we should never forget this shooting, an act that represents the worst side of human nature, we should also remember there is another side of human nature: our common rights that know no borders.

I was born in Lansing, Michigan in 1966. My Mom was a nurse, my Dad a Personnel Director. Along with six brothers and sisters, we were a middle class family living in a middle class home with access to good schools.

What gave me this good fortune? God? Luck? Why wasn't I born in Allepo or Port-au-Prince or Nuristan or Juba. I did nothing proactive to deserve this fate.

By focusing on the very few that may increase risk, we miss seeing the vast majority of immigrants who are simply seeking what I, and many of us here today, were lucky enough to be born with. And that is the human right of freedom from oppression and an opportunity to live, study, and work in a welcoming community. Our community.

Last fall, I read an essay written by Jason Motlagh for Outside magazine entitled "A Terrifying Journey Through the World's Most Dangerous Jungle." This piece tells the story of the Darién Gap between Colombia and Panama. There, travel a large number of migrants from Asia, Africa, and other parts of the world. In the article, Mr. Motlagh writes:

"Some ugly myths have taken root in the United States that these people are predisposed to be criminals, a dormant threat to our national security and a gathering drag on our economy...Yet, somehow people of all stripes keep angling for our faraway borders with their dreams intact, risks and distances be damned.

Inevitably, through sheer force of will and a lot of good luck, some of the ones stranded in Colombia will make it to Panama and on to the United States. Maybe they'll be spared the onerous jungle crossing; maybe they will get a berth on an airlift; or maybe they are bushwhacking a new route through the darkness of Darién Gap at this very moment, their feet and gazes in lockstep forward against the inertia of fear and cynicism, driven by visions of something better.

They are our past, our present, and our future.

And they are worthy."
