



With the proposal of this bill, you are saying to us, the law-abiding citizens of Howard County, that you will not abide by the law.



This bill is a declaration of the warm and welcoming atmosphere of our diverse county that stands for civility, decency, and acceptance and the right to be free of prejudice, bigotry, and hate—values that the citizens of Howard County expect our county to uphold.

CB 9 ensures a safe environment for people to share information with school or government workers or officials without fear of potential detention or deportation. For county employees to inquire about a person's national immigration status is not a function of county government or county law enforcement.

This bill abides by all county, state, and federal law and does not break or condone breaking any laws. It clearly states that county resources should not be expended in enforcing federal laws of the Immigration and Custom Enforcement agency. There are federal law enforcement officials whose task it is to enforce such laws. This is not our county's task.

Jeff Vandenbroek Highland, MD Testimony of James N. Purcell, Jr., Chairman of the Board of Directors, US Association for International Migration, before the Howard County Council, Re: Bill No. 9-2017, January 18, 2017 (jpurcell7@verizon.net)

My objective is to put the sancturary cities debate on a higher plane. It is part of a much bigger issue that is playing itself out around the world.

For nearly 50 years, I have worked as a humanitarian diplomat to promote the principle of safe, orderly, and legal migration. Working in the U.S. and with other governments around the world, I have sought to establish and promote national and global migration regimes that are open, generous, diverse, that provide opportunity, and that are legal.

I have found that the greatest enemy of efforts to promote orderly and safe migration are governments, local, state or national, that tempt people (rejected or unvetted asylum seekers, visa overstayers, or those who decide to avoid the legal migration route altogether) to skirt the system, to work around the system, to gain immigration advantages. Sanctuary cities – counties – are a noteworthy example.

My cumulative experience demonstrate that legal refugee and migration systems have proven adequate for national and global needs and can fulfill them in ways that protect the human rights of all applicants. It is therefore, not necessary – in my opinion – to establish faux-migration systems, like sanctuary cities, counties or states to guarantee protection or human rights for legitimate migration populations. Let me illustrate.

At the end of the Vietnam War, Secretary of State Cyrus Vance asked me to head up an efflort to create a rescue mechanism for the millions of Southeast Asis allies (Vietnamese, Cambodian, Laotian) left behind after American troops withdrew. That led to creation of State's "Refugee Program" which I led for most of the next decade. As Assistant Secretary of State for Refugee Program, I was the head of the American refugee program, involving multiple federal agencies, state and local governments, NGOs, multilateral organizations and partner governments.

Over the next decade, we resettled almost a million refugees in the United States and almost that many were resettled by other governments. The U.S. also helped hundreds of thousands gain political asylum in this country or to return those who did not qualify. We convinced doubting government heads, legislative bodies, NGOs, state and local governments, etc, that we could manage the social, political, and economic consequences of this vast movement of people in beneficial ways for out societies. We established vetting procedures that ensured that those who migrated met legal requirements for admission. After many hours and days of contentious testimony before the U.S. congression and multilateral organizations, we achieved consensus on humane and lawful admissions programs.

We assisted people like many of those we have heard about over the past two days. These were people fleeing persecution for reasons of religion, race or national origin, forced out of their homes because of war, corruption, or natural disasters, enterprising young people seeking to expand their horizons and world view, people seeking to better provide for their families, and a host of other legitimate reasons. They made incredible contributions to our societies. And, they came legally.

I was introduced to the notion of sanctuary cities almost four decades ago, in Central America. Some religious and academic groups opposed to Reagan administration policy in Central America convinced large numbers of people - who did not qualify for refugee or asylum status - to clandestinely flee to the United States and seek safety in secure places beyond the reach of U.S. law, which they called sanctuary cities. Our efforts to convince the Central American governments to undertake needed reforms to keep their citizens at home, or to convince protected poulations to return and seek legal entry, were undermined by the so-called sanctuary cities. Why should they take the risk? I had the same reaction to - and experience with - many other sanctuary cities established during that period.t

After the State Department, I was nominated by Presiden Reagan to become the U.S. candidate to be Director General of the IOM in Geneva. I won a five-year term in 1988 and was renominated by President Clinton in 1993 for a second term.

My job there was to work with the world's governments to "again" promote the safe, orderly and beneficial movement of people between governments and societies. Over my time there, we helped over four million relocate from danger, poverty, corruption, or to find better opportunities elsewhere. We found many governments and societies willing to become their brothers' keepers, and to do so lawfully.

Unfortunately, migration trends are worsening today. Populatons of endangered people around the world are rising to epic proportions. The number is now estimated at 65 million and rising; it has doubled in the last three years. Governments in all regions are beginning to reacting defensively, setting up walls or other defensive barriers to keep people out. Previously welcoming doors are slamming shut. That's obviously a reaction to terrorism and a growing concern that governments and societies can no longer control their borders and protect their citizens and economies.

How do we counter these negative trends? We must work to assure citizens in this country and around the world that, even as we reach out to help the multitudes of deserving people around the world, we can identify and keep out harmful or unlawful elements — and that we can admit those our economies need or who need protective assistance.

Why so much concern about rejected or unvetted asylum seekers, or migration system abusers? Just look at Germany today. About 1.2 million unvetted asylum seekers came last year. The result: Gernmany and the rest of Europe fractured, migration barriers croping up throughout Europe and around the world, societies turning inward.

At the initiative of President Obama, the world's government met at the UN in New York last September to discuss these growing world problems. They agreed to work on, over the next two years, and hopefully approve two new global compacts addressing these growing problems. One compact will be devoted to refugees and the other to migration. This is where we should be putting our energy and attention.

We can do better. We must do better. Side initiatives, like CB-9, dimish — and triviaize - efforts to make needed course adjustments in migration regimes and approaches. I do not support CB-9.

It presents an "us versus you" mentality, which makes it hard to come to any resolution without a feeling of win or lose. We need to do better than this in Howard County.

I hope you will consider the pros and possible cons of this bill and make the decision to support CB9. Thank you for your time.







Council members, I oppose the adoption of CB-9 for the following reasons:

- 1. Federal laws are promulgated that establish when to contact immigration agencies during the processing of criminals. Local government should not attempt to establish procedures that call for disregarding federal law, policies, or agreements.
- 2. Laws are established through a rigorous process. You get to participate in that process, however, once codified, one doesn't get the ability to pick or choose which laws you want to observe.
- 3. By the adoption of CB-9, you put the Howard County Police Department in an untenable position of not enforcing certain already established laws.
- 4. Columbia, a city recently selected as the best place to live in the U.S. by a major magazine, didn't gain that distinction by being a "sanctuary city." Instead it earned that award by being represented by hard-working, tax paying residents.
- 5. Howard County, while generally affluent, does not have unlimited resources. Simply put, resources devoted to illegal immigrants in the County detract from those available to law-abiding citizens.
- 6. If CB-9 were to be adopted, the loss of federal government funding may ensue (as mentioned in testimony by HCPD Chief Gary Gardner). Additionally, he spoke of potential loss of working alliances with certain federal agencies charged with investigating crime if Howard County were to become known as a "sanctuary county."





proposed CB9 legislation. I feel confident that once all of the testimony and facts are considered by all council members regarding this bill, it should die by a majority vote in opposition. If it doesn't, it will most certainly be vetoed by our County Executive.

However, I still believe it important to express my views about how troubling it is that we currently have elected officials that would seriously consider proposing legislation that would label our great county as a "Sanctuary County" given there's **absolutely no benefit to those that you represent by doing so**. We as taxpayers gain nothing, but stand to lose a lot.

Make no mistake, there has been a drastic increase in serious criminal activity and financial strain experienced by other municipalities throughout the country that have passed similar legislation. At the end of this week, we will have a new federal administration that will deny our county federal funding that might be needed to address a variety of serious issues we may encounter at any time, and some that might actually be created by this proposed legislation. All very serious risks at least a couple of you are willing to take simply for political posturing, pandering, and potential electoral advantages for your political party in future elections.

When I originally proposed, and Councilman Fox, and former Councilmember Courtney Watson, kindly cosponsored <u>CB30-2011</u> (28 minutes into <u>legislative session</u>), an act allowing for a 100% property tax credit for all of our county's non profit 100% volunteer swim clubs, at a cost of about \$50K per year out of an overall budget of \$1.5B, despite multiple local municipalities having previously enacted this same legislation, the council previously enacting <u>CB59-2005</u>, and the **zero nay** unanimously supported <u>SB982</u> <u>CH446</u> state enabling legislation allowing the county to do so; it was voted down by Councilmembers Ball, Sigaty, and Terrasa. I find it very difficult to understand how at least two of them would now be willing to risk losing \$1.2M alone, that ICE alone contributes annually to the county's general fund, to help their constituents live safely. And that would be just the beginning as the new federal administration begins systematically, and deservingly, defunding all "sanctuary cities" throughout our great nation.


I really don't care how you try to spin this, that you're simply not willing to allocate county resources to offer federal immigration authorities assistance, despite their willingness, and financial contributions, to help keep those that helped you get elected, your tax paying constituents that contribute to your campaigns and salaries, safe, it's blatantly partisan and horrible for the county. This proposed legislation puts an embarrassing beacon on our community encouraging those that commit illegal acts to flood into our communities. We are a nation of immigrants, but we are also a nation of laws, and those laws are meant to protect your tax paying constituents. 

My husband, also raised in Howard County and also caucasian, and I decided to raise our kids here because of the diversity of the community. The lessons we learned growing up with classmates and friends from a variety of races, cultures, and religions, enriched our childhood. They helped shape our core values regarding equality, civil rights, respect, tolerance, and being a good person.

Our kids are being raised in a diverse neighborhood, in a diverse community, with a beautiful rainbow of peers at school. My daughter has become close with 2 friends who are Latina and I believe are first generation Americans. How will they and their loved ones be treated in this xenophobic environment? Will their parents be forced to produce their papers for inspection as they try to go about their daily lives? Will they live in fear of acts of bigotry? If they are undocumented, will they live in fear of being discovered by overzealous xenophobes eager to expose them for "invading" the community. This bill could help them and others like them.

Most of us do not have ancestors who are native to this country. It is hypocritical as well as heartless to not care for the well being of undocumented residents, who are just trying to improve their and their family's lives. It is wrong to force some citizens to produce proof of their legitimacy based on their ethnicity, race, nationality, religion, etc.

TESTIMONY IN OPPOSITION OF CB9-2017

.Councilmember's,

I am a Marine Corps Veteran with service from 2000-2011; the oldest of eight children; a Tucson AZ native, raised back-and-forth between Tucson Arizona and San Diego California. My Father is the youngest of 12 children and a legal permanent resident alien. We are Spaniard, Chiricahua-Apache, and Pueblo Indian. I joined the Marine Corps and moved my family to the east coast -- the opposite side of the country -- to ensure my wife and children would be raised far far away from the destructive influences of illegal immigration and drug smuggling.

Unlike anyone who has testified before you on this matter, I have grown-up with the very real consequences of drug smuggling and illegal immigration. I was raised with drug smugglers, coyotes, and illegal aliens. I've survived, the poison and cancer, which accompanies smuggling, illegal immigration, and drug trafficking. My uncle was mowed down with automatic firearms for his interaction with cartels. Throughout the 70s and early 80s members of my family and family friends smuggled drugs across the border, sometimes using heavily loaded small planes flying within a couple hundred feet above the ground. During my youth my family name was a death sentence in parts of Mexico. I grew up in fear and hatred of the crimes being committed by my illegal alien family members, and family friends. Thus, I am categorically opposed to even the perception of sanctuary for illegal aliens.

Ball and Terrasa, you may genuinely have the best intentions but you are, either, at best unwittingly or at worst intentionally, fostering a community situation supportive of the same criminal element I fled the southwest to protect my wife and children from.

Of all The testimonies I heard over the last two nights, not a single person in favor of this bill has testified of any firsthand experience living with drug smugglers, illegal aliens, and coyotes along our western border. What we have had are a number of brazen illegal aliens testify at this hearing with entirely zero fear of being deported for breaking our immigration laws. They even go so far as to identifying themselves as "undocumented citizens" in an attempt to normalize their criminal behavior. These testimonies are proof positive that illegal aliens in our community already have zero fear of our police officers, no respect for our rule of law, and zero fear of prosecution or deportation.

The politically motivated divisive speech, used to justify CB9-2017, appears to be nothing more than self serving political posturing and pandering to anti-Trump voters. Further, it is dangerous and irresponsible to continually associate President Donald Trump with unfounded allegations of xenophobia, Islamophoba, racism, and sexism. No American citizen should be called Xenophobic Islamophobic, racist, or sexist for

wearing a T-shirt in support of the President of the United States of America. These baseless accusations and divisive language only succeed in further polarizing our community. It fosters derision, hostility, ridicule, and bullying of patriotic children who are guilty of nothing more than respecting and supporting the President of the United States of America. No child should be afraid to show open support for our President.

As evidenced by the previous testimony of several illegal aliens, you do not need to codify this inflammatory language to help illegal aliens feel safe and at home in Howard County. If Calvin Ball and Jen Terrasa wish to help illegal aliens perhaps they can start holding town halls and community outreach programs to inform illegal aliens of current Howard County Police policies for dealing with immigration status issues. You can have a greater impact with outreach efforts informing illegal non-English speaking immigrants of current Howard County police procedures than by making the foolish assumption that non-English speaking illegal-immigrants are going to take the time to read and understand this bill. Even if you do enact this bill to affect the changes you have spoken of then you are still going to need a massive outreach effort to inform non-English speaking illegal immigrants that Howard County advocates violation of Federal immigration laws.

Board members, by voting yes on CB9-2017 you are setting a dangerous precedent, subverting the rule of law, and condoning criminal violation of U.S. immigration laws under the U.S. Immigration and Nationality Act. A yes vote on CB9–2017 also has far reaching nationwide implications for the safety of border patrol agents and law enforcement officers in all states between Mexico and Maryland. You are, in effect, sending out a nationwide call for illegal aliens to travel across the country to take up residence in Howard County Maryland.

I strongly urge you to vote no on CB9-2017.

Is it a Crime to Enter The U.S. Illegally? Illegal entry (or "improper entry") to the US carries criminal penalties (fines and jail or prison time), in addition to civil penalties and immigration consequences (deportation and bars from future entry).

Whether it's by crossing the U.S. border with a "coyote" or buying a fake U.S. passport, a foreign national who enters the U.S. illegally can be both convicted of a crime and held responsible for a civil violation under the U.S. immigration laws. Illegal entry also carries consequences for anyone who might later attempt to apply for a green card or other immigration benefit. The penalties and consequences get progressively more severe if a person enters illegally more than once, or enters illegally after an order of removal (deportation) or having been convicted of an aggravated felony.

What Is Illegal Entry?

The immigration law actually uses the term "improper entry," which has a broad meaning. It's more than just slipping across the U.S. border at an unguarded point. Improper entry can include:

- entering or attempting to enter the United States at any time or place other than one designated by U.S. immigration officers (in other words, away from a border inspection point or other port of entry)
- eluding examination or inspection by U.S. immigration officers (people have tried everything from digging tunnels to hiding in the trunk of a friend's car)
- attempting to enter or obtain entry to the United States by a willfully false or misleading representation or willful concealment of a material fact (which might include, for example, lying on a visa application or buying a false green card or other entry document). (See Title 8, Section 1325 of the U.S. Code (U.S.C.), or Section 275 of the Immigration and Nationality Act (I.N.A.) for the exact statutory language www.uscis.gov/laws/immigration-and-nationality-act.) Criminal Penalties

For the first improper entry offense, the person can be fined (as a criminal penalty), or imprisoned for up to six months, or both. For a subsequent offense, the person can be fined or imprisoned for up to two years, or both. (See 8 U.S.C. Section 1325, I.N.A. Section 275.) But just in case that isn't enough to deter illegal entrants, a separate section of the law adds penalties for reentry (or attempted reentry) in cases where the person had been convicted of certain types of crimes and thus removed (deported) from the U.S., as follows:

- 1. People removed for a conviction of three or more misdemeanors involving drugs, crimes against the person, or both, or a felony (other than an aggravated felony), shall be fined, imprisoned for up to ten years, or both.
- 2. People removed for a conviction of an aggravated felony shall be fined, imprisoned for up to 20 years, or both.
- 3. People who were excluded or removed from the United States for security reasons shall be fined, and imprisoned for up to ten years, which sentence shall not run concurrently with any other sentence.
- 4. Nonviolent offenders who were removed from the United States before their prison sentence was up shall be fined, imprisoned for up to ten years, or both. What's more, someone deported before a prison sentence was complete may be incarcerated for the remainder of the sentence of imprisonment, without

any reduction for parole or supervised release. (See 8 U.S.C. Section 1326, I.N.A. Section 276.) Civil Penalties

Entry (or attempted entry) at a place other than one designated by immigration officers carries additional civil penalties. The amount is at least \$50 and not more than \$250 for each such entry (or attempted entry); or twice that amount if the illegal entrant has been previously fined a civil penalty for the same violation. (See 8 U.S.C. Section 1325, I.N.A. Section 275.) Immigration Consequences of an Improper Entry

A person who comes to the US without permission of the immigration authorities is inadmissible. To learn more about inadmissibility, see Who Can't Get Into The United States? In practice, that usually means that if the person became eligible for a green card or other immigration status, he or she would be ineligible to adjust status within the United States. By leaving the U.S. and applying from overseas, the inadmissibility problem could be solved – unless the person had already stayed in the U.S. for six months or more without a right to be there. In that case, he or she would run into a separate ground of inadmissibility, based on "unlawful presence" in the United States. (For more on how that affects your possibilities of obtaining a green card, see Legal Options for an Undocumented Immigrant to Stay in the U.S.) If a person was removed from the U.S. (deported) on the basis of a conviction for an aggravated felony (other than illegal entry or reentry), then the improper entry itself is considered to be an aggravated felony. (See 8 U.S.C. § 1101(a)(43)(O).) Having one of more aggravated felonies on one's record is a huge problem, because aggravated felonies bar a person from virtually all immigration benefits, and are a grounds of deportability (under 8 U.S.C. 1227, I.N.A. Section 237).
