Hi Bev,

As we discussed earlier this week, there seems to have been some misunderstanding regarding the legislative timeline for the capital budget request submitted to the Council which was dated October 5, 2016, and was received on October 11, 2016.

I have spoken with Jennifer Sager and understand that she was already planning to prepare a TAO for the requested transfer to be prefiled later this month for introduction in November. Based on my conversation with you on Tuesday, I understand that this timeline is acceptable to HCPSS, as it would provide for Council action on the request at its legislative session on December 5, 2016.

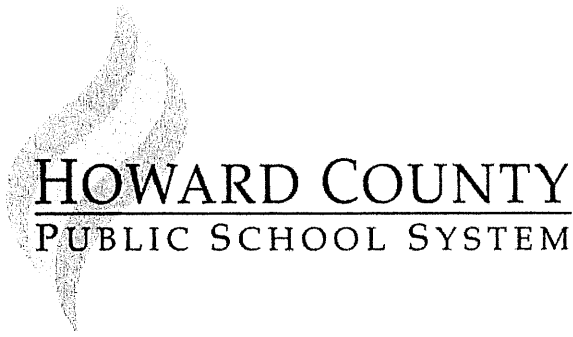
Given this timeline, here are the steps we should follow to move the request forward:

1. Please send a written withdrawal of the transfer request dated October 5, 2016.
2. Continue to coordinate with Ms. Sager for a TAO to be prefiled with the Council on October 27, 2016.
3. Submit your official request for the transfer to the Council on November 7, 2016 (the date on which the TAO will be introduced).
4. The Council will hold a public hearing on the TAO on Monday, November 21, 2016.
5. The Council will be able to act on the TAO at its legislative session on Monday, December 5, 2016.

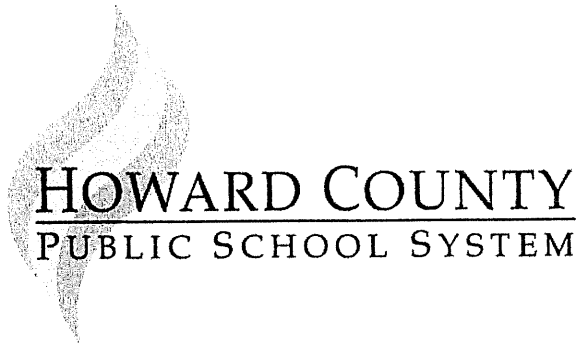
