Dear Councilwoman Sigaty,

I attended the County Council working session on January 23 to learn more about CB9 and was there for most of the testimony. Yesterday, I called your office (I live in District 4) and had a very helpful discussion with Julia Singleton. I was pleased to learn that the Council is considering actions in addition to a yes/no vote on the bill as it now stands.

I identify as a Democrat, and a liberal Democrat. I want all of our residents to have fair and equal access to County benefits, opportunities, and services. However, I don't believe this bill, in its current form, is the best way to achieve this goal. I don't believe that Howard County should be declared a sanctuary county.

As I understand it, most of the provisions are already de facto in effect in Howard County. I hope that will continue, and I completely understand that our undocumented residents feel less safe than they did before the recent election. I want them to be able to continue their lives here, and I do not think it is the job of our police force to enforce immigration law. But I also believe there are risks inherent in codifying this into the current bill: increasing polarization of views in the county, and potentially drawing attention and making matters worse for undocumented residents. As a result, I support an increased effort behind assuring our undocumented residents that the County plans to continue current practices as they are. This may or may not involve new written provisions. I don't know.

What I would like to see is some creative problem-solving to develop a strategy that is most appropriate for Howard County in 2017. I would like to see different groups who are involved – FIRN, HopeWorks, The Howard County Police Department and other County agencies – working with the County Council and taking advantage of the best legal and programmatic expertise applied to the particular context of our County.

We live in a community with a commitment to human rights. Let's come up with a creative solution together.

To the Howard County Council,

As many really great people have said to me, “we can’t just keep talking” – we have to act. I am writing to you this evening, to express my thoughts on CB-9. I believe that it is imperative that CB-9 passes. Aside from the political events which have just transpired, including recent statements and orders from President Trump, there are other considerations. Sanctuary cities are important, because they recognize that individuals need to live and work in a calm, safe location. I believe that I am taking for granted, at this very moment, the safety and security that comes from being someone who is a citizen of the United States. Right now, without Sanctuary, individuals will have no sense of security or calm.

Research has shown that immigrant-inclusive areas, including areas with measures such as Sanctuary provisions, have decreased rates of mental-health issues among Latino immigrants within the community. Sanctuary is a form of a “structural” provision which would benefit individuals in an assurance that they can trust individuals around them, including law enforcement officials. I will affirm many of the points that proponents of CB-9 have laid forth. But I will also stress the importance of immigrant communities. Individuals who I have observed, as clients at FIRN (Foreign-Born Information and Referral Network) in Columbia, where I interned are good people. They are calm and kind. Individuals whose cases I researched – I am assured that these people are simply trying to find legal immigration options within a system that is not amenable to them. Amidst a complicated and difficult national structure, can’t we help immigrants in Howard County, through a Sanctuary bill that would make life easier?

Beyond the economic benefits that immigrants bring to any community, there are also other aspects of the Howard County community which immigrant residents enhance. There are local business and cultural affairs which immigrant residents have a large part in. The Howard County government and other testimonials as well as FIRN have acknowledged this. There are so many students who are trying to gain an education and benefit the community, as has been demonstrated by individuals testifying at the county council meeting recently. But, there is also the consideration of the roles that Howard County officials play in daily life.

Police officers who would like to uphold the laws, and who are tasked with apprehending criminals – they still can do this. Individuals must follow the law, and proponents of CB-9 understand this. But Sanctuary, at its core and as I understand it, must protect individuals who are in violation of civil immigration law. The county must operate on a basis of not asking about immigration status. And federal laws would be upheld, or state laws that contradict the current Sanctuary provisions. CB-9 is not outrageous, but it is Sanctuary. It is trying to protect Howard County residents.

In the name of civil rights, and in the memory of the inclusive community that so many have championed in Howard County – please support CB-9. This, as others have mentioned, will protect and support all in Howard County.

But we have no right to take their freedom away from them. The Constitution endows individuals with rights, including freedom of religion, or assembly. In 2011, the Government Accountability Office (GAO) released a study on approximately 250,000 illegal aliens locked up in our federal, state, and local prisons. They represent more than a quarter of all of the prisoners in the federal prison system alone. **The GAO's "study population" had been arrested nearly 1.7 million times and committed three million offenses, averaging about seven arrests and 12 offenses per criminal alien.** The incarcerated aliens had been arrested for a vast array of crimes:

- 49 percent had been arrested for drugs;
- 37 percent for burglary, stolen property or robbery;
- 35 percent for assault;
- 21 percent for fraud, forgery or counterfeiting;
- 19 percent for weapons violations;
- 13 percent for homicide or kidnapping, and
- 12 percent for sex crimes.

Jessica Vaughan of the Center for Immigration Studies analyzed Immigration and Customs Enforcement (ICE) records and found that during just one eight-month period in 2014, sanctuary jurisdictions released more than 8,100 deportable aliens. **Of those, 62 percent had a prior criminal record; 3,000 were convicted felons. Of those released, 1,900 were later rearrested a total of 4,300 times on 7,500 different offenses.** As Vaughan says, "when local jurisdictions shield aliens wanted by the feds, the aliens can commit more crimes."

Sanctuary cities are not only perilous to the lives and safety of innocent Americans, **they are violating federal immigration law.** 8 U.S.C. §1373 bans state and local governments from prohibiting or restricting law enforcement or other government officials from sending or receiving information from the federal government on the "citizenship or immigration status, lawful or unlawful, of any individual."

Too many Americans are being assaulted, murdered, kidnapped, and otherwise victimized by sanctuary policies that allow dangerous criminals to remain on the streets. There is no justification for these policies – if you doubt it, just ask the families of those who have been lost because known criminals were given sanctuary by supposedly "caring" government officials.

In closing, will HoCo government be held accountable for any harm brought to county residents resulting from a sanctuary policy. Or will it hide behind sovereign immunity from lawsuits? And will it waive its
