

As a fellow long-time (43 years) resident of Columbia, and having grown up a family friend, and later an employee of Jim Rouse, the ideals upon which our city was founded are well-ingrained in my head. Columbia was built to be a city that was first and foremost a welcoming beacon to ALL people. You see the remnants of this ideology in the racial mix of our residents, and now to a lesser extent, the economic mix of our residents. These ideals shaped me as a person as they did many of my fellow Columbians.

This resolution is not creating racial tension or animus, any more than having a black president created racism in America. It is exposing the reality that the dream of Columbia is not an easy one to execute and maintain over the years. It may be easy for white men like us to not realize the depth of everyday oppression people of color feel, even here in Howard County, but it does indeed exist. And the only way we can ensure that the ideals on which our community was founded can survive is to plant a flag firmly in the ground on behalf of those ideals, on behalf of ALL people who are welcome here. This is not just about protecting the "little guy" but about protecting what we as a community committed 50 years ago to care about.

The discussions around this resolution are indeed exposing some deep-seated emotions and discrimination that we may have wanted to pretend did not exist. But they do, and better that they get discussed than to go on living like a 1950's marriage of pretend bliss. Part of the reason so many people have been comfortable expressing some pretty hateful feelings of late has a lot to do with the campaign and election of President Trump, who has made a lot of hay spewing hate speech. Trump is a classic bully, the latest evidence of which came yesterday in his threats to "sanctuary cities." These are threats, not likely to be backed up on (there is a great Washington Post article from a day or two ago about this) as Maryland is an unlikely state to be targeted and many of the proposed threats are likely unconstitutional. But ultimately, it is incumbent upon our community to stand up to the bully and to protect our way of life. A way of life that welcomes everyone, that seeks to treat everyone as equals.

I know that sounds silly to most of the country, but we grew up on those notions here in Columbia, and they are part of who I am. That doesn't mean we are perfect, and it doesn't mean that racism is absent from our community. It is hard work respecting all people, but we need to speak loudly that that is what we in Howard County intend to do.

The following is written testimony that I was not able to get to during the allotted 3 minutes of oral testimony on January 18, 2017. With only three minutes to speak at the hearing, I appreciate the opportunity to extend my remarks here.

As I mentioned at the hearing, after reading the draft legislation known as CB 9-2017, I find multiple reasons to OPPOSE its adoption and implore my elected officials to vote AGAINST it. Also, I knew next to nothing about this topic prior to January 3, 2017 and have attempted to educate myself in the interim. If I have misunderstood anything stated herein, I'm open to correction. However, based on my reading to date, this bill is incredibly flawed. The following is a summary of my opposition.

1. A Less than Transparent Process.

On December 31, 2016 I was minding my own business and enjoying the holidays with my family. Then I received an 'alert' email from the Baltimore Sun indicating that my County Council would take up legislation on January 3, 2017 to make Howard County a 'Sanctuary County'.

What? What is a Sanctuary County? How did I miss this one? Why hasn't this been all over the papers? Well its gets worse. The actual schedule for adoption is as compressed as legally permissible:

- Introduction and first reading: January 3, 2017.
- Public Hearing: January 18, 2017
- Worksession: January 23, 2017
- Posting: January 26, 2017
- Council Vote: February 3, 2017

Wow. What an incredibly efficient process! I've never seen government work this fast on anything.

As far as I can tell, prior to January 3, there was no public outreach, no pre-submission public meeting to enlighten the public on the facts, no staff report or analysis, no white papers, nothing. In fact, Councilmember Ball indicated that CB9 is simply a way to codify existing policy. Really? As far as I can tell in the limited time available, there is no written policy on sanctuary status for foreign nationals.

As I sat through the hearing process, it appears that Councilmember Terrasa did not have a full understanding of the legislation and had to educate herself on several of the facts as a part of the public process. I base this statement on my observations and the Councilmember's own public statements at both the public hearing and the worksession. I've also been told that she saw this draft legislation for the first time just hours before official introduction. If true, that may explain some of her confusion.

I have formally requested an explanation of the process by which this legislation was prepared. I have asked the County Council Public Information Officer for this information in a PIA request. In an official response to my first request, which was broad, the Officer indicated that 'most if not all of your request may be covered under Legislative Privilege.' Really? How so? I'm awaiting an explanation.

Then, during the public hearing and the worksession on CB9, I learn that the sponsors of this bill did not even have the courtesy to inform others on the Council of the bill prior to introduction. I also learned that the sponsors of CB9 never bothered to ask the opinion or request input from the Howard County Police or other officials within the government.

Then I learned that the sponsors of the legislations in fact solicited comment, opinion and input from proponents of the bill prior to its introduction. Now isn't that curious: police-no, general public-no, government officials-no, proponents-yes.

Now compare this process to, say, someone who wants to subdivide their lot into two lots. Before they can even submit any plans, they need to notify the public, have a pre-submission public meeting and answer questions. Then compare the above schedule and outreach to the update of the County's General Plan. It takes multiple meetings and multiple years to fully go through the process, not 30 days.

So the two County Council sponsors find it more appropriate to create a Sanctuary County along the same general timeline it takes to appoint someone to the Architectural Board and that a change of use for a commercial property or the subdivision of a lot should have an order of magnitude of public input and scrutiny greater.

I would suggest to the Council that CB9 has at least as great an impact on the general welfare and public safety as a General Plan update, or, at least as much as a change of land use. I'd like to know from EACH council member whether they agree or disagree with that statement. If they disagree, I would like to know why. I would also like to know who the sponsors met with in crafting this legislation prior to introduction. Does the public have a right to know? If not, why not.

2. A Play on Words.

Proponents of CB9 opine that it is 'not a crime' to enter the United States without permission or to extend a permitted stay beyond an agreed upon date of departure. Technically this is correct, however, it totally misses the larger point and is intended to purposely confuse the issue.

Illegal activity is activity that contravenes the law. Entering the US without permission is an illegal activity. Criminal activity is illegal activity that is also a crime. What constitutes a crime is usually detailed in a criminal code in each jurisdiction but can derive from common law crimes like murder, arson, rape etc.

Some in the general public may use the term 'criminal' in advocating against CB9, however, this should not be a reason not to listen to their views. It is my hope that the Council understands the plain meaning and intent of comments by many citizens of Howard County who are opposed to CB9, without getting into a weedy discussion of legalistic terminology.

Proponents say that the Immigration and Nationality Act“(the “Act”) does not even contain the term ‘illegal alien’”. Well that may be true, but it also doesn't include the term ‘undocumented resident’. What the Act does include are terms like ‘aliens’, ‘legalized aliens’, ‘aliens that are unlawfully present’, ‘aliens residing in an unlawful status’, ‘violation of immigration law’, etc. Proponents seem to want to imply to the Council that it is lawful to be a resident foreign national residing in Howard County without permission, but it is not. Their clever use of language attempts to disguise and obfuscate the real issues.

Furthermore, the Act was written in 1952 and has been updated and modified by various legislation and codes over the years, including laws such as *The Illegal Immigration Reform and Immigrant Responsibility Act of 1996* (emphasis added by underline). In many places, such as the United States code, the term 'illegal alien' is in fact used.

Why is this important? It appears that this clever use of the English language and limited explanation of the facts by the proponents may have had an impact on some of the members of the Council. At least two council members found it offensive and derisive to use the term 'illegal alien'. However, that is in fact the legally correct terminology.

- Illegal
 - (adj), forbidden by law or statute; contrary to or forbidden by official rules, regulations, etc..
- Alien
 - (adj), belonging to a foreign country or nation.
 - (noun), a foreigner, especially one who is not a naturalized citizen of the country where they are living.

So, to be clear, 'Illegal Alien' is in fact the most appropriate terminology and therefore I will use it in my testimony.

3. The Role of Local Government.

Proponents of CB9 argue that Howard County should not enforce federal immigration laws. They go on to say that it is perfectly legal to restrict information and to not cooperate with federal authorities. On the first point they are correct, the US Constitution reserves the responsibility for naturalization to the federal government.

However, Section 1373 of Title 8 of the U.S. Code prohibits governments at all levels from restricting the reporting of immigration status information. That section reads, "Notwithstanding any other provision of Federal, State, or local law, a Federal, State, or local government entity or official may not prohibit, or in any way restrict, any government entity or official from sending to, or receiving from, the [DHS] information regarding the citizenship or immigration status, lawful or unlawful, of any individual." That same section goes on to further prohibit the restriction of the exchange of information between federal, state, and local governments. It is clear that the intent of Congress was the free flow of information between all levels of government when it comes to immigration status.

Additionally, Congress created the 287(g) program, which has been used by other Maryland jurisdictions, whereby the federal government trains and deputizes state and local law enforcement agents to act as immigration officers. So it is clear that the purpose and intent of the law is that local governments should provide a free flow of information regarding immigration status, and could in fact be a part of the enforcement infrastructure. So to argue that a local government could obstruct the federal government in these matters seems to fly in the face of a reasonable reading of the code. To order employees to affirmatively not cooperate with federal authorities seems to go

well beyond the intent of the law and the relationship envisioned between government entities and could open the County up to law suits.

In the 2012 case *Arizona v. U.S.*, the U.S. Supreme Court upheld a provision requiring state and local law enforcement to make a reasonable attempt to determine the immigration status of persons involved in a lawful stop when officers have a reasonable suspicion that the person is unlawfully present. The Court found that the state provision did not conflict with federal law; rather, the Court said it fostered the cooperation expressly encouraged in federal law between federal officials and state and local officials and it made clear that no formal agreement or special training needs to be in place for state officers to ‘communicate with the [Federal Government] regarding the immigration status of any individual....’”

4. A Country of Laws, yes or no?

For the past 16 years, both republican and democrat administrations at the federal level have not enforced the immigration statutes. However, the fact that previous administrations have ignored this portion of the law by executive fiat doesn’t change the law. The fact that the current administration has indicated that they will ‘enforce the laws on the books’ seems to require cooperation at some level by Howard County. CB9 does the opposite.

The County Solicitor testified that the County, based on recent court cases, has the ‘ability to choose’ whether or not to adhere to their obligation under the law and whether or not to cooperate and share information with the federal authorities. Has the County Solicitor offered this opinion in writing? Is it available to the public?

My question to the Council is simple: what if the County Solicitor is wrong? What does the legal landscape look like for Howard County if he is wrong? Clearly, other County Attorneys have a completely different view on this subject. Who’s to say one is right, and one is wrong? It seems that the only way to get a final decision is through a court challenge and adjudication. And who pays for that?! Yep, you guessed it, all the taxpayers of Howard County, not Councilmembers Ball or Terrasa.

If the County Solicitor is correct and the County Council can choose whether to ‘cooperate’ with the federal government regarding laws that are within the purview of the federal government, then Howard County should be free to pick and choose other federal statutes that they agree or disagree with, and act according to their ‘local policies’. Why not have a Sanctuary County for anyone who doesn’t want to pay the federal income tax, or chooses not to follow the ‘rules’ set forth by the Environmental Protection Agency? Why not create a Sanctuary County for persons who choose not to adhere to FCC standards of decorum? Either we are a country of laws or we are not. Which is it?

5. Obligations of Local Officials.

State and local officials have an obligation to protect its citizens from the harmful effects of illegal immigration.

One harmful effect of illegal immigration is the impact on public services. In the 1982 case of *Plyler v. Doe*, the Supreme Court struck down a Texas law and established a precedent that a local jurisdiction cannot withhold state funds for the K-12 education of illegal aliens. In that same case however, the Court recognized a state’s need to legislate against the negative consequences of illegal immigration.

The Court emphasized that, "Despite the exclusive federal control of this Nation's borders, [it] cannot conclude that the States are without any power to deter the influx of persons entering the United States against federal law, and whose numbers might have a discernible impact on traditional state concerns."

Negative impacts are real. Just look across the border to Montgomery County.

In September 2016, the National Academy of Sciences (NAS) published a major report entitled *The Economic and Fiscal Consequences of Immigration*. The report shows that, other than a small number of scientifically educated immigrants, immigration produces little or no overall economic gain for non-immigrants but may cause a substantial shift in income from employees to business and capital owners. The report indicated that as immigration increased or decreased the post-tax per capita income of the non-immigrant population was impacted in three ways: through an "immigration surplus," technological change, and a fiscal impact on government finances. In other words, immigration (whether legal or illegal) enriches business owners at the expense of employees and has a negative impact on government revenues.

Some facts that may be of importance to the Council on this issue:

- The national cost of illegal immigration on state and local governments is estimated at \$84 billion. What is Howard County's share? Does the County Council know the amount? If not, why not?
- This cost of educating the children of illegal aliens is estimated at \$44.8 billion. State and local governments are on the hook for nearly 99 percent of that burden. Case law requires education of illegal immigrant children. Has the County factored that impact into their consideration of CB9? If so, how much is it?
- Some illegal aliens pay taxes, and some don't. However, the net is in the negative. The average illegal alien household takes in \$14,387 more in benefits than it pays in taxes.

So, in general, the acceptance of illegal aliens in the population by our County Council will, by definition, add to the annual school budget, add to the general tax burden, and add costs to the services sector that will have to be passed on to those who pay into the system. My position is that Howard County has both the right and the obligation to avoid these impacts, and its allegiance is first to its citizens and taxpayers. It is clear, the County must deter the detrimental effects of illegal immigration, not encourage it, as would be the case under CB9.

6. Creation of a Protected Class.

CB9 states that illegal aliens cannot be discriminated against. Well isn't that above the law. Someone who is in the country without permission would be granted a protection higher than that of a citizen?

So, let's say, just theoretically, I note that one of my neighbors is in the country illegally, and that I make notification to the Department of Homeland Security. Am I in violation of CB9? Have I discriminated against this foreign national who has now received a right of protection?

What about the discrimination of legal immigrants. I've heard stories of people who have spent many years (6-12) going through the proper process. How is it that the protection class for illegal aliens is not a discriminatory act? How is it that essentially moving illegal aliens to the front of the line is not a discriminatory act to those still on the line? It seems to me that CB9 turns the law, ethical behavior, and

reasonable judgement on its head. It in fact rewards those who don't obey the law to the detriment of those that do, and then protects the law breakers.

7. There Goes the Money.

Just yesterday, the new administration has stated unequivocally that it will withhold funding from Sanctuary Cities (counties). Proponents of CB9 say 'don't worry, they can't do that'. They cite court cases, such as *Sibelius* to make their point.

However, what we have in the Proponent argument is same slight of hand they use in their other arguments. The federal government is not going to 'take it all away', but they could clearly reduce funding for impacted services, since, as stated above, the impact is voluntary on the part of the Sanctuary jurisdiction and completely within their control to avoid. In other words, the federal government can say to the local jurisdiction, "you made this mess and caused these cost burdens, you fix it". They would be completely within their rights to do so.

And yet, here we go down a path of financial impact that hasn't even been calculated. Correct me if I'm wrong but the County has not looked at any financial impacts associated with this bill? Who pays the bill? You guessed it, the Howard County taxpayer; not Councilmembers Ball or Terrasa, not CASA de Maryland, not Jonathan Greene. But don't worry, we have their word that there is nothing to worry about, they are the experts don't you know.

8. An Abundance of Inconsistencies.

CB9 is constructed one level higher than Rube Goldberg's mousetrap. It is fraught with inconsistencies, circular logic, propaganda, political statements, and the creation of rights for non-citizens and prohibitions against working with the federal government.

For example, the preamble says "Howard County is comprised of immigrants". Well that is correct, but as a legal document, this foundation statement should not conflate legal immigrants and illegal aliens.

The same preamble goes on to state that "the recent national political climate has galvanized support for xenophobic, Islamophobic, and racist sentiments within certain portions of the population, resulting in increased incidents of hate speech and violence". That's strong language. Where is this documented? How many incidents of hate speech? How many incidents of violence? Does it include hate speech against supporters of the President? What do you mean by 'certain portions of the population'? If this statement is 'foundational' to the ensuing document, it would be appropriate to know how much of this is actually occurring and how much it has increased in the 'recent' past.

Next, the County Council calls out the President by name, saying he bolsters such 'dangerous sentiments', causing several residents to 'fear for their personal safety and civil liberties'. So, it appears that the County Council is concluding that proponents of national borders and the rule of law are causing people to fear for their personal safety? How so?

Next, the County Council makes the foundational statement that anybody who lives in Howard County shall have access to County benefits, opportunities, and services, regardless of whether that person is here legally or illegally. Interesting...maybe we should all stop obeying the law, we still have access to all benefits, opportunities, and services.

Further on, the County Council states that “we need to be free of prejudice, bigotry and hate. So the County Council appears to be concluding that if you are a citizen, a taxpayer, a lawful resident and you think that we are a country of laws that should have national borders and that immigrants should enter the country in a legal manner, you are by proclamation of the County Council a prejudiced, hate-filled bigot. And the sponsors of this bill ask us to take this legislation seriously. Well, I do. If it wasn’t so serious, it would be a joke. Why not just add a ‘whereas’ and conclude that anybody who doesn’t agree with the County Council is irredeemable and part of a basket of deplorables’.

Finally, the County Council declares that Howard County is a sanctuary county. What? And what is the definition, from a legal standpoint? What are the impacts to the lawful citizens of the County? What are the costs to the taxpayers? What are the loss of freedoms associated with this change? What are the social implications? What are the fiscal implications?

The proposed code language, labeled as Subtitle 21 of Title 12 is a cut and paste facsimile from the Takoma Park code, but with stronger language to create sanctuary status, protect illegal aliens and stifle the rights of citizens. That’s interesting, the code language came from the same place CASA is located. I’m sure that’s just a coincidence.

Finally, there has been much said about the ‘safety clauses’ built into the legislation. The proponents of the bill are telling us all to relax, nothing in the bill will usurp or contradict federal law. Really? The whole bill is built upon the premise that we are not to work with the federal government in any way. Well, federal law, as mentioned elsewhere, does in fact provide for and assume cooperation between entities, thus a built in contradiction.

Based on my reading of the bill, CB9 is built on unsubstantiated claims, has inconsistent and circular logic, and it is built upon language from the hometown of one of its sponsors, uh, I mean proponents. Nothing in the bill has anything to do with the simple fact that for the first time in 20 years, the federal government has indicated that it will enforce existing law. Nope, our elected officials make a finding that that proposition is racist, xenophobic, etc. Sounds more like a political campaign statement than a proposed revision to the County code. Wait a minute, one of the sponsors of the bill declared his candidacy for County Executive just after the bill was introduced. Well isn’t that another interesting coincidence. Boy oh boy, this process and product are just chock full of coincidences.

9. Probability and Statistics.

Some have said that there are at least 12 million illegal aliens in this country, others have said the number is closer to 35 million. Nobody knows. No facts, no figures, nothing to work from. I saw a statistic that illegal immigration was somewhere between 500,000 to 800,000 per year. At the public worksession, someone said it is estimated that 11,000 illegal aliens live in Howard County today, but again, nobody knows. CB9 will only increase this lack of knowledge and data.

Proponents of the bill indicate that illegal aliens are less likely to commit criminal acts as compared to the naturalized population. Maybe that is true, how would anybody know? Proponents also indicate that illegal aliens are good people. I believe them, and I am sure most are, but not all. However, they are all law breakers by definition. Sorry to be so insensitive but it is a fact.

Based on statistics I have seen, about 20% of the general population has a criminal record. Others who act criminally but have not been caught are not included in that number. In Canada, it is estimated to be

about 10%. So, for the sake of argument, let's say that Howard County is somewhere between those two numbers, or about 15%. Now let's accept the 11,000 figure mentioned above. And let's also accept the premise by the proponents that illegal aliens are better behaved than native citizens, let us assume that they are, well, 50% better.

Finally, let us assume that for every 2 people with criminal records, there is only 1 person operating criminally but has yet to be caught. Well, the math would conclude that there are 550 illegal aliens acting in a criminal manner in Howard County at the present time but have not been convicted of a crime.

Whether you agree with the math or not, the number is not zero as one would be asked to conclude from Proponent testimony. In fact, I would argue that the number is probably higher. Now, based on CB9, these 550 persons are protected against deportation, and County officials and employees are forbidden to even inquire as to their legal status. On top of that, they are placed in a protected class that cannot be discriminated against, whatever that means.

Based on testimony from the worksession, this number is 100 times greater than the number of 9/11 terrorists that passed through Howard County. Go figure, by passing this bill our elected officials will be granting this population sub-set rights as long as they don't get caught. Now, add to that, the magnetic effect of Sanctuary Status.

10. Come one, come all.

Sanctuary status creates a beacon for illegal immigrants. This is not even arguable. It will increase the flow of illegal immigrants into Howard County. If bill CB9 were to be adopted, there is no limit as to how many would be allowed. In fact, the sky's the limit, the bill would actually prohibit any restrictions or monitoring. With the school system and great health care in the County, who wouldn't want to come to Howard County? And the best news is, if don't want to pay, you don't have to. Free schooling for your kids, free health care if you want it, government subsidies galore. Come one, come all. We are an open and inclusive county, we practice civility.

And the best news is, if some law-abiding, taxpaying citizen starts looking into your immigration status, don't worry, we'll make sure they are slapped with a discrimination law suit. And if we don't do it, we'll make sure one of our 'immigration experts' gets you in touch with an 'immigration attorney', possibly subsidized by the tax-paying sap, and he'll set him straight. In fact, you are free to wander, and the sap may get 3 to 5 years. Isn't Howard County a great place?!

11. Enabling our Enemies and Endangering our National Security.

If you are not keeping a database of illegal aliens, if you're not registering them, if you are not vetting them, if you are not deporting them, if you grant them special privileges, and you offer them sanctuary, I would argue that you are creating a haven for potential enemies and terrorists. As long as they don't commit a criminal act, they are free to set up shop and are protected by CB9.

Illegal immigration may be the most direct violation of our sovereignty and the sanctity of our borders, but the flaws in our legal immigration policies pose a real threat to our national security. Creating a sanctuary only makes it worse.

The same open borders and lax entry/exit controls that allow millions of economic migrants to settle here can be easily exploited by terrorists and others who threaten our security. In order to protect our nation, we need measures in place that significantly reduce the ability of potential terrorists to operate freely in the county. CB9 actually puts up roadblocks and barriers to enforcement and thus creates an environment for this activity to flourish, not unlike the pre-9/11 context where agencies and governments were not sharing information or working in concert.

12. Employee Disciplinary Policy Non-Existent.

CB9, sub-section 12.2102(B) states:

“IN THE PERFORMANCE OF OFFICIAL DUTIES, AN EMPLOYEE SHALL NOT ASSIST IMMIGRATION ENFORCEMENT IN THE COLLECTION OF INFORMATION ABOUT ANY PERSON, EXCEPT AS REQUIRED OR AUTHORIZED BY STATE OF FEDERAL LAW, INTERNATIONAL TREATY, OR AN EXISTING AGREEMENT BETWEEN THE COUNTY AND A FEDERAL, STATE, OR LOCAL AGENCY.”
(Emphasis Added)

So, if adopted, what is the policy if an employee does ‘assist immigration enforcement’? Will you do nothing? Will you reprimand? Will you dock the employee’s pay? Will you terminate that employee? Does this action open the door for legal action? I bet it does. I’m sure Mr. Greene and CASA can’t wait for the day.

None of this is spelled out in CB9. Nothing, and yet this bill is on a fast track. I think the County Council has an obligation to county employees to explain itself and to explain the implication of this bill prior to its adoption. Don’t the employees of the County have a right to know what you are getting them into? These lawsuits are occurring throughout the country, most recently in San Francisco.

As a commentary, it could be concluded that federal law ‘authorizes’ an employee to act in assistance to immigration enforcement. So who knows how to act under this bill? Seems like a litigation lawyers paradise. And who gets stuck with the bill defending the County? Not Councilmembers Ball or Terrasa. Yep, you guessed it, it’s the taxpayer, yet again. Not a very well thought out bill. Almost looks like an immigration attorney wrote it. Nope, I stand corrected, he only ‘consulted on it’.

13. Legal Sufficiency.

I’m not a lawyer, but the legality of this bill is certainly suspect. It also barely passes the legal smell test, but the County Solicitor has opined that it is legally sufficient. This is the term the County Solicitor used when asked if the bill is ‘legal’. So, what does that mean? It doesn’t appear as a defined term or phrase in the County code. I’ve asked the County for clarification. I would suggest that just because something is legally sufficient, it does not mean it is meaningful legislation.

14. Public Safety and the General Welfare.

If illegal aliens are not counted, registered¹ and/or vetted, how in the world do we know that they are healthy? How is amnesty and sanctuary for illegal aliens in any way in the public interest and a promotion of the general welfare? It’s not. The only solution is LEGAL immigration.

¹ Note that the INA of 1952 requires registration within 30 days of entry into the country.

15. The Benefits of Legal Immigration.

The solution to this problem is not illegality but legality. We are a nation of laws, and most immigrants respect that and work within the law. There are numerous benefits to legal immigration, none of which will be an outcome if CB9 is approved.

16. In Conclusion.

- Everything about this bill is upside down. Rights for illegals, limits on citizens.
- The bill is inconsistent within itself, contrary to standing law, and makes little sense.
- The preamble is nothing more than political propaganda.
- Everything about the processing of this bill is rushed and convoluted.
- Everything relative to its creation is cloaked in secrecy and potential Legislative Privilege.
- The sponsors never engaged the public, including the police, but engaged and consulted with proponents of the bill.
- There is no analysis accompanying the bill, nor estimates of its impacts.
- If adopted, it opens the County, its employees, and taxpayers to lawsuits and untold costs.
- It creates 'rights' for illegal foreign nationals that don't exist for citizens.
- It only creates problems. It solves nothing.

For all of these reasons, and the explanations above, I am adamantly OPPOSED to the adoption of CB9 and I implore the Council to withdraw it or vote it down. Thank you.

PS. Just to put an exclamation mark on this, the sentiment in the country is not in line with the tenets of this legislation. A loss of some federal funding is very real. County officials and employees will not be exempt from injunctions and potential fines. Here is just one example I found.

Yes: Havens for Alien Criminals Should Lose Federal Funding

President-elect Donald Trump has promised to do what no prior administration has done: end sanctuary cities.

Thank goodness. The federal government should crack down on cities that violate federal immigration law. In the process of flouting the law, these cities wind up creating havens for criminal predators who murder, rape, molest, rob and otherwise victimize law-abiding residents.

Sanctuary policies ban local officials, particularly law enforcement personnel, from contacting the Department of Homeland Security about illegal aliens who have been arrested, detained or otherwise stopped.

This clearly violates federal immigration law, which states that local and state governments "may not prohibit, or in any way restrict, any government entity or official from sending to, or receiving from, the Immigration and Naturalization Service information regarding the citizenship or immigration status, lawful or unlawful, of any individual."

Sanctuary cities claim this law violates the 10th Amendment, which reserves to the states all "powers not delegated to the United States by the Constitution."

But the Constitution does, in fact, give Congress complete authority over immigration matters. Article I, Section 8, Clause 4 declares that "The Congress shall have the Power to ... establish an uniform Rule of Naturalization."

In other words, states have no power over immigration matters other than what Congress grants them. States may pass state laws consistent with federal immigration law, but efforts by sanctuary cities to obstruct immigration enforcement violate the Constitution.

Thus, the next attorney general can go to federal court to obtain injunctions against any local jurisdiction that has implemented this type of sanctuary policy.

Any city official who violated an injunction order would be subject to the same type of contempt proceedings as segregationist officials who defied court orders issued during the civil rights battles waged by the Justice Department in the late 1950s and early 1960s.

As president, Trump will also be able to instruct the Departments of Justice and Homeland Security to bar any sanctuary city from receiving many of the grants and funding these departments have available for local law enforcement under numerous programs.

He may have the ability to withhold federal funding awarded by other executive branch agencies too, although this is something his new cabinet appointees should research and review.

But sanctuary cities aren't just violating federal law. They are also endangering their residents.

A Government Accountability Office report released in 2005 reviewed crimes committed by 55,322 immigrants who "had entered the country illegally and were still illegally in the country at the time of their incarceration in federal or state prison or local jail during fiscal year 2003."

The destruction inflicted by these 55,322 illegal immigrants was truly shocking. According to the GAO, they had been arrested a total of 459,614 times, averaging about eight arrests each. Moreover, they had committed almost 700,000 criminal offenses - about 13 offenses each.

Twelve percent of the arrests were for violent crimes such as murder, robbery, assault and sex-related crimes; 15 percent were for burglary, larceny, theft and property damage; 24 percent were for drug offenses. The remaining offenses covered the waterfront, from DUI and fraud to forgery and counterfeiting.

And every time one of these illegal immigrants was released back into the community instead of being deported, he was given yet another opportunity to injure more people.

Sanctuary policies are meant to be "humane." But they create safe spaces for dangerous criminals who should be deported, not protected by big city mayors.

If you doubt that, just ask the families of Kate Steinle and Tony, Michael and Matthew Bologna, all of whom were murdered by illegal immigrants as a result of San Francisco's sanctuary policy.

We need to make sure that no other families suffer such needless tragedies.
