NO SANCTUARY IN HOWARD COUNTY

I am opposed to the proposed measure to make Howard County, Maryland a sanctuary for immigrates that break the law to enter this Country. Please consider the following:

- This Country is based on the rule of law---indeed civil society depends on the rule of law. With this legislation, you invite people to break the law and then provide them with a sanctuary. Who decides what law is ok to break and what law is not ok to break? You say its ok to come to this Country illegally and this will be a sanctuary---what law is next? We cannot start down this slope.
- By passing this legislation you are promoting human smuggling. The vile scum that prey on the less fortunate will now have another sanctuary location to convince people to pay for their services. How many desperate people will fall for this?
- By passing this legislation you provide a motivation for people to break the law----break any law and get to Howard County any way you can and you will be safe----that is essentially what this legislation says. The illegal journey into this Country is dangerous----will there be blood on your hands? If anyone uses this legislation as motivation and they die en-route, their blood is on you.
- When this county loses Federal funding, will you also raise taxes to compensate? What will we have to give up due to loss of funding?

My husband and I have lived in Howard County for 15 years; first in Columbia, now in Ellicott City. Our children attend Howard County Public Schools, so we know all of our neighbors from the bus stop. Every morning and every afternoon, we spend a few minutes together: families from Korea, Mexico, Nigeria, Pakistan, and Russia, biracial families, and caucasian families. Our kids all play together, because that is what kids do.

The house rules are universal, regardless of the specific culture of the host family: the kids all remove their muddy shoes at the door, say please and thank you, and look out for the littler ones. The menu at our gatherings is usually pizza-centric (because it's both peanut-free and halal) but kim chi, tamales, Christmas cookies, and roasted goat make regular appearances. My two blondhaired, blue-eyed children have flourished in this totally disorganized and joyful daily cultural exchange.

This is what makes Howard County so special— my children have learned that anyone is a potential friend. In our multicultural, multilingual neighborhood, we have chosen to build a community. We are able to celebrate each individual's cultural and personal experiences, AND marvel at the many ways in which we are similar.

Declaring Howard County "Sanctuary" is completely in keeping with the ideals of Jim Rouse, and the vision that built the city of Columbia. Using local resources to enforce an impossible federal mandate will only teach our children suspicion, nativism, and the kind of fervent Americana that proves dangerous after a few beers. Except for the few citizens who are 100% Native American/Indigenous/First Peoples, we are all immigrants here.

For all of these reasons, I am in favor of CB9. It is time to stand up and support our neighbors and friends, to believe that we are all here for the same reason—to raise our children the best we can.

• January 2017 — A Mexican illegally in the United States;, Leonard Pennelas-Escobar, was shot dead in Arizona as he assaulted a police officer by banging his head against cement after Pennelas shot and wounded the officer who had stopped to render assistance after Pennelas driving at a high speed had rolled the car killing the woman passenger.
