

Good Morning Executive Kittlelman,

To my letter I would add, it is deeply distressing to me to see the kind of hatred and xenophobia this bill brought out in our community, particularly the very district which I have called home for a quarter century. Knowing that my neighbors are so afraid and disdainful of the very individuals that make this a great country through knuckle-bloodying work, and that they forget that their own forebrears did the same, is saddening. However, I am more motivated than ever to ensure that all Americans understand who we really are as a nation- our identity is strengthened by the openness of our arms. I don't need to list for you the immigrants, often undocumented at first, often refugees themselves, who have placed America at the pinnacle of achievement in science, art, and governance. 

I write today to tell you why I support Howard County Council bill 9, also referred to as CB9. This is a bill that establishes Howard County as a sanctuary county, simply stating that law enforcement officials will not ask for citizenship or immigration information unless it is legally appropriate. It commits to preventing discrimination by Howard County employees based on citizenship or immigration status. This allows members of the community who need help to access police protection without fear. It creates opportunity for all our neighbors to acquire work without prejudice. It confirms that Howard County employees will always cooperate with federal, state, and local laws.

Like most Americans, I am the child of immigrants. My parents came here when America was desperately in need of doctors. In the 1970's, we didn't have enough physicians to care for sick Americans. Many doctors did not want to work in poor or rural areas. So scientists from around the world were invited to help. These highly trained professionals came here to help our forebears. And they came to love this country. My parents proudly carry an American passport. They always wear their American flag when they







and education, and like them, I have. They taught me to respect our American laws and appreciate our American life. I kept a copy of the constitution in my pocket for decades. We love America.

We love that anyone can come here and educate themselves, work hard, and make a life without the chains of prejudice, poverty, illness, lawlessness, military coups, or religious oppression. These are all a mundane part of everyday life where my parents were raised. They came here and we became free. And we love America.

I have family and friends and patients who have been "undocumented." It doesn't mean you forced your way in or you scaled a border wall with a pocket full of pemmican. Sometimes it means you did everything you were supposed to, and then waited for the authorities to complete their tasks. It means that while you complete your training, you depend on fortune and friends to protect and believe in you. In this country, though, administrators in immigration and embassies produce results without bribes or coercion. Because simple acts like getting a new passport or driver's license happen without a dirty handshake, we love America.

I have spent summers in a country where you are woken by government workers at 3 am to prepare to fast. Here in Maryland, nobody has ever knocked on my door to impose their religion on me. In fact, I'm welcomed by curious friends whenever religion is a topic. I belong to the American Ethical Union as a practicing Secular Humanist, I have friends and family of every religion, and we are not afraid of each other. We can think and love and practice our religions freely here, and that is why we love America.

We are called on now to stand for these American values: freedom of religion, freedom to work, and the opportunity to be treated as equals, and pursue our happiness. This requires respect for the law, and our legal tradition protects our neighbors in need with due process and equal protection under the law. We must protect our constitution, our American way of life, and our laws. These very laws protect all of us. They protect our freedoms, and thus our very way of life. This is why CB9 is sensible, important, and necessary.

I urge all Howard County residents and all our council members to support our American way of life by supporting CB9.

To my councilman Greg Fox, councilpersons Weinstein, Ball, Terrasa and Sigaty, and county executive Kittleman,

I am writing today in support of sanctuary county status for Howard County. As with any important decision I make, I have reviewed pros and cons of this bill, studied other cities and counties with this status, have read what you, on the board, HoCo constituents, and law enforcement around the country have said about sanctuary status, and have come to the conclusion that passing this bill will strengthen the connection that EVERYONE living in this county will have towards their government at ALL levels and to their country, the United States of America -- far outweighing any negative impact that people fear.

I, myself, am an immigrant. I have been in this country since I was a little girl. I was lucky. My family, back in Peru, had money. My mother had a degree in Accounting and had studied at UT-Austin and within the University of California school system. I came to this country speaking very little English, but through my outstanding elementary school in Fairfax County, VA's ESL program, I quickly learned the language. Through support of my family already in the country and new friends I made, and through the welcoming openness of my community, I quickly assimilated and became an American, a gringa, as they call me whenever I go back to visit Peru. Growing up in Fairfax County, in some of the wealthiest towns in this nation (McLean and Great Falls), I was often immersed in the cultures of different immigrants from all parts of the world. A drive down Route 7 was like a visit to every corner of the earth. And within those outer communities in the county, lived people that were documented, but also that were not. Their struggle was different than mine. They didn't have the resources I did, the connections I had. They had language barriers, pennies in their bank accounts (if they had bank accounts at all), people needing them back at home. To them, being American meant not only embracing a country as their own, but also first being able to survive. They needed a CHANCE. They were not criminals, they were not here to live off the state. They were here for the exact same reason my mom and I came - to have a better life. To be American. But, as you may know, to be a new American is hard. There are a lot of forms, a lot of documentation, a lot of money is needed – resources that many people just don't have. So, what happens? Well, they become undocumented, "illegal." Are they criminals? No. Are they cancers to our community? No. Are they different from YOU or ME? NO! The vast majority of these undocumented individuals want to be legitimately in this country, and we, as a county deep-rooted in "civility" need to be there for them. The focus of our county's resources should not be on helping to eliminate otherwise law-abiding citizens. We should welcome them and provide them care and assistance. We should HELP them become American, not make it harder for them. Let our county resources work for good. Don't bog them down with demands from the federal government. Let's focus on our people, ALL our people, and do what we can to make their time in our county filled with security and openness. Let's tell them that in Howard County we are here to help you. You are safe. You are wanted. You are HoCo too.

So-called sanctuary jurisdictions are one focus of that debate. The analyses in this report provide new insights about how sanctuary counties perform across a range of social and economic indicators when compared to nonsanctuary counties.

The data are clear: <u>Crime is statistically significantly lower in sanctuary counties</u> compared to nonsanctuary counties. Moreover, economies are stronger in sanctuary counties—

First of all, thank you for all that you are doing to make Howard County a vibrant, safe, attractive place to live, work and raise a family.

Second, I would like to ask you to vote FOR CB-9 to declare Howard County a Sanctuary County. My argument is outlined below, in the form of responses to the statements made by Executive Kimmelman explaining why he plans to veto the bill.

[Kimmelman] Council Bill 9 (CB-9) is a hollow political statement

"Hollow" implies a space that can be filled. A glass is hollow; it is its very hollowness that makes it useful. CB-9 is a clear declaration of *values*, made as a political statement. To frightened immigrants, a bill filled with a clear declaration that local law enforcement officers will not make themselves instruments of potential deportation has great power.

[Kimmelman] False Sense of Security...The Howard County Police Department...has never been engaged in the enforcement of immigration laws. This bill's own language states it will not supersede any federal or state law, or any existing agreement between the County and any other federal, state or local government.

Yes HCPD has never been engaged in enforcing immigration laws, but now we have a President who has expressed his intention to bring back ICE's problematic "Secure Communities" program and strengthen the Delegation of Immigration Authority Section 287(g) Immigration and Nationality Act. These programs have created a real sense of insecurity and been highly problematic: see

http://altopolimigra.com/documents/FINAL-Shadow-Report-regular-print.pdf and https://pitchengine.com/pitches/a4ef098a-9536-4608-8799-fba6ea669c2a. A formal declaration of Sanctuary status is a real and valuable step to increase the sense of security in our immigrant population (both documented and undocumented), which will allow them to participate more fully in the social fabric of the county, which benefits everyone.

[Kimmelman] Compromise Public Safety Efforts. Our police department has made tremendous progress working with ICE..A serious concern is that passage of CB-9 could compromise the County's ability to keep our community safe.

On the contrary, the "Secure Communities" program and 287g efforts have been shown to *decrease* trust of law enforcement by immigrant communities, the very trust on which law enforcement agencies depend in

×



this bill will *enhance* public safety, not compromise it. And if, as Kimmelman says, the bill's own language states it will not supersede any federal or state law, or any existing agreement between the County and any other federal, state or local government, how could its passage compromise the County's ability to keep our community safe?

[Kimmelman] Loss of Federal funds. CB-9 will add language to the Howard County Code that could put us at risk of losing some critical federal funding. I am not willing to jeopardize existing programs and services which benefit all Howard County residents to adopt a label that would not change any of the policies and practices that we already have in place.

Here we come to the political nature of the bill. One of the responsibilities of political leaders is to LEAD, which includes making statements of our values and priorities. Do we boldly declare our commitment to minimizing the atmosphere of fear while so many of our county's residents are feeling more fearful every day under the current administration in Washington, or do we join the fear by remaining silent because an impulsive, authoritarian President might try to withhold funds from us? This Presidency is a national crisis, and anything that we do to empower the current President because of fear, we do at our own peril. You can't put a dollar price on dignity, or on standing up for what is right. No, the bill might not change any current policies and procedures, but there is real fear that the "Secure Communities" and 287g programs could sweep the country if we don't take a stand against them, early and firmly. Passage of this bill will make people feel a little less fearful that that will happen here, which will make Howard County stronger and safer for us all.

For these reasons, I ask you to vote YES on CB-9. Thank you very much for your time and consideration, and for all of the good work that you do.

The signatories of this petition request that you support Council Bill 9 to make Howard County a Sanctuary County and a safe community for all of our residents.

The signatories of this petition also request that you consider additional measures to protect the religious affiliation of residents in this community.

President- Elect Trump's statements calling for the creation of a Muslim registry and the wholesale deportation of undocumented immigrants deeply worry many people in Howard County and throughout our nation. As you know, Howard County has a very diverse population -- racially, culturally, economically, and in many other ways – and this diversity is greatly valued by many residents. The signatories of this petition fervently support and hope to continue the caring, diverse community that has proven to be a significant asset to our County's growth and civility.

In the past, Howard County has worked to end discrimination and create a safe community for people of all backgrounds. Other Maryland counties, including Prince George's and Montgomery Counties, have already taken action to protect their residents by becoming Sanctuary Counties. We want Howard County to follow this lead and support the security of all of our residents by also becoming a Sanctuary County through County Bill 9.

County Bill 9 is "AN ACT providing that certain individuals shall take, or refrain from taking, specified actions with respect to the immigration status of specified individuals; prohibiting certain discrimination based on citizenship status; requiring that certain information related to citizenship status be kept confidential; providing a procedure whenever specified provisions may be preempted by other law; requiring specified officials to take actions under certain circumstances; and generally relating to human rights in Howard County." In addition to County Bill 9, signatories of this petition also feel that Howard County cannot be considered a Sanctuary County unless religious affiliation of residents are also protected. Therefore, we use this to bring the following claims to the attention of the County Council and County Executive in the hope that they will take immediate action to enact these as law:

Whereas the President-elect and his supporters have increased threats against

people of certain religions and citizenship status, and

Whereas this information is not needed to provide services to students or residents in Howard County,

The religious affiliation of individual persons shall be immediately deleted from any and all county databases;

The religious affiliation of any individual person shall not be collected in the future by the Howard County School System, Howard County Police Department and Sheriff's Office, any Howard County Department or Agency, any employee of Howard County government, or any entity contracting with Howard County government.

Furthermore, county funds will not be used to enforce, aid, or offset federal efforts to obtain demographic information related to the religious affiliation of any individual person.

Census data on religious affiliation may be taken only if the information is not linked to any individual person.




