Dear council members,

I am a longtime county resident. I would like to say that I have great sympathy for immigrants and the difficulties that many of them face and it has long irked me how many of them are taken advantage of by many businesses. Not too many years ago I worked for a short while for a company with a large labor work force composed almost all of legal immigrants who were paid a sub marginal wage because none of them could speak English well enough to get a better job. An interesting mix of people from many different countries from Africa, Asia and Latin America some of whom had worked there for 5 years and were entitled to some benefits. The company couldn't fill all its open positions with such low wages and wanted to expand by hiring 50 additional employees. A new management system solved the problem. All the existing labor force was laid off and a new one brought in at .50/hour less and no benefits. Illegal immigrants became their slave labor.

This sort of situation needs to come to an end! Unfortunately it won't until we somehow arrive at an immigration solution that benefits all workers, both native and foreign born. To do that we need compromise and adding to the divisiveness that already exists in this country will not help. Passing a bill written in such a way as to criticize the President will only serve to antagonize him at a time that we need to talk to him instead.

Therefore I am emphatically against the passage of this bill CB9-2017 for the following reasons:

- 1) As there seems to be no evidence that any of the Counties agencies or employees there of are interested in the citizenship of those they serve there is no need for this law.
- 2) The language of this law as is written in its unamended form is clearly divisive in nature and I believe unfortunately so intended.
- 3) The passage of this bill could put Howard County at risk of losing Federal funds.

Personally, I think that maybe we all need to stand back a bit, take a deep breath and say a prayer that Divine Providence will help guide our President in the right direction. We might get surprised.

I believe it sets an extremely dangerous precedent to arbitrarily choose if and when to assist our federal agencies in performing their legal duties. Will county employees also be forbidden to cooperate in reporting suspected terrorist activities? Tax-evasion? Counterfeiting? Amendment 3, Section 12.2101(B)(3) does nothing to improve this aspect of the bill. By definition, any foreign-born undocumented illegal has broken the laws of this country and is therefore a criminal so the requirement that the federal agency demonstrate probable cause exists that the individual is engaged in criminal behavior is unnecessary.

I urge you to vote yes on CB9-2017 for the following reasons:

I understand and believe that the substantive provisions of the Bill set out the current practices of the County police department, and, to a large extent, the Bill purportedly codifies those practices. This has led to the criticism that the bill is unnecessary because it seeks to fix a “non-existent” problem. In addition, the potential veto of the Bill has been couched, in part, in terms of fiscal responsibility —*i.e.*, to guard against defunding reprisals from the federal government. Finally, I believe some opposition is also based on the misguided notion that the Bill provides an immutable safe harbor for all immigrants, akin to the ancient “sanctuary” practices of the church, leading to fears that criminals will be unconditionally sheltered.

Perception over substance appears to rule the day. That is unsurprising, given the:

- complex nature of federal, state, and local jurisdiction and authority,
- multitude of potential factual scenarios,
- important constitutional issues implicated in unlawful detention, and
- less than clear news coverage of these issues.

However, the events of the last two weeks have overtaken the finer points of this discussion. No longer is it enough for me that the County has the finest and most professional police force in the State. Nor is enough that I respect the ability of the Chief of Police to understand and balance the nuances of these complex situations.

Uncodified, the laudable policies and restraint of our police force can disappear remarkably quickly if the Executive, like the mayor of at least one county in Florida, decides to bend to the will of the President.

The fact that the Executive has not, to my knowledge, denounced Mr. Trump's divisive rhetoric, coupled with the Executive's threatened veto for fiscal reasons—even before the President issued his threat of funding reprisals—is not reassuring.

Moreover, even when a "wait and see" approach might be appropriate in some circumstances, I believe it is wholly inappropriate when individual liberty interests are at stake.

The sad fact is that a bill that might have seemed politically opportunistic and unnecessary when it was introduced is now suddenly prescient and necessary. There may be other opportunities in the near and distant future when we need to take a public and unpopular stand to resist the assault on the founding principles of our country. But I am persuaded that neither the threat of fiscal retaliation nor political unpopularity sufficiently outweighs the overarching purposes and effect of CB 9.

I agree with Ms. Sigaty when she said we needed to find balance not only to treat undocumented people (non-criminals) with respect, but also not to jeopardize safety for innocent people. However, I am afraid that enacting CB9 is not the answer to this because LAW draws clear lines, but the issue we're facing is a grey area. There are no clear lines to cut. I think the judgement on how to handle undocumented immigrants should be left to the professionals (our police officers) on a case-by-case basis. Our police officers have had tremendous amount of training on how to identify suspects. They are the only professionals who know the best on how to provide community safety, not CASA or FIRN, and definitely not any immigration lawyers.

Although I admire some council members' intention to improve quality of life for the undocumented immigrants, but it should not be at the cost of any individual's life.

We have heard a lot about MS13. MS13 originated from refugees from El Salvador and continue to prey on the young generations of this undocumented group. It is not surprising to me when I found out that the currency of El Salvador has become US dollars. The reason is because that one of the main revenue of this country is to receive money sent back by the illegal immigrants living in the U.S. Here are a few facts. Illegal immigrants residing in the U.S. send \$50 billion in remittances to their home countries each year, according to the Bureau of Economic Analysis. The World Bank estimates that number is even higher, closer to \$120B.

because it is earning their economy billions of dollars! And Americans are the ones forced to pick up the \$113 billion tab for taking care of the country's 12 million illegal immigrants.

It is disturbing to me that Dr. Ball and Ms. Terrasa had invited so many individuals to the work session that have clear conflict of interests on this matter. Let's not forget that organizations such as CASA, FIRN and some of the immigration lawyers (such as Mr. Green and a few others) are also beneficiaries from this chain of business. And if Dr. Ball and Ms. Terrasa had received sponsorship from CASA or FIRN on their past election campaign, should I doubt their true motive on this CB9 bill?

I also wanted to share with you on a piece of news below regarding sanctuary cities. In the article, it quoted a poll that shows 74% Californians want sanctuary cities ended, 65% Hispanics, 70% of Indies, 73% Dems and 82% GOP.
