**Testimony for the Howard County Council
January 17, 2017**

Council Bill 9-2017 – Sanctuary – Immigration and Citizenship

SUPPORT

The ACLU of Maryland supports Council Bill 9-2017, which prevents certain Howard County employees from enforcing federal immigration law, prohibits discrimination based on national origin, and works to protect the privacy of the County's residents.

Howard County has protected its immigrant communities by rejecting the use of Immigration and Customs Enforcement (ICE) detainers to prolong the detention of detainees beyond their release date. However, a policy of rejecting ICE detainers could benefit from enforceable law that affirms these protections, and recommitts Howard County to protecting all of its residents, not just its citizen residents.

Passage of this bill will also limit the county's liability in legal disputes and lawsuit settlements that involve violations of constitutional rights, by disentangling local law enforcement from enforcing federal immigration law. President Trump's Executive Orders target noncitizens in such an expansive way that the Trump Administration will necessarily rely on local law enforcement to instill fear in immigrant communities and participate in unconstitutional policies that courts have already ruled as rampant Fourth Amendment violations.¹ This will expose the county to legal challenges alleging violations of constitutional protections.

Although President Trump has threatened to defund "sanctuary" jurisdictions, compliance with that order is unconstitutional and is merely a scare tactic that is used to bully the country into enforcing his racist and xenophobic immigration policy. Any attempts to defund cities and counties that welcome noncitizens will incur a full-fledged legal fight from immigrants' rights organizations, including the ACLU.

Council Bill 9-2017 also improves public safety and helps law enforcement officers enforce criminal law. Legislation that disentangles local jurisdictions from unlawfully

We all know that a significant number of these are children brought here by their families.

My ideal for our immigrant neighbors is to come through legal channels but I know that the wait time on our overloaded system can take an average of 7 years. The reality is that individuals and families can face grave hardships waiting for their turn to come, so they make the hard choice we will never be forced to experience - breaking the rules and enter without legal documentation.

It's not just our immigration system that's broken- our world is broken. Many current immigrants and refugees would choose to stay in their homelands if they were able to be safe and have political and economic stability.

Because the recent election has given rise to an aggressive strain of anti-immigrant violence, I believe that declaring Howard a "sanctuary county" is the best way to endure safety for our immigrant residents and a healthy, trusting relationship with the police force. As a local pastor who has worked with minority groups, I'm aware of how hard our police force has worked to build trust with vulnerable populations. The county will be safer if mechanisms are in place to keep and build that trust.

Please be courageous and keep your most vulnerable citizens in mind.

If you can't vote for CB9, find another way to ensure safety and support for our immigrant neighbors. Too often we tell

you to vote "our way or the highway." You can help us see beyond either/or to a third way. It will take extra work and courage because no one will be fully satisfied. But your job is to help us discover our best selves in citizenship, not to sink to the lowest acceptable standard. As Howard County has evolved over decades to welcome and create a home for many different kinds of people, it can continue to evolve in its practice of finding a balance of justice and compassion for all citizens.
