I emailed over a week ago and I must say, I only recieved a response from one of you. I have made this known in my circles and on social media to the people that I know that live in this great county that with such a serious matter, four of you can not take the time (or even have one of your many assistants) respond to my previous email. So, with that said, Dear County Council Members Sigaty, Weinstein, Ball, Terrasa, Fox:

I live in Ellicott City and I am a registered independent. I know most want to focus on "safety" and there are good arguments on both sides but I am pretty sure you have heard your fair share so I will not go into that subject. However, I sit back and read both sides and I see this bill doing more harm than good. I have seen first hand (working in Western Howard County and in EC) illegal immigrants take jobs away from citizens, teenagers and legal immigrants because employers can pay them under the table and at a lower rate than what I or others were making. I have several friends in the police force and in the fire department and they tell me there are practices already in place, and are followed, to not discriminate against illegal immigrants. As stated earlier, when looking objectively, I see this bill doing more harm than good. Which leads me to think this is most likely political strategy. This bill will likely make things worse. It will send more illegal immigrants our way that will take jobs away from people doing things the RIGHT way. It will create a message of safe harbor for criminals to move into our communities (whether they continue to act as criminals is up for discussion) and it will most likely decrease federal funding (which will lead to cutting programs or raising taxes which are already substantial). Creating "Sanctuary Counties, Cities, etc." continues, whether inteded or not, to show people that its ok if you come into our country illegally. As long as you can make it to one of these areas you are ok. That is not the message we should be sending. This law will (already has) create a divide and raise tension, two things that this bill is "suppose" to fix. A lot of the tension will come from people here legally and I completely side with immigrants that are here legally and trying to do things the right way. Some say that not passing this bill will "tear families apart" which is highly unlikely. But, lets say by some odd chance it does. They made the decision themselves and they decided to come here illegally knowing the chances. A bill like this will continue to send the signal that its ok to come to this country illegally. We need to take care of the people legally here and that are trying to come here legally, not the other way around. Please be aware that the February edition of the River Hill Newsletter ("The Villager") contained some incomplete information about CB-9 that may have resulted in erroneous e-mails being sent to the County Council. The River Hill Representative to the Columbia Council has a regular column in the Villager, to inform residents about the actions of the Columbia Council and other local governing bodies. CB-9 was mentioned in this context. Here is the full text from the Villager (one paragraph):

The County Council is debating a Sanctuary Howard Bill (CB9-2017) to declare "sanctuary" status in Howard County. The purpose is to shield undocumented immigrants from deportation. The bill was proposed by council members Dr. Calvin Ball (District 3) and Ms. Jen Terrasa (District 2). You can email councilmail@howardcountymd.gov to reach all council members to express your support or opposition to this bill. The bill is scheduled for a vote on Feb. 6, 2017.

The "purpose" stated in the above paragraph is incorrect, and possibly even inflammatory. (I have no evidence that this was intentional - I assume it was not.) Since many River Hill residents may write to you based solely on the above statement, I wanted to bring it to your attention.
