Unfortunately we have seen a rise in both in recent times, as evidenced by a political culture of false information being passed as fact in order to use fear to garner power. We are seeing this from detractors of CB9. With this context, the reasons I support CB9 are as follows:

• Across the US there are nearly 400 sanctuary cities and municipalities that offer a variety of policies and protections for residents. While there is no legal definition that spans all of these locals, essentially the term refers to a locality that has chosen not to use its local resources to enforce federal immigration law. If the CB9 legislation passes in Howard County, it would legally direct county employees and police not to inquire about a resident's immigration status unless required by law (for example, checking legal authorization to work during the hiring process). The benefits of making what has been a policy position into law are that it prevents discrimination; ensures county resources are prioritized for local law enforcement efforts; and protects the county from exposure to potential liability. Importantly, it also reflects our values as a welcoming and diverse community and promotes trust between our community and government/police.

• This bill would not interfere with our police's ability to investigate crimes and enforce local and state law. Additionally, it does not interfere with ICE's ability to carry out deportation. Our local police would still be required to comply with any federal warrants for arrest. Separating local policing from immigration enforcement promotes public safety and promotes family unity and human dignity.

• Congress appropriates and authorizes the spending of federal funds, not the President. Nothing in this bill violates federal law, so Howard County should not be under any threat of losing federal funds. There is not transparency around any federal funding that Howard County receives that would be threatened if additional steps would be taken to further bolster the County as an inclusive, supportive, compassionate community.

• I have the privilege of being a Caucasian, able-bodied, straight, educated, upper middle class, U.S. citizen, of a non-threatened faith. I have MANY friends and colleagues who do not fit one or more of these categories. As I wrote in my November 20th Op Ed in the Baltimore Sun regarding Governor Hogan's lack of leadership around the rise of hate speech and actions, "There are children in Maryland who are now living in fear due to circumstances around which they have no control — the color of their skin, their accent, their religion, their disability, and so on. Friends of mine have been called the N-word for the first time in the diverse and inclusive community of Columbia. Other friends are afraid to wear any public indication of their religion due to harassment."

Now more than ever we need thoughtful, courageous leadership to protect our communities where state and federal leaders will not. I am appreciative that Dr. Ball and Ms. Terrasa put this bill forward and hopeful that both Ms. Sigaty and Mr. Weinstein will support it, making County Executive Kittleman's premature veto determination moot.

The sturm and drang surrounding Council Bill 9 have passed without an official declaration by the Howard County Government of its commitment to the values its officers so often proclaim. Undeniably, the Bill's explicit partisanship, its Constitutional implications, and its problematic implementation generated legitimate concerns, but the claims pervading the debate only obfuscated the issue of the County's consideration of the immigrants living within its jurisdiction.

Contrary to the assertions of some, Howard County has no law governing the treatment of immigrants. To be sure, only the U.S. Government has the power to regulate immigration, and the Supremacy Clause of the U.S. Constitution makes clear that no local government can lawfully displace this power. Equally as clear, U.S. immigration law empowers local governments to provide their services to immigrants. Since only Federal officers have the discretion in their enforcement of Federal immigration standards, Howard County is fully charged with the power to extend its services to those whose compliance with Federal immigration rules is dubious.

The choice for Howard County is not whether to block Federal officers from executing U.S. law. Howard County must decide whether to make public and official its protection of those who, at present, may fear deportation. Treating immigrants the same as citizens represents a laudatory extension of private morality and a rational approach to public policy. More than twenty years of experience have taught local police departments the danger generated by the fear of deportation. Where witnesses to crimes believe their cooperation will result not in justice for the criminal but in the deportation of their families, violent criminals find safe havens from which to launch their attacks. Protecting immigrants provides that rare legislative moment, the concurrence of the highest public ideals and the safest community outcomes.

Beyond the establishment of sound relations with vulnerable residents, the inclusion of immigrants under the umbrella of equality of treatment demonstrates the County's commitment to its proclaimed values. Moreover, the ease of implementation negates any lengthy legislative

effort. Title 12 of the Howard County Code defines the kinds of discrimination prohibited in the County. While the effect on private citizens in employment and financing practices may preclude changes to Sections 12.208 and 12.211, protection of immigrants becomes a part of County law simply inserting the phrase "Immigration or Citizenship Status" after "National origin" into Sections 12.200, 12.207, 12.209, and 12.210.

Through this enactment, Howard County will reaffirm its status as a jurisdiction opposed to discrimination. Whether this action makes Howard County a "sanctuary" is purely a function of the ever-changing use of the word. Historically, "sanctuary" was the term reserved for houses of worship that provided refuge to those threatened by the immoral conduct of the local government. Many in Howard County still cherish those European churches, and private individuals, for the sanctuary they provided to Jews fleeing the German government.

The contemporary use of "sanctuary" does not precisely match this historic meaning. First, those fleeing the brutality of their homeland have come to the United States seeking refuge, and, even now, the U.S. Government does grant such refuge, called asylum, to those able to prove this status. Second, "sanctuary", today, refers to granting refuge to those who fled to the United States. Third, for seventy years, and more, the government of the United States has struggled with the regulating of immigrants and, not once has the U.S. Government copied the practices of the German government of the Nazi Era or similarly brutal regimes.

The proposed changes to the Howard County Code are a public declaration that the County opposes the mistreatment of immigrants. The County has no authority to enforce U.S. immigration laws; consequently, the County has no reason to investigate the immigration status of anyone. Good government does not require a law describing every power either not available or not asserted. In the exercise of their First Amendment rights, some may call Howard County a "sanctuary" for its proposed extension of its non-discrimination laws. The use of the term does not impact Howard County's obligation to its residents nor does it alleviate Howard County of its responsibility to declare its values.

History proves that America's better angels, not official silence, must confront the rising tide of animus directed against the strangers living in our midst. Our Nation and our community are at a crossroads, and Howard County must summons the courage to reject the disparate treatment of immigrants based on their Federal immigration status. Such action does not offend the principles of our Constitution; it preserves them.

(a) In furtherance of this policy, the Secretary shall immediately take appropriate action to engage with the Governors of the States, as well as local officials, for the purpose of preparing to enter into agreements under section 287(g) of the INA (8 U.S.C. 1357(g)).

(b) To the extent permitted by law, and with the consent of State orlocal officials, as appropriate, the Secretary shall take appropriate action, through agreements under section 287(g) of the INA, or otherwise, to authorize State and local law enforcement officials, as the Secretary determines are qualified and appropriate, to perform the functions of immigration officers in relation to the investigation, apprehension, or detention of aliens in the United States under the direction and the supervision of the Secretary. Such authorization shall be in addition to, rather than in place of, Federal performance of these duties.

In response to inquiries that I have received and in order to avoid misrepresentation or misunderstanding of my opinion, I would like to share with you my position on sanctuary status legislation. Please feel free to share the following message with others in the Asian American community.

Over the last few weeks, as a "sanctuary county" bill is hotly debated locally (Howard County-CB9) and as I see thousands protest against an illegal immigration ban nationally, I am disturbed by the lack of support from the Asian American community for other populations of color or national decent. As the only Asian American elected official in Howard County and one of only two Chinese Americans serving in the Maryland General Assembly, I feel obliged to take a longer view and broader perspective on the issue of immigration and "sanctuary" status. And as a leader within the Asian American community, I feel compelled to speak out in support of sanctuary protections in an instance where so few have.

For me, this topic is personal. Some 50 years ago, my late grandfather stepped off a boat onto American soil after a long, arduous journey. Like so many undocumented, he worked tirelessly, barely earning a livable wage while enduring long, hard hours at manual labor. Were it not for the opportunities he was afforded to achieve the American Dream, I would not be here representing you in the Maryland General Assembly.

And so my message to the Asian American community is this: if you are fighting these sanctuary measures, you are not only denying future generations of Asian Americans the chances that you've had to reach the American Dream, but you are doing so at your own peril. This opposition is short-sighted, and this is why:

Right now, sitting in the luxury of our own homes, it's easy to frame this in the context of "us" (the Asian American community) and "them" (predominantly the Latino community, but others as well). This is easy to do because most of the undocumented people that we see locally in Maryland are Latinos.

Undoubtedly, it can be difficult for many Asian Americans here in Maryland to relate to "them." The vast majority of Asian Americans live in Montgomery County (highest median family income in the state) and Howard County (second highest median household income of any county in the country). As a result, most Asian Americans in Maryland are insulated. In fact, we are the exception in the U.S.—there are millions of Asian Americans throughout the country who are not living in the privileged and high wealth communities that we are.

But the truth is: while "they" are not "us" right now, we could soon be "them." Thus, the outpouring of animosity and anger that we're seeing now (even among some Asian Americans) could continue to turn towards us.

Don't believe me? Here's the evidence:

In this environment of heightened racial tensions spawned by reckless federal actions, local racial profiling of Asian Americans has already started. Just a week ago, the Baltimore Sun reported that an Indian American citizen who lived in her community for decades was stopped and asked about her immigration status while walking in her neighborhood by local police in Bel Air, Harford County, who were responding to a report of a "suspicious person." As this incident made clear, deputizing local police as immigration officials will only exacerbate racial profiling of Asian Americans.

While attention has been focused on the Latino community as the source of the nation's "immigration problem," that attention will soon turn towards the Asian American community making incidents like that in Bel Air all the more common. In fact, immigration from Asian nations has now surpassed immigration from Latin

America. While the sheer number of Latinos still surpasses that of Asian Americans, our rapidly rising rate of immigration means that, in our lifetimes, we will likely see the Asian American population surpass that of the Latino population in actual

number. Once that happens, the hostility towards "them" will be aimed at "us," and our children's children will experience the immigrant wrath that we are seeing today.

Much of the current ill will is directed at the undocumented. The fact that the current undocumented population is largely Latino masks the data showing that there are 1.5 million undocumented Asian Americans living in the U.S. The actual figures should be a wakeup call to our community: There has been a 43% increase in undocumented Chinese immigrants, 94% increase in Indian immigrants, and 31% increase in undocumented Koreans in just the period from 2000 to 2011. Today, with nearly 60% of Asian Americans being foreign-born (the highest percentage of any racial group), the shocking reality is that Chinese Americans, Korean Americans, and Indian Americans are the fastest-growing groups of undocumented immigrants.

Again, Asian Americans in Maryland are insulated from this reality because we live in high income, highly educated communities where few undocumented can afford to live. But just across the border in Virginia, there are 60,000 undocumented Asian Americans, which comprises nearly a quarter (24%) of all of the undocumented in the state. And the numbers are similar in other states with large populations of Asian Americans: In New York, 195,000 Asian Americans are undocumented representing 22% of the undocumented in the state. In Washington, it's 39,000 (18% of the undocumented in the state). In New Jersey, it's 102,000 (19%), and in California, it's 412,000 (13%).

Over time, what we see and experience here in Maryland will change as immigration patterns shift and move, and I have no doubt that the number of undocumented Asian Americans in our state will rise. And when that day comes, the same opponents of sanctuary measures who are fighting "them" now, will be fighting "us" then.

That's why I believe foes of sanctuary measures are focusing narrowly and missing the longer-term picture. For now, these are self-serving measures of "keeping them out," but they will be self-defeating later when the bullseye inevitably turns to us.

I do recognize that there are some Asian Americans supporting sanctuary protections, and I appreciate their encouragement. But the most vocal Asian American voices on this topic locally have been the opposition.

I've heard these critics say, "well, I'm not being helped [by sanctuary protections]," and while true today, that's self-serving. To be concerned about only oneself at the expense of the broader community and our future generations—that's the definition of being shortsighted and selfish. Until our community recognizes that we need to band together with other immigrant populations and that there are larger issues for our community outside of our own self-interests that we need to work together on, we won't have the unified voice and thus respect that our community deserves. And that's self-defeating.

I have had Latinos come to my office in Annapolis asking me "what's wrong with the Asian American community? Why don't they support this [sanctuary status]? Don't they see that this could be them?" And I'm embarrassed to have to admit to them that "no, they [the Asian American opponents] have let themselves be overcome by fear and resentment"—with falsehoods that crime will go up (untrue), that they don't pay taxes (untrue), that they use more government resources (untrue), that they contribute nothing to the community (untrue), that sanctuary measures could jeopardize federal funding (unconstitutional), that sanctuary measures will only help them and won't ever benefit the Asian American community (self-centered and shortsighted), and the notion that "I arrived here the right way, and they did not" (remember the 1.5 million and rapidly growing undocumented Asian

American population?). For all of these reasons, I'm deeply disappointed in those vocal Asian American critics of sanctuary status.

And that's why I stand with my brothers and sisters—African Americans, Latinos, other Asian Americans, and many communities of color—today to be on the right side of history. I am honored to be part of a statement in support of sanctuary status with fellow legislators from Howard County, proud to be a co-sponsor of several sanctuary bills to be introduced in the Maryland General Assembly, and pleased that the Asian American Legislative Caucus has joined with the Black and Latino Caucuses in Annapolis in support of these measures.

After all, do you want them to come to your support when it's you being targeted, your children, or your children's children? Because that day will come, and it is my hope that future generations of Asian Americans will be protected by the measures that we adopt today. Sincerely,

BOR Staff Column: Sanctuary to Slaughter February 23, 2017 Karina Pulec will not see her 29th birthday. She was a lawyer in Denver, a devout Catholic who spent her free time doing volunteer work. Karina, described by a colleague as a 'lovely and gifted young woman,' died a horrible death when she was run down and dragged by a driver who immediately fled the scene. You can surely predict the rest of the sordid story – the driver was a criminal illegal alien from Honduras who had been previously deported. There is no word on whether authorities notified Cruz' next-of-kin via fax. The real 'bad hombres' in this story aren't here illegally, nor are they Hispanic. When asked about the murder of Timothy Cruz, Denver Sheriff Patrick Firman hid under his desk, from where he issued a cowardly and mealy-mouthed statement: 'Detaining anyone without a criminal warrant is a violation of the Fourth Amendment.' Bull, Sheriff Firman! Valles was a gang member and there was an ICE detainer that you refused to honor. Sheriff, you described the killing as a 'tragedy.' No, it's an absolute and despicable outrage. Then there's Denver Mayor Michael Hancock, who says his police will not 'do the work of federal immigration authorities or violate the constitutional rights of any of our people.' What constitutional rights were being violated, Mr. Mayor, when you defied the feds? It may be a tired cliché, but Sheriff Firman and Mayor Hancock have blood on their hands. Equally bloody are the hands of all the left-wing loons who defend sanctuary cities and ignore the carnage. This noxious idea was begun, of course, in California, where local cops in

San Francisco and Los Angeles were forbidden from stopping suspects simply to inquire about their immigration status. That policy, not irrational by itself, soon morphed into total madness when local officials provided sanctuary to convicted felons.
