All swimming classes at all swimming levels are turning away people because there just isn't enough pool space to keep up with the demand. The children classes, in particular, have become very highly competitive across the county because the demand to get into the classes are so high...our children can no longer be kids who can swim for the love of swimming because there are so many other kids who are faster than them. The swim meets for the competitive swimmers are also a nightmare. I was at a swim meet just a few weeks ago where the meet lasted for over 7 hours each day over the weekend trying to get all the kids through their races...it was grossly overcrowded, hot, and uncomfortable to sit through...not to mention that most meets are located upwards of an hour away because we can't host any of the meets locally.

And yes, people do still get hurt due to overcrowding. Just last week a swimmer in my lane left practice early because they got kicked in the face/goggles due to crowding.

 - The speed of the swimmers vary drastically in each lane making it almost impossible to circle swim without impacting your or someone else's workout.

 - May 9, 2016 was the first day of Master's practices swimming outdoors for the season

- Injury prevention
 - Most injuries are minor, but occur more often when there are too many people in the pool
 - # Injuries due to impacts with other swimmers and the lane lines due to overcrowding can include:
 - Bruised fingers, hands, arms
 - Poked in the face or hit in the head
 - Damaged fingernails not superficial breaks
 - # Bruised fingernail beds
 - # Broken fingernails into the nail bed (painful & take weeks to heal)
 - Scratches across the legs, arms, back, and face
 - Twisted ankles trying to avoid other swimmers during flip turns
 - # More severe injuries can include: broken fingers/toes, concussions, torn ligaments, bruised bones, pulled muscles, etc

- More relaxed and enjoyable workout
 - Swimmers feel intimidated to be in a lane when they are slower than other swimmers in that lane
 - # Faster swimmers can't perform their best when slower swimmers hold them up
 - More pool space will allow for the power of stronger swimmers to dissipate making the water less choppy and easier for others to swim in
 - # A coach can try techniques to alleviate the impact of the crowd, however, this can break down and all the swimmers end up in confusion with a reduced workout
 - # Swimmers will come to the pool, swim and enjoy swimming rather than leave because it is too crowded.
 - # Swimmers will experience the full exertion of their work out becoming faster and healthier

- Competition swimmers and triathletes need a longer pool to practice in on a regular basis
 - # Columbia has a large group of adult members who compete in various open water swims, US Masters swim meets, triathlons, etc multiple of times throughout the year.
 - Columbia also has a large group of children aged 5-18 who swim and compete as well.
 - The first time and only times we swim in a 50 m pool shouldn't be during meets. Competitors need to be comfortable in the swim environment when they get there, not inhibited because it is bigger than any other pool they have ever seen before.
 - # Since there isn't an adequate competition pool in the area:
 - Local swimmers go to other pools in other counties (with their money) to train and compete.
 - # I sent my children to Fairland Aquatics Center in Prince Georges County.
 - # My husband has suggested that I move to Fairland as well.
 - Competitions can't be hosted in Columbia and the revenue from a competition can't be earned in the county.
 - People who would otherwise swim, don't.
 - A 50 meter pool inherently can help circumvent issues due to overcrowding

- Revenue and Advertising from competitions
 - # The 2016 Olympic Trials had nearly 200,000 spectators across 15 sold-out sessions
 - More than 36 million television viewers watched live primetime coverage from the eight nights of Trials on NBC
 - # The event generated more than \$74 million for the city of Omaha
 - # Smaller events host fewer people and therefore have less revenue for the city, but they <u>do</u> generate revenue for the pool and the surrounding restaurants, hotels and stores.



I am contacting you to voice strong opposition to CR66-2017 which would provide exemptions for certain entertainment taxes in Howard County. Specifically, I am concerned about the proposal to exempt select activities from the entertainment tax and reduce the tax imposed on other selected activities.

My first concern, when I hear of exemptions from tax, is to wonder: who will pay for this tax reduction? How will the budget compensate for the deficit represented by these uncollected funds? These funds will have to be collected from elsewhere, which means that effectively the proposal is to have these entertainment costs be absorbed by those taxpayers who do not benefit by the proposal. In this proposal, the activities to be subsidized: hot air ballooning, golf fees, concerts, and agritourism, can be outside of the budget of some family households. So the net effect of the tax exemption is to subsidize entertainment of the wealthy, while passing the costs of funding this subsidy on to those who do not benefit from it.

My second concern is regarding the trend in our local and federal government to move away from a free market economy towards corporatism, where government regulations are crafted to financially benefit specific interest groups. In a free market economy, the success and failure of an entertainment establishment would be dictated by the consumer assessment of the cost and benefits of the product or service. This bill would circumvent the free market by subsidizing activities such as agritourism, golf, indoor athletic fees, concerts, and hot air ballooning, artificially lowering their costs relative to other entertainment options. Thus this bill could be thought of as taxing other entertainment options in order to subsidize select activities, used and run by a small minority, rather than to advantage of the general public.

To pass this bill would be a misuse of government authority, and is unbefitting to a representative democracy.

Dear Chairman Weinstein and Honorable County Council Members,

Thank you for the opportunity to comment on the Proposed FY2018 Operating Budget. The Chesapeake Bay Foundation (CBF) and our over 20,000 members in Howard County are vitally interested in the ongoing restoration and protection of water quality in local rivers, streams, and the Chesapeake Bay. Water quality relies on many factors, such as public education and participation, conservation and restoration efforts, and smart land use planning. Most of these factors, and therefore clean water and healthy communities, depend at least in part on sufficient resources and funding. We appreciate the Council's ongoing support for clean water in Howard County, as evidenced through the County's stormwater program. To build upon and expand the County's stormwater pollution reduction efforts, CBF urges the Council to support the University of Maryland Extension's request to include the Howard County Watershed Stewards Academy in the County's FY2018 operating budget.

The Howard County Watershed Stewards Academy (WSA) has proven highly successful in educating the public, assessing community watersheds, and implementing stormwater pollution reduction projects, all of which benefit and complement the County's ongoing efforts in these areas. As you know, the County is currently undertaking stormwater remediation efforts pursuant to the County's federal Municipal Separate Storm Sewer System (MS4) permit as well as the County's Watershed Implementation Plan (WIP). However, as demonstrated through remediation plans, the County has a difficult time accessing private property. As private residences make up approximately 60 percent of the County's impervious surface, this is a major obstacle to meeting the County's pollution reduction obligations. That is why the Howard County WSA is such a great asset to the county, local communities, and clean water. Through the Extension, the WSA achieves and supplements several of the objectives of the county programs in a highly cost-effective manner that leverages resources and volunteers and can access private land the county has found inaccessible.

CBF members and employees have participated in WSA activities, such as the Master Watershed Steward program and various public forum and speaking events, and found that the WSA truly engages and inspires public action. The volunteer and community based model of WSA reaches citizens and removes common hurdles to project implementation in our communities.

For these reasons, CBF and our Howard County members strongly support the WSA program and urge the Council to approve the University of Maryland Extension's request for the FY2018 WSA program funding.

To the Honorable Howard County Council,

I am writing to urge you to support the University of Maryland Extension's request to include as a new program the **Howard County Watershed Stewards Academy** (HoCoWSA) into the County's FY 2018 operating budget. HoCoWSA provides valuable services to the Howard County community. The academy trains and educates local citizens in relevant stormwater and watershed issues using trained Master Watershed Stewards. These stewards assess neighborhoods and residential sites for stormwater management problems and potential solutions, while also guiding citizens as they seek to initiate residential-scale best management practices that will reduce the volume and pollution that leaves these sites as stormwater runoff.

HoCoWSA is able to access private property within Howard County – property that is outside of the County's authority/ownership and is thus inaccessible – and has collaborated with a number of county departments, nonprofits, schools, Boys/Girls Scout Troops, homeowner associations, and places of worship conducting education and outreach efforts and acting as an effective bridge between the County and its citizens. With the increase in rain events and their resulting impacts to individual properties, the demand for help from homeowners across the county continues to increase.

Prior to meeting the Howard County Watershed Stewards we had limited knowledge about stormwater runoff. Living in western Howard county we did not believe that it was something we needed to be concerned about. When talking with our neighbors about stormwater runoff, they all have similar beliefs that our runoff doesn't cause a problem. After being educated by the stewards at an outreach event we now realize that stormwater runoff affects all of us. Therefore, we believe it is critical that the Howard County Watershed Stewards program continue if we as a county are going to move forward in controlling stromwater runoff.

Again, I urge you to support the University of Maryland Extension's request to include as a new program the Howard County Watershed Stewards Academy (HoCoWSA) into the County's FY 2018 operating budget.
