Resolution No. 136 -2012

Introduced by: The Chairperson at the request of the County Executive

A RESOLUTION approving the 2011 Amendment to the Howard County Master Plan for Water and Sewerage, consisting of text, tables, and maps incorporating various revisions based on and including:

1. An analysis of the water and sewerage systems, including systems expansion to serve presently undeveloped areas within the Planned Service Area and augmentation of undersized existing facilities;
2. The progress of projects for future water supply and sewerage treatment needs in the county and outside of the county, including improvements to the Western Third Zone water supply and expansion of the Patapsco Wastewater Treatment Plant being built in coordination with Baltimore City and Baltimore County;
3. Review of service priorities for properties in the Planned Service Area; and
4. Changes in the anticipated alignment, location, and sizing of future facilities.

1 **WHEREAS**, Title 9, Subtitle 5 of the Environment Article of the Annotated Code of
2 Maryland requires each county governing body to adopt a Master Plan for Water and Sewerage
3 and to review the plan every 3 years; and

6 amendment to the Master Plan for Water and Sewerage by adoption of Council Resolution 77-
7 2008 on October 15, 2008, and the comprehensive amendment provides for the submission of
8 semiannual updates; and

10 **WHEREAS**, the Department of Public Works prepares semiannual updates to keep the
11 Master Plan current, the last update having been adopted by Council Resolution 135-2010,
12 effective January 3, 2011; and

14 **WHEREAS**, in accordance with the Master Plan and State law, the Department of Public
15 Works has prepared the attached 2011 Amendment to the Master Plan for Water and Sewerage;
