Councilmembers,

Thank you for giving our team an opportunity to provide an overview of the process as well as the details of the redevelopment plans for the Long Reach Village Center. We appreciate your engagement and your questions.

At the meeting on Monday, there was a question related to the process prior to the start of the 2015 community engagement sessions, particularly, with the timing of when the County settled on the two parcels. I've attached a copy of the purchase and sales agreement which was executed in September 2014. Should you have any legal questions related to this agreement or the two settlements, Office of Law would be the best to answer your questions as this agreement was executed by a prior administration.

There was also some discussion about the timing of a Council vote. As I noted in the my email below (please see yellow highlighted section), there is an extensive, multi-step process ahead for Orchard Development which is why a timely Council approval is necessary. Ideally, a July 3rd vote would give us the ability to keep some cushion in the timeline and begin the Major Village Center Redevelopment Process, which would kick-off with a community planning process. We do believe that should the Council need additional time to review the resolutions, a delay of the vote until July 26, 2017 will be manageable. Any delay beyond that would significantly impact the timeline and compromise the development team's interest in this project. The timeline that Amy Gowan referenced during Monday's presentation is available on the Relmagine Long Reach website and was also included with the original submission to you.

As I've noted in earlier emails, DPZ staff, members of the RFP committee and the development team are available to meet with you individually should you wish to schedule a time to discuss the proposed redevelopment at any point during the Council's review.

The legislation will be to approve the Urban Renewal Project as well as the disposition of the property. The substantive piece in the legislation is the reference to the proposal submitted by Orchard Development which is what the County Executive provided to the Council on April 26. The legislation is currently being drafted and I'll be happy to send it to you prior to the pre-file deadline for your review. We delayed the press release on Friday and will be happy to send you a draft this afternoon once it has been completed. I have spoken with the County Executive regarding your request and we are not going to delay filing the legislation. As we shared during our meeting with you on April 25 and in the transmittal on April 26, Council review of the legislation will be another step in the process for the public to review and provide input. We shared the same info and timeline with the public during the community meeting held on May 2 and in subsequent communication with stakeholders. This schedule directly supports Orchard's ability to take on the management of the center as well as deliver on the first new uses for the Village Center as efficiently as possible.

When we worked backwards to develop the schedule, we accounted for the Council's August recess as well as avoiding any conflict with the Council's review of the budget. A pre-file this month would give the Council the ability, should you and your colleagues desire, to table the legislation in June and take an extra month to review. Delaying the legislation through the Council's August recess, however, will cause considerable delays in the closing schedule as well as the subsequent approvals that the development team will need to seek. While we were able to delay the RFP release at your request last fall, we now have a private development team with a financial stake in the project and critical deadlines ahead of them to ensure that their proposal for a thriving village center is successful. In addition to the implementation of the redevelopment proposal, the timing of the ownership transfer is also critical to the management of the Village Center. Orchard, which has experience managing retail, has committed to taking ownership and restore vibrancy to the village center. We are hopeful to make this happen by the end of this calendar year, when a majority of tenant leases in the Long Reach Village Center expire.

The developer and the community are relying on the County to not delay this redevelopment. The members of the RFP review committee devoted many hours over a short period of time to ensure that we completed the review in time for Planning Board and County Council approvals. The Long Reach Village Board and the Planning Board, after a comprehensive review of the plans, voted last week to provide unanimous support and all testimony submitted to the Planning Board was in favor of this proposal. At the May 2, community meeting, all comments and questions about the proposal were also supportive of these future plans. During the council's review, you will likely hear similar testimony. We hope that you will consider cosponsoring the legislation to advance the redevelopment, however, regardless of that decision, we hope that you will not encourage delay of the Council's review of the proposal.

Councilmembers,

At the June 19 public hearing, a question was raised concerning why approval of the project and disposition of the property were not being done in conjunction with the zoning changes that would need to occur or after relevant approvals were in place for the redevelopment project. There are several different reasons for this – some legal and others because of the community and the Administration's desire to see the realization of the community's vision for the Village Center as quickly as possible.

- 1. Even if the two processes could be done simultaneously, the result would delay the execution of the purchase and sale agreement until the sale is approved (either at re-zoning or entitlement). Without a purchase and sale agreement, Orchard is not obligated to perform, nor can we hold them to any development milestones. This shifts significant risk to the county- should the developer not receive certain approvals or decide to walk away because a certain change or approval they sought is not approved
- 2. Maintaining County ownership of the LRVC would require the County to be the petitioner for the Major Village Center Redevelopment process. This poses a number of issues:

i. Any plan review documents or rezoning requests would be submitted by the county as the petitioner and reviewed/evaluated by DPZ and other County Departments. While this may be appropriate for a public works project, this will be a private development and not a public use. The county acting as the petitioner, regulator/reviewer, and ultimate approver creates a perceived (and potential) conflict.

ii. There are considerable planning and designs cost related to the Village Center Redevelopment process that would be shifted to the county if the developer is not under contract.

iii. Required community workshops and meetings would be the responsibility of the county as the petitioner and property owner with no developer obligation to participate.

- 3. Not having a purchase and sales agreement in place would delay the due diligence process for the developer; so even with all approvals in place, the developer would have the ability to walk away prior to performing any redevelopment work on the property, putting the County and the community back to Square 1 for urban renewal
- 4. In response to legal advice on the issue of contract zoning, the Administration is being careful to avoid creating any apparent or potential links between zoning changes and the sale of the property; a claim if raised could set the redevelopment of the property back.

- 5. The transfer of ownership will enable a private company with experience in owning commercial and retail property the ability to manage the Village Center more effectively. Owning and operating a commercial center is not a typical government function and therefore the county is not best suited to perform that role. We do not have the expertise necessary to operate it, nor address the current blight conditions.
- 6. Orchard has committed to expediting the Village Green in 2018 to allow quicker community use of the Village Center. This would be delayed should the County continue to maintain ownership, further contributing to the decline of the Village Center.
