1 **WHEREAS**, a seven member Compensation Review Commission is established and is
2 empowered to set compensation and allowances to be paid the members of the County
3 Council pursuant to the authority of Section 10-302 of the Local Government Article of the
4 Annotated Code of Maryland, formerly codified in Article 25A, Section 5(AA) of the
5 Annotated Code of Maryland, and Section 202(d) of the Howard County Charter and Title
6 5, County Council Subtitle 1, Compensation Review Commission of the Howard County
7 Code; and

9 **WHEREAS**, pursuant to Section 302(e) of the Howard County Charter, the Compensation
10 Review Commission shall review the County Executive's compensation and allowances
11 and make recommendations to the County Council regarding same.

13 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
14 Maryland, this 5th day of September, 2017 that the following residents of
15 Howard County be and they are hereby appointed to the Compensation Review
16 Commission:

1 The Commission shall elect from its members a chairperson, a vice chairperson and such
2 other officers as it shall deem appropriate.

3

4 **AND BE IT FURTHER RESOLVED** that, not later than December 18, 2017, the
5 Commission shall submit by resolution to the County Council its recommendations of
6 compensation and allowances for the County Executive and County Council to be elected
7 in November 2018.

8

9 **AND BE IT FURTHER RESOLVED** that the Commission may recommend an increase
10 or decrease in the compensation and allowances paid to the County Executive and
11 members of the County Council but in no event may compensation be less than that
12 provided in the Howard County Charter.

13

14 **AND BE IT FURTHER RESOLVED** that the Commission shall hold public hearings
15 which shall be advertised for two successive weeks in a newspaper of general circulation in
16 Howard County, and notice of all meetings, public hearings, and work sessions of the
17 Commission shall also be posted on the County Council bulletin board and website at least
18 two weeks in advance of such sessions.

19

20 **AND BE IT FURTHER RESOLVED** that the Commission shall terminate and cease to
21 function on April 30, 2018.
