1 **Section 1. Be It Resolved** by the County Council of Howard County, Maryland, that Exhibit B  
2 attached to Council Resolution 105-2016 is enlarged by adding to the development district the  
3 following parcels:

4 (1) the parcel at 5900 Symphony Woods Rd, Columbia 21045, Tax Map 36, Parcel 307,  
5 Tax Account number 15-018364 also known as "Lot 1 Area 1 S 5" consisting of 2.58 acres that  
6 is the current home of Toby's Dinner Theater;

7 (2) the parcels located adjacent to South Entrance Road known as Open Space Lot 3, or  
8 Tax Map 36, parcel 527, Tax Account numbers 15-599583 and 15-599592, which are adjacent to  
9 and northwest of the parcel described in item (1); and

10 (3) any portion of South Entrance Road that is adjacent to the development district and  
11 also to the parcels described in items (1) and (2).
