Good evening, my name is Tonya Tiffany and I live at 10702 Judy Lane, in Columbia MD. I support the Board of Education's recommendations for APFO as well as Mr. Zhang's request to strengthen our roads test. It might be a good idea to create a sliding scale of requirements based on the size and scope of a development.

I have 2 major concerns in regards to our school systems overcapacity issues in relation to the portables in use around the county. The first concern that I have is during emergency situations and the feasibility of executing safety plans. There are several real life reasons for that concern. In January of 2016 there was a fire at Glenwood MS. The entire school (thankfully an undercapacity one) had to be evacuated and they were lucky enough that there is an elementary school across the parking lot. Then last school year at Clemens Crossing Elementary School the whole school went into a real lockdown as there was an active shooter type of situation that happened in the neighborhood. Each of these situations presented very different types of real issues for safety. Fortunately at GMS and CCES there are very few portables in use. Can you imagine the situation had either of them occurred at Howard High?

My second major concern comes in the form of health risks from compromised air quality and structural stability. Over the past several years I have been a part of a group of parents who were instrumental in the uncovering of the mold issues in our school systems. The photos that you have before you were taken last year during the efforts to figure out how to effect change. Our school system already has an existing backlog of building maintenance issues to deal with, but you also need to add in 200 individual portable buildings that must also be maintained, but many times they are ignored. Until issues become obvious enough to have to deal with them.

I would like to take you on a journey into one of the top ranked school systems in our country and a give you a sampling of how it is marred when you look at the condition of some of our portables.

I have been a resident of Howard County for 5 years. My family moved from Baltimore County to Howard County in large part because of the schools. I have a 2nd grader and 4th grader at West Friendship Elementary. I am also a member of the HCPSS Attendance Area Committee (AAC). I have seen first-hand how school overcrowding and the redistricting process has torn the county apart.

I certainly understand the need to utilize capacity at our existing schools, but changes need to be made to the underlying causes of overcrowding so that large scale redistricting isn't needed every few years. Ideally, redistricting should only occur when a new school is opened and should only impact the area closest to the new school. The fact that land was not secured from the developer of Turf Valley for an elementary school and that ES45 isn't planned until 2028+ is inexcusable. ### Good Evening -

My name is Vanessa Zawodny and my family and I reside at 2917 Greenlow Court Ellicott City, MD 21042. We specifically moved to the Valley Mede neighborhood earlier this year for the same reasons that the majority of our neighbors seem to share: the schools. While I had some knowledge of possible redistricting prior to moving to the neighborhood, I was admittedly not as well informed as I should have been about the Adequate Public Facilities Ordinance (APFO) and current proposed changes contained in Council Bill 60 & 61 (CB 60 & 61).

My concerns with CB 61 are as follows:

- 1. I am concerned about current and proposed development projects that bring tax revenue, businesses, and new residents to our county but that do not adequately fund the critical services and infrastructure necessary to support a growing population (schools, fire, police, community centers, etc.) and protect our quality of life.
- 2. As a mother and someone who specifically moved to this area for the quality of the community and its schools, I paid a very high premium for access to them. I am concerned that if the county doesn't do a better job controlling and planning for development the schools will be forced to redistrict again in 2-3 years. Redistricting has several potential ramifications including increased costs for busing students to schools that are further away, increased time students spend on buses to get to school, and those buses would add to the already congested local roads in the area. Our neighborhood's schools are already over capacity in many instances and have portable classrooms on school property to accommodate the existing student population, which not only present health and safety concerns for our children but also affect the quality of teaching and learning that is provided.
- 3. Lastly, I am concerned that my property taxes will be increased to make up for the low development fees that developers pay in our county to increase density but not services or infrastructure to support their development or our community.

I am requesting that CB 61 is amended with the following provisions to more fairly and equitably balance well-planned growth and effective mitigation for our public infrastructure:

- 1. School capacity limits –INCLUDING high schools to be set at 100%. Schools are closed to new development at that level.
- 2. Mitigation (funding, additional time, or both) begins when a school reaches 95% capacity.
- 3. NO reductions to the current wait time for housing allocations or school tests.
- 4. APFO needs to be reviewed every 4 years.

- 5. Increase real estate transfer tax to account for resale contributions.
- 6. APFO needs to include measures for public safety, emergency services, recreation, and other community facilities.

In conclusion, I think it is worth noting that the only people that are in opposition of APFO amendments are developers. The residents of Howard County are united in our opposition of CB 61 and the only ones that are for it are those who stand to make a profit at our expense. I am one of the over 100,000 employee members of the Maryland Building Industry Association (MBIA) representing over 1,000 business members. I write in support of Council Bill 61 as drafted and without ANY substantive amendments related to the County's Adequate Public Facilities Ordinance. This bill represents hundreds of hours of work over the course of an entire year by the APF Task Force including 23 county residents from a broad cross section of stakeholders. The bill as presented is a reasonable and responsible compromise that effectively protects the County's valuable public resources while respecting the rights of private property owners and implementing the County's growth goals in PlanHoward 2030.

#### Good Afternoon -

My husband and I have lived in this county for 13 years and are raising two young children in the public schools. We moved to this county from Montgomery County (where we were raised) to raise our kids as we had heard about the amazing school system and we liked the fact that the county still had green/open spaces. Since moving here, I have become extremely concerned about the impact of the development. We purposely avoided moving to Northern Virginia or Rockville because the development has made it so crowded and unpleasant. I want my children to grow up in an area that has conveniences like the mall, but also in an area where they can still see grass and farms.. In looking just at the area around the mall, I recently commented to my husband that it's beginning to look like Tysons and I hope that someone will put a stop to this mass development as I will not continue to live in a county that become too overpopulated to the point it destroys the peacefulness and impacts your ability to even get around.

As we have started navigating the school system, I have become even more concerned about the impact of development on the schools. While I understand that redistricting may be necessary to correct the problem (and I am not necessarily concerned about where my children will be redistricted), I am concerned that the development will make redistricting a common occurrence. My husband and I were redistricted 5 times as kids from 1<sup>st</sup>-12<sup>th</sup> grade – that is NOT something I will allow my children to go through. It's my hope that you will stop the ridiculous amount of development that seems to keep occurring throughout the county until the developers can show that the infrastructure in the county will support the number of people they want to put here.

I, unfortunately, have had to visit the ER several times this year and have experienced the incredible delay to receive treatment. When inquiring about the delay, they informed me that on a Saturday night, they have one doctor and one PA! How does that make any sense given the number of people who frequent the ER. My husband and I have actually considered returning to Montgomery County to seek medical care, which is absurd given that Howard General is a JHU affiliate (and the tax dollars we spend in this county). However, the prestige of JHU is nothing if it takes 13 hours to be seen due to the large number of people who visit the ER.

The traffic on Route 29 has become problematic, even with the massive widening that took place over the last few years. I have also experienced delays in calling 911 – once for medical care and once for someone breaking into my house.

My biggest concern is that developers are being permitted to develop every last piece of land they can find without any consideration for what it does to the citizens who actually live here. The schools are having trouble keeping up, the roads can't handle the number of people that live here, the hospital is having trouble keeping up with its patients, 911 takes forever to get through, and it is my understanding that the police department is having trouble keeping up with the demand of the population.

I urge the County Council to vote this month on CB61. Updates to the County's APFO are well overdue as evidenced by the County Executive's action to form a committee to review and submit recommendations to APFO and his subsequent drafting of CB61 and CB62. We need immediate action on APFO.

County Council members need to show the community that their citizens are their priorities, which means that they will ensure that our infrastructure, including our schools, will not suffer. Please do not delay the vote on APFO any further. I would like to see the following:

- 1. Ensure that public safety measures, including roads, emergency services, and the hospital capacity can support the number of people in the county to include those future citizens that the developers count on.
- 2. Set school capacity limits including high schools at 100%. Schools should be closed to new development once they reach 100% capacity.
- 3. Begin mitigation (funding, additional time, or both) when a school reaches 95% capacity.
  - a. If developers find that their current projects are going to cause the schools to exceed 100% capacity, the developers should pay a stiff penalty. We need to deter these (often non-Howard County) developers from increasing our population to our detriment.
  - b. If developers suddenly "forget" to create affordable housing in their plans (once everything has been built and seeks to build additional units), they should be forced to pay a hefty fine. This should not happen. The developers are not inexperienced and have experts at their disposal to assist them with their projections. Howard County citizens should not be the ones who suffer because a large developer forgot to account for the affordable housing.
- 4. No reduction to the current wait time for housing allocations or school tests.
- 5. Increase transfer tax percentage on resales to help off-set the cost of new seats being added from resales.
  - a. If there are any other ways to increase fees to require the developers to invest in the infrastructure before increasing our population, then please explore those options.
- 6. Review and update APFO every 4 years
- 7. Ensure that Howard County will continue to have green spaces throughout the county. If this area turns into concrete structures as far as the eye can see, it will not longer be an attractive place to live and I predict you will see many move to other counties.

Please do not delay this vote. Parents and taxpayers deserve to see where you stand on this important issue.

Written Testimony For CB 61

My name is Chris Forrest and I reside at 10305 Greenbriar Ct, Ellicott City MD 21042. I have lived at this address for 9 years after living overseas for 5+ years. Prior to living in the UK for 5 years, I resided in the Elkridge section of Howard County for 5 years. My concern today is that we are not choosing to grow our county responsibly. I commend Mr. Kittleman for setting up a task force to look at APFO as it has been long overdue.

Let me give you some background on where my concerns stem. As I mentioned, my family has lived in Ellicott City for some time. I work in Annapolis. We chose Howard County as this is a midway point for the different directions we take to make a living. We chose Howard County because our previous experience living here....to put it simply we were coming home. We chose Howard County because of the reputation school system in 2008 and we knew our son would be given a good foundation for life. Today unfortunately I now deal with what was a 45-60 minute drive home with some evenings being closer to 90 mins due to increased development without the same investment in infrastructure. The traffic at the intersections 100, 29, 40, 70 can now take 30+ minutes. My son attends Manor Woods Elementary School. In 2014 his 1st grade year, capacity was at 672, just below school capacity of 681. Last year we ended the year just at 115% of capacity, so we have lived through the growth numbers represented in APFO. Unfortunately the development does not stop because we have met this number....we will continue to grow with new developments being delivered as we speak. From a personal experience, this quick a growth for a school is difficult for the administration, the teacher, and the students. Mr. Kittleman you attended our Blue Ribbon ceremony in May, you could see how uncomfortable and perhaps unsafe it may have been to have that many students in the cafeteria. There is a separate issue related to how the school system responds to development they should know is coming. The answer can't be to just add portables. This a temporary fix. More money needs to be available to the school system and better communication needs to happened between DPZ and HCPSS to understand capacity impacts.

I am often asked at work why do I live so far away? It was easy, I used to brag how good the community and the school system was. My colleagues would argue that the Severna Park and Broadneck communities and school system is great. I would say I understand, but Howard County is even better. That was 8 years ago. Based on the unbridled construction and lack of parallel investments in infrastructure and schools, that is not a valid argument anymore. Howard County seems to have rested on its laurels and just assumed the county will stay great without effort. That isn't the case. A lack of planning for growth is making the investment we put into our homes and associated property taxes one of diminishing returns. We have friends move to Carroll County for a better quality of life. As I sit in traffic jams on I-100 or I-29, or listen to my son describe how crowded and noisy his classes can be, I wonder why we are staying here.

The recommendations from the APFO task force which do not go deep enough are reflected in CB-61. We need to amend CB-61:

- School capacity limits need to be set at 100%.
- School capacity must include High Schools. We are telling our 13-18 years olds they don't matter by not including a HS test in APFO. All stages of school are important and should be represented when making development decisions.
- No reductions to the wait times.
- Impact fees need to realistically cover the cost of an additional family. School, roads, fire, police, recreation all need some of these funds. Current impact fee does not come close to covering the cost of a school age child in the system.
- Real estate transfer tax needs to increase by at least 1.0%.

- APFO testing needs to include fire, police, recreation (quality of life factors). Our fire and police are ready to serve, let's listen to their needs so they can serve effectively.
- APFO legislation needs to be reviewed on a regular interval. Every 4-5 years would provide time to see how the county is fairing with current legislation. As with most things we need to adapt more quickly to needs as they appear.

I appreciate your time to consider my feedback. I hope you will help create a future for Howard County that will have the next generation proud to say they are from Howard County and that we have chosen to build responsibly.

I attended the Council meeting on September 11, 2017. I listened to CB 60 and 61 testimony. I did not plan to testify on APFO, but after listening to the children testify about school conditions, I knew I must.

We moved to Howard County in the summer of 2016. In other states, my children attended schools/school districts that used portables to manage capital spending. However, those portables had water/bathrooms. Any portable used in Howard County should have a bathroom. From the young girl's testimony, it seems as if they do not.

Last year was the first year one of my children has not used a portable. My son attends Northfield Elementary and did not have to attend any classes in a portable. While I understood the need for portables, I can say the educational experience is better without them. The Northfield Elementary School art rooms are amazing. However, last year, my son's homeroom classroom was a converted resource room, so it was smaller than a traditional classroom. They repurposed an adjoining restroom into a "cloakroom", and discreetly moved wooden cubbies in front of the urinals. When I first saw the classroom set-up I thought the school was very resourceful, and was impressed with their ability to manage a less than ideal situation. Even though the classroom was cramped, my son had an excellent 4<sup>th</sup> grade year, due to his teacher, Ms. Donna Dixon, and her dedication to the students. During the current 2017-2018 school year, due to the increased number of students, Northfield moved a classroom into a portable.

As I learn more about school funding and redistricting, I worry that we do not have appropriate facilities for our students, and we are not preparing for the future. How did the county get to a point where Howard High School is at 137% of capacity? Centennial is at 123% of capacity; Long Reach is at 120%. At those numbers, students are not getting the attention they need to grow. It makes it harder to join sports teams, and participate in drama, and other extracurricular activities crucial for success.

I was heartened to hear that the County Executive wants to fast track the construction of HS13. However, it is 5 years away and we are facing a crisis now.

My daughter is an 8<sup>th</sup> grader at Dunloggin Middle School. She says it is difficult to move in the hallways it is so crowded. Please accelerate the improvements and expansion at Dunloggin Middle School.

Schools are not the only public infrastructure in need of help. On Dunloggin road there must have been a "water event" under the blacktop, and it has rippled a major portion of the road. Crews work to fix breaks, but I feel like these are band aid measures. The road will be shut down this week for repairs. Many roads are not wide enough for traffic. The turn lanes and U-turns on Route 40 are scary and dangerous.

Last week I drove from Northfield Rd. to Route 40, against traffic. At 8:30 a.m. on a Thursday morning, there was bumper to bumper traffic from Northfield to Frederick Rd. and almost to Route 40. Until then I had no idea what a "moving parking lot" was.

We need adequate facilities. And developers need to pay an appropriate amount to cover the new development.

#### My recommendations:

- 1. Stop development when schools are at 100% capacity at the elementary, middle school AND HIGH SCHOOLS.
- 2. Raise the rates developers pay.
- 3. Fast track HS13 in the eastern part of the county.
- 4. Start planning for the 14<sup>th</sup> high school so we are prepared if we need it. I cannot believe we will get no relief from high school over capacity until the 13<sup>th</sup> high school is opened in 2022 (fast tracked date).
- 5. Accelerate improvements at Dunloggin Middle School. (Other schools need attention too.)
- 6. Improve roads, water and sewers.
