Transfer of Appropriation Ordinance No. 1 Fiscal Year 2017

Introduced by: The Chairperson at the request of the County Executive

AN ACT transferring \$550,000 in grant funding from Capital Project D1165, Flood Mitigation and Stormwater/Waterway Enhancement, to Capital Project D1158, Watershed Management Construction, so that the County may receive additional grant funds from the Maryland Department of Natural Resources, Chesapeake Bay Trust Fund, for stream restoration work.

1 **WHEREAS**, for Fiscal Year 2017, the County budgeted \$1,450,000 in grant
2 funds in capital project D1158, Watershed Management Construction, for a grant from
3 the State of Maryland’s Department of Natural Resources, Chesapeake Bay Trust for
4 stream restoration work (the “Grant”); and

5
6 **WHEREAS**, after the start of the Fiscal Year, the County was notified that it was
7 awarded a total of \$2,000,000 for the Grant; and

8
9 **WHEREAS**, the grant awarded exceeds the amount budgeted by \$550,000; and

10
11 **WHEREAS**, D1158 contains \$7,430,000 in prior appropriated grant funding but
12 much of that is for grants that have already been awarded and spending authority for the
13 additional \$550,000 does not currently exist in D1158; and

14
15 **WHEREAS**, grant funding is available in Capital Project D1165, Flood
16 Mitigation and Stormwater/Waterway Enhancement, to account for the additional grant
17 funding; and

18
19 **WHEREAS**, the County wishes to transfer grant funding from Capital Project
20 D1165, Flood Mitigation and Stormwater/Waterway Enhancement, to Capital Project
21 D1158, Watershed Management Construction, to account for the additional \$550,000;

24 **WHEREAS**, Section 609(b) of the Howard County Charter authorizes and
25 empowers the Howard County Council to make such transfers; and

27 **WHEREAS**, the Director of Finance has certified that the appropriation to be
28 transferred is not encumbered and is available for transfer.

30 *Section 1. Be It Enacted by the County Council of Howard County, Maryland, that,*
31 *subject to the provisions of Maryland law, the Howard County Charter, and the Howard*

1 *County Code relating to the budgetary and fiscal procedures, the amount hereafter*
2 *specified is hereby approved, appropriated, and authorized to be disbursed for the*
3 *general County purposes specified and in sums itemized for the fiscal year beginning July*
4 *1, 2016 and ending June 30, 2017, as hereinafter indicated.*
