20 *V. Duration of Certificate; Renewals.* [[Certificates are valid until July 1 following the date of
21 issuance and may be renewed each July 1 provided that the Applicant conforms to the provisions of
22 the subtitle and regulations issued pursuant to it.]] A CERTIFICATE REQUIRED BY THIS SUBTITLE IS
23 VALID FOR TWO CALENDAR YEARS FROM THE DATE OF ISSUANCE WHICH SHALL BE JULY 1 AND MAY BE
24 RENEWED UPON PAYMENT OF A LICENSE FEE AND COMPLIANCE WITH THE REQUIREMENTS OF THIS
25 SUBTITLE AND REGULATIONS ISSUED PURSUANT TO THIS SUBTITLE.

28 *VII. Duration of Taxicab Driver's License:*

29 a. A license shall be valid [[until July 1]] FOR TWO YEARS FROM [[after]] the date of issuance

1 WHICH SHALL BE JULY 1.

- 2 b. A license may be renewed [[each July 1]] upon certification by a physician of the
3 continued good health of the driver and upon payment of the renewal fee.
- 4 c. Any taxicab driver who has allowed [[his/her]] THEIR license to lapse FOR MORE THAN ONE
5 YEAR BEYOND ITS EXPIRATION [[for over two years]] shall not be permitted to renew the
6 license and shall go through the application process to obtain a license.
- 7 d. The individual may not drive a taxicab while [[his/her]] THEIR taxicab driver's license or
8 Maryland driver's license is suspended, revoked or lapsed.

11 ***Section 2. And Be It Further Enacted*** by the County Council of Howard County, Maryland that
12 *this Act shall become effective 61 days after its enactment.*
