Pursuant to Section 18.204 of the Howard County Code, please accept this letter on behalf of Triangle Route 108 Associates, LLC (the "Petitioner") as a request to close a portion of Old Maryland Route 108 as referenced and specified hereinafter.

To assist your review of this request, the following documents are attached:

- (1) A detailed description of that portion of Old Maryland Route 108 being requested to be closed (**EXHIBIT A**); and
- (2) A certified plat signed and sealed by a professional land surveyor which describes that area of Old Maryland Route 108 being requested to be closed (EXHIBIT B).

Old Maryland Route 108 currently services seven parcels that Petitioner has under contract for the development of an eighty-two unit stacked multi-family residential development. In order to facilitate this development, Howard County Department of Public Works has requested that Petitioner take ownership of this road, which is the sole means of ingress and egress to Petitioner's property from Old Annapolis Road. Petitioner submits this request for road closure in order to make the road and underlying property available for transfer.
