1           **WHEREAS**, concurrent with this fee schedule, the Council has approved Council Bill  
2 No. 12-2018, which requires a permit for concerts and for special events such as parades, public  
3 assemblies, athletic events and block parties; and

5           **WHEREAS**, Section 17.905, as included in Council Bill No.12-2018, provides that the  
6 County shall charge a non-refundable application fee for Special Event and Concert Permits and  
7 the application fee is due upon application for a permit; and  
8

9           **WHEREAS**, Section 17.905 provides that the application fee shall be adopted by  
10 Resolution of the County Council; and  
11

12           **WHEREAS**, Council Resolution No. 62-2017 was approved by the Council on May 24,  
13 2017 and adopted a rate for concert permit applications under the authority of Title 14, Subtitle 5  
14 of the Howard County Code; and

16           **WHEREAS**, Council Bill No. 12-2018 repeals Title 14, Subtitle 5 and, accordingly, any  
17 fees authorized by that Subtitle need to be repealed.

19           **NOW, THEREFORE, BE IT RESOLVED**, by the County Council of Howard County,  
20 Maryland this \_\_\_\_ day of \_\_\_\_\_, 2018 that it adopts the attached application fees for the  
21 Special Event and Concert Permit.

23           **AND BE IT FURTHER RESOLVED**, that the fee schedule shall be effective when  
24 Council Bill No. 12-2018 is effective and shall continue in effect until changed or repealed by  
25 subsequent Resolution of the County Council.

27           **AND BE IT FURTHER RESOLVED**, that the fee schedule titled “Concert Permit”, as  
28 adopted by Council Resolution No. 62-2017, is hereby repealed.

**APPLICATION FEES FOR SPECIAL EVENT AND CONCERT PERMITS**

*This fee is set pursuant to Section 17.905 of the Howard County Code that authorizes the County to charge an application fee for Special Events and Concert Permits.*

Non-refundable Application Fee for Special Events: \$50

Non-refundable Application Fee for Concerts: \$200
