WHEREAS, the County Executive has proposed a County-share of the Howard Community College Fiscal Year 2013 operating budget totaling \$27,213,286; and

WHEREAS, debt service on outstanding bonds issued by the County for the Community College in Fiscal Year 2013 is projected to be \$6,557,320; and

WHEREAS, \$5,739,174 in debt service will be paid directly by Howard County government; and

WHEREAS, Section 16-301 of the Education Article of the Annotated Code of Maryland requires the County governing body to review and approve the budget of the Community College; and

WHEREAS, Section 16-304 of the Education Article of the Annotated Code of Maryland requires the County governing body to make appropriations for the Community College by major functional categories.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County, Maryland, this 31 day of May, 2012 pursuant to Sections 16-301 and 16-304 of the Education Article of the Annotated Code of Maryland, that the Fiscal Year 2013 budget of the Howard Community College in the total amount of \$168,183,779 is hereby approved, and that appropriations are made for the major functional categories as attached hereto and incorporated herein.
