1           **WHEREAS**, Howard County, Maryland (the “County”) wishes to lease multi-function  
2 printers that are capable of printing, copying, faxing and scanning (with optical character  
3 recognition); and  
4

5           **WHEREAS**, the County’s current contract for copier and printer services expires on  
6 October 18, 2018; and  
7

8           **WHEREAS**, the County has explored alternatives and recommends moving to Hewlett  
9 Packard printers and copiers which will result in significant cost savings and which will provide  
10 more efficient support of making searchable data; and  
11

12           **WHEREAS**, in order to realize significant costs savings, by August 1, 2018, the County  
13 will need to enter into a 5-year lease for copiers and printers with CDW-G, LLC pursuant to a  
14 Lease Agreement, substantially in the form attached as Exhibit A; and  
15

16           **WHEREAS**, entering into the Lease Agreement by August 1, 2018, will allow the  
17 County to begin a smooth and efficient transition to the new copiers and printers; and  
18

19           **WHEREAS**, the Lease Agreement requires the payment by the County of funds from an  
20 appropriation in a later fiscal year and therefore requires County Council approval as multi-year  
21 agreements pursuant to Section 612 of the Howard County Charter.

23           **NOW, THEREFORE,**

25    *Section 1. Be It Enacted by the County Council of Howard County, Maryland that in*  
26    *accordance with Section 612 of the Howard County Charter, it approves the terms of the Lease*  
27    *Agreement between Howard County and CDW-G, LLC, which shall be in substantially the same*  
28    *form as Exhibit A attached to this Act.*

1 **Section 2. And Be It Further Enacted** by the County Council of Howard County, Maryland that  
2 *the County Executive is hereby authorized to execute and deliver the Lease Agreement for such*  
3 *term in the name of and on behalf of the County.*

5 **Section 3. And Be It Further Enacted** by the County Council of Howard County, Maryland, that  
6 *the County Executive, prior to execution and delivery of the Lease Agreement may make such*  
7 *changes or modifications to the Lease Agreement as he deems appropriate in order to*  
8 *accomplish the purpose of the transaction authorized by this Act, provided that such changes or*  
9 *modifications shall be within the scope of the transaction authorized by this Act; and the*  
10 *execution of the Lease Agreement by the County Executive shall be conclusive evidence of the*  
11 *approval by the County Executive of all changes or modifications to the Lease Agreement, and*  
12 *the Lease Agreement shall thereupon become binding on the County in accordance with its*  
13 *terms.*

15 **Section 4. And Be It Further Enacted** by the County Council of Howard County, Maryland that  
16 *this Act shall be effective immediately upon its enactment.*
