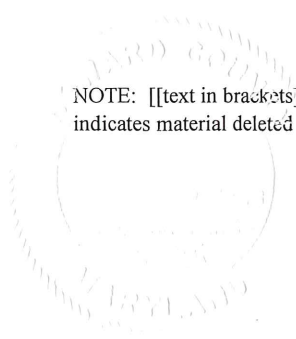

18 (b) *Appointing Authorities.* Appointing authorities for Executive exempt employees are as
19 provided in this subsection:

- 20 (7) *Public Works.* The Director of Public Works, with the approval of the County Executive,
21 is the appointing authority for the:
22 Deputy Director of Public Works;
23 Engineering Manager II, serving as the Chief, Bureau of Engineering;
24 Engineering Manager II, serving as the Chief, Bureau of Environmental Services;
25 Engineering Manager II, serving as the Chief, Bureau of Highways *[[and]]*;
26 Engineering Manager II, serving as the Chief, Bureau of Facilities~~*[[.]]*~~; AND
