1           **WHEREAS**, the County Executive issued Executive Order 2018-07 on May 27, 2018, related to  
2 a severe flooding event that occurred on May 27, 2018; and

3           **WHEREAS**, by passage of Council Resolution No. 84-2018 (“CR 84”), the County Council  
4 extended the State of Emergency through July 3, 2018; and

5           **WHEREAS**, the State of Emergency declared by Executive Order 2018-07, and extended by CR  
6 84, will expire on July 3, 2018, unless extended by the County Council; and

7           **WHEREAS**, the hazardous conditions will continue beyond July 3, 2018; and

8           **WHEREAS**, extending the State of Emergency is necessary to protect public health, safety, and  
9 welfare and to protect property.

11           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,  
12 Maryland this \_\_\_\_\_ day of \_\_\_\_\_, 2018, that the exercise of Emergency Powers by  
13 the Executive under Sections 6.103 and 6.104 of the County Code is necessary to protect the public  
14 health, safety, and welfare and to protect property in the parts of the County that were harmed by the  
15 flooding.

17           **AND BE IT FURTHER RESOLVED** that the State of Emergency declared by the County  
18 Executive through the Executive Order issued on May 27, 2018, and extended by CR 84, is extended  
19 through July 30, 2018, unless terminated sooner by the County Executive or extended by Resolution of  
20 the County Council.

22           **AND BE IT FURTHER RESOLVED** that representatives of the Administration shall provide progress  
23 updates to the Council at its scheduled meetings on July 9, July 16, and July 23, 2018.
