To Whom It May Concern,

My name is Brian J. Ro, and I have been a resident of the Owen Brown village in Columbia since 2009. I want to express my support for CB36-2014. I own 2 electric vehicles (EVs), a Chevy Volt and a Ford C-Max Energi. While I have been thrilled being able to drive over 20,000 gas-free miles since 2012, there has been a persistent issue that I have encountered time and time again. On many occasions I have been prevented from using an EV-designated charging space due to a conventional gas vehicle blocking it. Upon inquiry to store owners or property managers, the usual response received was, "Sorry, we can't do anything as no law is being broken".

The charging stations I frequent most often are located on Columbia Association (CA) property, and during busy times it is almost a guarantee the EV charging spaces will be blocked. The majority of these CA charging stations were at least partially funded by state/federal incentives, so each time an EV owner is prevented from using these spaces as intended is a waste of taxpayer money.

Governor O'Malley is a supporter of EV adoption, signing into law EV purchase incentives back in 2010, and has just renewed these incentives this past July 1, increasing the max excise sales tax credit from \$1,000 to \$3,000, and the EVSE charging station credit from 20% to 50% of the unit cost + installation costs. The governor has also made it a requirement that state greenhouse gas emissions be reduced 25% by the year 2020.

Maryland is part of an 8-state coalition that has pledged to put 3.3 million EVs on the roads by 2015. With these new incentives combined with falling EV prices, EV sales are set to take off in our state.

The time to act is now, so that this parking issue can be resolved before it becomes a bigger problem. Montgomery County has already pass legislation address the EV space blocking problem, and I urge Howard county to follow in their footsteps. This is an issue that should not be punted down the road any more. EVs are not a temporary fad...they are here to stay, and passage of CB36-2014 is simply the next logical step in enhancing EV adoption in Maryland.

My name is Mitchell Schull. I live in Columbia, MD and am a paying resident of the Columbia Association (CA). I drive a Nissan LEAF and plug in at the CA owned Level-2 chargers in the Harpers Choice village center. First of all I am grateful for CA's contribution in putting EV chargers around Columbia. My understanding is that these chargers are funded partially through a DOE grant but also partially funded through CA. As a CA member who pays fees I want to see these chargers being used. At the moment it is my experience that these charger's parking spots are taken by Internal Combustion Engine (ICE) vehicles quite frequently. I've actually encountered people parking in these spots and have approached them. Most of the time people don't even realize the spot is reserved for EVs therefore I don't fault them. I live in Howard County and have been driving an electric car for over two years. I'm proud of the leadership that Howard County has demonstrated in supporting plug-in vehicle charging infrastructure. I was present at the dedication ceremony when the five charging stations at the Dorsey Building were opened in 2011. I believe they were the very first public EV charging stations in the county and it shows that Howard County is committed to sustainable transportation which I support.

According to the Maryland Motor Vehicle Administration, there are 252 plug in vehicles in Howard County as of December 2013. That ranks the county third in the state. There are currently over 35 public charging stations at 13 sites in the county including four charging stations recently installed at the George Howard Building.

Gasoline-powered, non plug-in vehicles parking in front of charging stations has been an issue at some locations. When I've approached the managers of the properties where this is occurring, one reason I'm told that they will not place official "no parking except for electric vehicles" signs is the lack of legislation that allows for enforcement.

I believe that ensuring access to charging stations is a public policy issue because many of those public stations were funded with taxpayer money through US Department of Energy grants. The cost of installing these Level 2 public charging stations is said to be between \$6,000 and \$10,000 each. That investment goes to waste each time they are not accessible

for their intended use.

Attempts to address this problem in the Maryland General Assembly have failed for the past three years in a row. In the 2012 session, Delegate Guy Guzzone, who represents my district, co-sponsored HB108. I wrote and offered input and support for that bill but HB108 didn't pass.

In 2013, a similar bill, HB1149 was introduced but it also failed to move through.

Earlier this year, Delegate Frank Turner, who also represents my district, co-sponsored HB1020 which died after an unfavorable report in the House Environmental Matters Committee.

Meanwhile, Montgomery County passed a law (bill 32-13) which is the first in the state of Maryland to deal with this issue. The law became effective on June 11, 2014.

In my opinion, the current text of bill CB36-2014 is adequate without any well-meaning language that could cause difficulties in actual practice. For example, if it were amended to require a plug in vehicle to be "charging" or "plugged in" that could leave an innocent driver susceptible to a fine or towing if someone unplugs their car without authorization. Time limits for parking can be imposed where necessary to encourage turnover.

I support passage of CB36-2014 as written.

# Dear Council members,

After attending the meeting on Monday and listening to the work session from Tuesday there are a few additional issues I'd like to weigh in on. I'll keep this very, very brief.

**CB-38:** I strongly support prohibiting the County from exercising condemnation of private property for economic development purposes. Citizens should not have their property taken simply becasue it interferes with governments master plan for an area. For example, I'd rather see Route 1 as a hodge podge of individual businesses than have ANY property owner forced out so that a big developer can put up the next bright shiny thing. My family experienced this in Baltimore County decades ago and I'd never want another family business --or homeowner--to be treated in that manner.

**CB-88 and CB-89:** I strongly support the right to referendum by citizens and by Council members. **CB-88**: In my 16 months of observing Council meetings I have witnessed several occasions where more time to get all the facts would have been beneficial before a vote. Less tabling could result and citizen and staff panels could provide the needed information to make an intelligent decision. **CB-89:** Cost over runs and changes to capital projects seem to have unfortunately become the norm. Well defined procedures for changing the budget are clearly called for.

**CB-36:** I support the restrictions on use of parking spaces designated for plug-in vehicles by others with the following reservations; (1.) The spaces should not be placed adjacent to buildings to further punish those unable to afford them (or hybrids). [The Banneker parking lot and the one for the Medical building on the hospital campus are perfect examples of government over-reach in social engineering. Free spaces for "average" vehicles are in short supply and at the furtherest reaches of the parking lots. I'm pleased that the charging stations at Banneker are in the middle of the lot.] (2) the cost of recharging the vehicles on County property should not be at taxpayer expense, especially since electric vehicles don't contribute to the highway fund. (3.) Stage in fines for violations only after an awareness campaign and clearly marked signs are implemented.

I hope that **CB-37** will get further consideration in the future. By holding off testimony until after midnight many persons had left before the opportunity to speak. It also appeared that persons objecting to the bill had only read the brief description rather than the full bill and failed to understand, among other things, that there is a distinction between school buildings and other county property.

Most people don't block EV charging stations on purpose, they are just not aware that their behavior presents a problem because they don't drive an EV. For those of us who have invested in this important vehicle fueling alternative, the issue is about much more than the car. This is about our energy independence and climate prosperity. We are tackling the devastating effects of our 250,000,000 million cars on the roads in the U.S. alone, comprising 30% of our carbon emissions. One EV at a time, we are making a difference by choosing cleaner, smarter transportation alternatives.

BEVI was one of the first grant recipients of the Maryland Electric Vehicle Infrastructure Program which resulted in placement of 72 public charging stations throughout the State of Maryland, 5 of which are located at the Howard County Dorsey Building. I drive a Nissan LEAF and plug in at the CA owned Level-2 chargers in the Harpers Choice village center. First of all I am grateful for CA's contribution in putting EV chargers around Columbia. My understanding is that these chargers are funded partially through a DOE grant but also partially funded through CA. As a CA member who pays fees I want to see these chargers being used. At the moment it is my experience that these charger's parking spots are taken by Internal Combustion Engine (ICE) vehicles quite frequently. I've actually encountered people parking in these spots and have approached them. Most of the time people don't even realize the spot is reserved for EVs therefore I don't fault them. Which is why I believe this bill should be passed. If people are informed that these spots are for EVs with bigger and more obvious signage I believe it would solve most of the problem. I live in Howard County and have been driving an electric car for over two years. I'm proud of the leadership that Howard County has demonstrated in supporting plug-in vehicle charging infrastructure. I was present at the dedication ceremony when the five charging stations at the Dorsey Building were opened in 2011. I believe they were the very first public EV charging stations in the county and it shows that Howard County is committed to sustainable transportation which I support.

According to the Maryland Motor Vehicle Administration, there are 252 plug in vehicles in Howard County as of December 2013. That ranks the county third in the state. There are currently over 35 public charging stations at 13 sites in the county including four charging stations recently installed at the George Howard Building.

Gasoline-powered, non plug-in vehicles parking in front of charging stations has been an issue at some locations. When I've approached the managers of the properties where this is occurring, one reason I'm told that they will not place official "no parking except for electric vehicles" signs is the lack of legislation that allows for enforcement.

I believe that ensuring access to charging stations is a public policy issue because many of those public stations were funded with taxpayer money through US Department of Energy grants. The cost of installing these Level 2 public charging stations is said to be between \$6,000 and \$10,000 each. That investment goes to waste each time they are not accessible for their intended use.

Attempts to address this problem in the Maryland General Assembly have failed for the past three years in a row. In the 2012 session, Delegate Guy Guzzone, who represents my district, co-sponsored HB108. I wrote and offered input and support for that bill but HB108 didn't pass.

In 2013, a similar bill, HB1149 was introduced but it also failed to move through.

Earlier this year, Delegate Frank Turner, who also represents my district, co-sponsored HB1020 which died after an unfavorable report in the House Environmental Matters Committee.

Meanwhile, Montgomery County passed a law (bill 32-13) which is the first in the state of Maryland to deal with this issue. The law became effective on June 11, 2014.

In my opinion, the current text of bill CB36-2014 is adequate without any well-meaning language that could cause difficulties in actual practice. For example, if it were amended to require a plug in vehicle to be "charging" or "plugged in" that could leave an innocent driver susceptible to a fine or towing if someone unplugs their car without authorization. Time limits for parking can be imposed where necessary to encourage turnover.

I support passage of CB36-2014 as written.

To Whom It May Concern,

My name is Brian J. Ro, and I have been a resident of the Owen Brown village in Columbia since 2009. I want to express my support for CB36-2014. I own 2 electric vehicles (EVs), a Chevy Volt and a Ford C-Max Energi. While I have been thrilled being able to drive over 20,000 gas-free miles since 2012, there has been a persistent issue that I have encountered time and time again. On many occasions I have been prevented from using an EV-designated charging space due to a conventional gas vehicle blocking it. Upon inquiry to store owners or property managers, the usual response received was, "Sorry, we can't do anything as no law is being broken".

The charging stations I frequent most often are located on Columbia Association (CA) property, and during busy times it is almost a guarantee the EV charging spaces will be blocked. The majority of these CA charging stations were at least partially funded by state/federal incentives, so each time an EV owner is prevented from using these spaces as intended is a waste of taxpayer money.

Governor O'Malley is a supporter of EV adoption, signing into law EV purchase incentives back in 2010, and has just renewed these incentives this past July 1, increasing the max excise sales tax credit from \$1,000 to \$3,000, and the EVSE charging station credit from 20% to 50% of the unit cost + installation costs. The governor has also made it a requirement that state greenhouse gas emissions be reduced 25% by the year 2020.

Maryland is part of an 8-state coalition that has pledged to put 3.3 million EVs on the roads by 2015. With these new incentives combined with falling EV prices, EV sales are set to take off in our state.

The time to act is now, so that this parking issue can be resolved before it becomes a bigger problem. Montgomery County has already pass legislation address the EV space blocking problem, and I urge Howard county to follow in their footsteps. This is an issue that should not be punted down the road any more. EVs are not a temporary fad...they are here to stay, and passage of CB36-2014 is simply the next logical step in enhancing EV adoption in Maryland.
