Drafted a letter that became a National Association of Attorneys General letter to the Senate signed by forty-one (41) Attorneys General opposing the legislation. The legislation was defeated.
  - o In 2007, led a five-state coalition to oppose federal preemption of state mental health parity laws in United States Senate Bill 558 - Mental Health Parity Act of 2007, resulting in a revision to the preemption language so that stronger state laws, such as those in Maryland, remain in place. United States Senate Bill 558 passed with the revised preemption language.
- Authored the 2009 Opinion of the Attorney General interpreting the impact of The Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 on Maryland insurance laws.
- Designee of the Attorney General on the Maryland Autism Commission.
