1 **WHEREAS**, Section 404 of the Howard County Charter and Section 6.300 of the Howard
2 County Code provide for the County Executive to appoint and for the County Council to confirm
3 nominees to Howard County Boards and Commissions created by law; and

4 **WHEREAS**, Sections 6.324 and 16.604 of the Howard County Code and Title 8, Subtitle
5 2 of the Land Use Article of the Annotated Code of Maryland provide for a Historic Preservation
6 Commission in Howard County; and

7 **WHEREAS**, the County Executive has proposed the reappointment of Bruno V. Reich as
8 a member of the Historic Preservation Commission; and

9 **WHEREAS**, the County Council ratifies the County Executive's special trust and
10 confidence in the abilities of the nominee.

Licenses: Registered to practice architecture in Maryland

Education: Bachelor of Architecture – University of Maryland 1981, member of Alpha Lambda Delta Honor Society and Phi Eta Sigma Honor Society

Capabilities: Over 30 years of experience as an Architect, developer, and contractor, designing and managing projects of all sizes, preparing construction documents, and supervising field personnel. Summary of Significant Historic Preservation Projects:

- 10106 Hyla Brook Road, Columbia, Maryland -1820 Oakland Manor Blacksmith Shop – stabilized the foundations, walls, and roof so the building could continue to be a single family residence.
- Brooklyn New York – 1884 Carpenter's Gothic Sheepshead Bay United Methodist Church – stabilized and renovated the steeples that had been heavily damaged and in danger of collapse due to termite infestation.
- Church Lane, Ellicott City, Maryland – 1920 American Foursquare – designed a rear addition that was in compliance with the local historic preservation ordinance.
- Union Chapel Road, Daisy, Maryland – 1885 Daisy Schoolhouse – completed As Built drawings that are keyed to the labeled building materials so reconstruction can be completed. Currently reconstruction is underway at the Howard County Living Farm Heritage Museum.
- Route 99, Ellicott City, Maryland – circa 1890 Stackhouse Barn – completed As Built drawings that are keyed to the labeled building materials for reconstruction. The barn has been successfully reconstructed at a private residence in Western Howard County.
- 9120 Frederick Road, Ellicott City, Maryland – 1860 St. John's Episcopal Church – Various preservation projects, notably the recreation of historic scroll work at the peak of the gable and by the cross. Examined historic photographs, prepared scaled design and drawing, and oversaw the fabrication and installation of scrollwork.
- Oakland Manor Road, Columbia, Maryland – Oakland Manor – completed a feasibility study, including cost estimates for the rehabilitation of Oakland Manor.

– Famous Buildings specializes in the design and erection of pre-engineered steel buildings. As founder and president, I started the firm from the ground up, completing sales, hiring and training construction crews, managing crews, and budgets.
