1           **WHEREAS**, Chapter 150 of the 2017 Laws of Maryland (HB150- the Budget Bill for  
2 Fiscal Year 2018) allocated a Special Fund appropriation of \$38,390,961 to the Maryland  
3 Department of Transportation for the purpose of providing transportation grants to local  
4 jurisdictions; and

6           **WHEREAS**, Howard County applied for and received a grant in the amount of \$742,000  
7 from the Maryland Department of Transportation; and

9           **WHEREAS**, the grant funds will be used to resurface County roads in accordance with  
10 Capital Project H2014, Road Resurfacing Program; and

12           **WHEREAS**, Section 609(b) of the Howard County Charter authorizes and empowers the  
13 Howard County Council to make such transfers; and

15           **WHEREAS**, the County has indicated that the funds are available for transfer from the  
16 respective projects.

18           *Section 1. Be It Enacted by the County Council of Howard County, Maryland, that,*  
19 *subject to the provisions of Maryland law, the Howard County Charter, and the Howard County*  
20 *Code relating to the budgetary and fiscal procedures, the amount hereafter specified is hereby*  
21 *approved, appropriated, and authorized to be disbursed for the general County purposes*  
22 *specified and in sums itemized for the fiscal year beginning July 1, 2017 and ending June 30,*


