1 **WHEREAS**, on May 31, 2018, the County Council adopted Council Resolution No. 54-
2 2018 (“CR54”) that sets forth the Fiscal Year 2019 Operating Budget for the Howard County
3 Health Department; and

5 **WHEREAS**, since the adoption of CR 54, the Health Department has been advised that it
6 will receive more funding from the State of Maryland in the total amount of \$1,575,000; and

7
8 **WHEREAS**, funding will be increased by \$75,000 to cover Cost of Living Adjustments
9 for state-funded employees; and

10
11 **WHEREAS**, funding will be increased by \$1,500,00 to account for an increase in one of
12 the Department’s largest grants because a change in vendor resulted in increased costs; and

14 **WHEREAS**, increased funding to the Department will not result in an increase in the
15 total County general fund expense budget for Fiscal Year 2019 because the additional funds are
16 state funds.

18 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard County,
19 Maryland this _____day of _____, 2019 that the Howard County Health
20 Department Operating Budget for Fiscal Year 2019 is amended as follows:

21 Council Resolution No. 54-2018 is amended as follows:

- 22 1. On page 1, in line 9, strike “\$25,143,074” and substitute “26,718,074”;
23 2. The chart titled “Howard County Health Department Budget Fiscal Year 2019” is
24 amended as shown in the attached Exhibit.
