1 **WHEREAS**, the Howard County Charter requires the County Council of Howard
2 County to establish a Charter Review Commission (“Commission”) every eight years; and

4 **WHEREAS**, a Commission last met in 2011; and

6 **WHEREAS**, the Commission’s purpose is to ensure that the Charter is clear in
7 meaning, addresses the needs of contemporary government, and remains a functional,
8 working document that effectively outlines the framework for the efficient operation of
9 County government; and

11 **WHEREAS**, the Council has selected fifteen residents of Howard County to serve
12 as members of the Commission, five of whom have been selected from a list of names
13 submitted by the County Executive, and no more than ten of whom are of the same political
14 party.

16 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard
17 County, Maryland this ___ day of _____, 2019 that there is hereby established a
18 Charter Review Commission to review the Charter, to identify sections of the current
19 Charter that need to be revised, and to recommend changes for consideration.

8 **AND BE IT FURTHER RESOLVED**, that the Chairperson of the Commission
9 shall be Yolanda Sonnier.

10

11 **AND BE IT FURTHER RESOLVED**, that members of the Commission are
12 entitled to reimbursement for expenses incurred, in accordance with County policy.

13

14 **AND BE IT FURTHER RESOLVED**, that the Commission shall submit to the
15 Council, on or before May 1, 2020, a comprehensive written report of its findings,
16 recommendations, and drafts of recommended revisions of the Charter.

17

18 **AND BE IT FURTHER RESOLVED**, that the term of the Commission is 2
19 years.

20

21 **AND BE IT FURTHER RESOLVED**, that the Commission shall establish a
22 schedule of public hearings to be held at various locations in the County.

23

24 **AND BE IT FURTHER RESOLVED**, that the Commission shall conduct
25 meetings in accordance with the Maryland Open Meetings Law.

26

27 **AND BE IT FURTHER RESOLVED**, that any vacancies on the Commission
28 shall be filled by the Howard County Council.

29

1 **AND BE IT FURTHER RESOLVED**, that all recommendations and proposed
2 Charter revisions shall be approved by a majority of the Commission members before the
3 recommendations are forwarded to the Council.

4

5 **AND BE IT FURTHER RESOLVED**, that any minority reports of the
6 Commission may also be forwarded to the Council for consideration.

7

8 **AND BE IT FURTHER RESOLVED**, that the Commission shall adopt or
9 designate, and may modify, rules of procedure to accomplish the charges as set forth in this
10 Resolution.
