1	WHEREAS, the County Council of Howard County, Maryland recognizes that the		
2	need for quality housing units in Howard County for seniors of low or moderate income;		
3	and

5	WHEREAS, Colonial LLLP, a Maryland limited liability limited partnership,		
6	proposes to renovate and operate a senior rental housing development comprised of		
7	approximately 100 units, known as Park View at Colonial Landing and located on		
8	Rowanberry Drive in Elkridge, Maryland (the "Project"), all of which will assist seniors of		
9	low or moderate income as required by applicable law or regulation; and		
10			
11	WHEREAS, the Maryland Department of Housing and Community Development,		
12	either directly or through the Community Development Administration, may provide some		
13	or all of the financing for the Project (the "Project Financing") in order to assist in making		
14	the project economically feasible; and

16	WHEREAS, Section 4-1207(a) of the Housing and Community Development		
17	Article of the Annotated Code of Maryland and Sections 5.05.05.18(11) through (13) of the		
18	Code of Maryland Regulations require approval of the Project and the Project Financing by		
19	the County Executive and the County Council; and

21	WHEREAS, the County Executive of Howard County has approved the proposed		
22	Project and Project Financing and recommends their approval by the County Council.

24	NOW, THEREFORE BE IT RESOLVED by the County Council of Howard		
25	County, Maryland this day of, 2012, that it endorses the Project and		
26	approves the Project Financing in the form of (i) tax exempt bonds in the approximate		
27	amount of \$4,300,000, (ii) an assignment of approximately \$1,058,101 in existing State		
28	loan funds to Colonial LLLP, (iii) a Maryland Rental Housing Works loan in the		
29	approximate amount of \$250,000, and (iv) a 4% low-income housing tax credit		
30	reservation that will contribute equity in the approximate amount of \$1,628,000; and
