1 *Section 1. Be It Enacted by the County Council of Howard County, Maryland, that the*  
2 *Howard County Code is amended as follows:*

4 *By amending:*

5 *Title 20 "Taxes, charges and fees"*

6 *Subtitle 11 "Watershed Protection and Restoration"*

7 *Section 20.1103 "Watershed Protection and Restoration Fee"*

9 **Title 20. Taxes, Charges and Fees.**

10 **Subtitle 11. Watershed Protection and Restoration.**

11  
12 **Section 20.1103. Watershed Protection and Restoration Fee.**

13 (a) The County shall charge and a property owner shall pay an annual Watershed  
14 Protection and Restoration Fee.

15 (b) ~~[[The]]~~ (1) EXCEPT AS PROVIDED IN PARAGRAPHS (2) THROUGH (5) OF THIS  
16 SUBSECTION, THE fee shall be based on the amount of impervious area on a property that  
17 exists annually as of March 1.

18 (2) THE STORMWATER REMEDIATION FEE SHALL BE ONE DOLLAR FOR  
19 NONRESIDENTIAL PROPERTY THAT IS OWNED BY AN ENTITY THAT IS EXEMPT FROM  
20 PROPERTY TAX UNDER § 7-204 OF THE TAX-PROPERTY ARTICLE OF THE MARYLAND CODE.

21 (3) THE STORMWATER REMEDIATION FEE SHALL BE ONE DOLLAR FOR  
22 NONRESIDENTIAL PROPERTY THAT IS OWNED BY A PRIVATE NONCOLLEGIATE EDUCATIONAL  
23 INSTITUTION, AS THAT TERM IS USED UNDER THE EDUCATION ARTICLE OF THE MARYLAND  
24 CODE, THAT IS EXEMPT FROM PROPERTY TAX UNDER SECTION 7-202 OF THE TAX-  
25 PROPERTY ARTICLE OF THE MARYLAND CODE.

26 (4) THE STORMWATER REMEDIATION FEE SHALL BE ONE DOLLAR FOR A PROPERTY  
27 THAT IS OWNED BY AN ENTITY THAT IS RECEIVING A COMMUNITY SERVICE PARTNERSHIP  
28 GRANT FROM HOWARD COUNTY.

29 (5) THE STORMWATER REMEDIATION FEE FOR PROPERTIES OUTSIDE THE PLANNED  
30 SERVICE AREA FOR WATER AND SEWERAGE SHALL BE:

31 (i) \$50 FOR RESIDENTIAL PROPERTIES; AND

1 (ii) \$100 FOR NON-RESIDENTIAL PROPERTIES.

2  
3 (c) *Setting the Impervious Unit Rate.* ~~[[The]]~~ SUBJECT TO SUBSECTION (B) OF THIS  
4 SECTION, THE County Council shall adopt by resolution a schedule of impervious unit  
5 rates.

6 (d) *Method of Calculation.* The fee shall be calculated as follows:

7 (1) Determine the impervious surface measurement in square feet for the  
8 property, rounded to the nearest whole impervious unit.

9 (2) Multiply the property's impervious units by the Impervious Unit Rate.

10 (e) *Determining what constitutes impervious area.* The County shall determine the  
11 impervious surface measurement for a property based on:

12 (1) Analysis of aerial photography;

13 (2) Measurement from approved engineering drawings including, without  
14 limitation, as-built drawings or site plans;

15 (3) Field surveys signed and sealed by a Professional Engineer or Professional  
16 Land Surveyor licensed in the State of Maryland; or

17 (4) Inspections conducted by the Department.

18 (f) *Common Areas.* Common areas owned by a community association or other common  
19 ownership shall be charged based on the total impervious surface measurement of the  
20 common areas as calculated in the manner prescribed in subsection (d) of this Section.

21 The fee shall be either:

22 (1) Billed directly to the community association or manager of property in  
23 common ownership; or

24 (2) If there is no community association or manager of property in common  
25 ownership, the fee shall be divided by the number of owners within the  
26 community association or number of common area owners and added to  
27 the fee for each owner's individual property.

28 (g) *Agricultural properties.* If a property has an agricultural use assessment as determined  
29 by the State Department of Assessments and taxation, the fee shall be based on:

30 (1) The impervious surface measurement only for residential structures and  
31 appurtenances located on the property, if the property has a fully

1 implemented Soil Conservation and Water Quality Plan that has been  
2 approved by the Soil Conservation District; or

- 3 (2) The impervious surface measurement calculated for the entire property, if  
4 the property has not implemented a Soil Conservation and Water Quality  
5 Plan approved by the Soil Conservation District.

6  
7 *Section 2. And Be It Further Enacted by the County Council of Howard County,*  
8 *Maryland, that fee set by this Act shall be applied for Fiscal Year 2014 and thereafter*  
9 *and may be implemented by credits, refunds, or other methods as the Department of*  
10 *Finance determines.*

11  
12 *Section 3. And Be It Further Enacted by the County Council of Howard County,*  
13 *Maryland, that this Act shall become effective 61 days after its enactment.*
