1	WHEREAS, Section 5-105 of the Education Article of the Annotated Code of Maryland
2	provides that a transfer between major categories of the budget of a County Board of Education
3	shall be made only with the approval of the County Council; and
4	
5	WHEREAS, Section 5-105 further provides that if a County Council fails to take action
6	on a written request for a transfer between major budget categories within 30 days of receipt of
7	the request, the failure to take action constitutes approval thereof; and
8	
9	WHEREAS, on or about May 6, 2013 the County Council received a request from the
10	Board of Education to transfer, in the Fiscal Year 2013 expense budget, a total of \$3,740,350
l 1	between categories; and
12	
13	WHEREAS, school system initiatives such as competitive pricing, technology upgrades,
14	and employee training have created an approximately \$1,900,000 surplus in the Utilities
15	program; and
16	
17	WHEREAS, funding is also available in the Mid-Level Administration, Maintenance of
18	Plant and Capital Outlay categories because of vacancies; and
19	
20	WHEREAS, cost savings will be used to cover overtime, substitute teachers, social
21	security, instructional salaries, pupil personnel workers, public information staff, the Harvard
22	Initiative, and contracted budget and legislative services and prefunds Fiscal Year 2014 health
23	benefits, media furnishings, audio visual supplies and growth/replacement equipment; and

25	WHEREAS, the Board of Education has indicated that the funds are available for
26	transfer from the respective categories.
