A RESOLUTION declaring that a total of approximately 18,992 square feet (.436 acres) of real property owned by Howard County and identified as Lots 9 and 36, Parcel 425, Tax Map 50 located in North Laurel, Howard County, Maryland are no longer needed for a public purpose and authorizing the County Executive to waive the advertising and bidding requirements of Section 4.201 of the Howard County Code in order to convey the property to Cornerstone Homes, Inc.; and providing that the County Executive is not bound to convey the property if he finds that the land may have a further public use and submits his finding to the County Council for its consideration.

1	WHEREAS , Howard County is the owner of certain real property known as a Lot 9,
2	Parcel 425, Tax Map 50 containing approximately 9,496 square feet (.218 acres) located along
3	Cissel Avenue in North Laurel, Howard County, Maryland as acquired by tax sale and recorded
4	among the Land Records of Howard County, Maryland at Liber 180, folio 526; and
5	
6	WHEREAS, Howard County is the owner of certain real property known as a Lot 36,
7	Parcel 425, Tax Map 50 containing approximately 9,496 square feet (.218 acres) located along
8	Linville Avenue in North Laurel, Howard County, Maryland as acquired by tax sale and
9	recorded among the Land Records of Howard County, Maryland at Liber 178, folio 78; and
10	
11	WHEREAS, Lot 9 and Lot 36 are shown on the attached Exhibit A and collectively
12	comprise the "County Property"; and
13	
14	WHEREAS, Cornerstone Homes, Inc. has asked that the County Property be disposed of
15	in accordance with Section 4.201 of the Howard County Code; and
16	
17	WHEREAS, the Department of Public Works has reviewed and approved the proposed
18	disposal of the County Property; and
19	
20	WHEREAS, Section 4.201, "Disposition of Real Property", of the Howard County Code
21	authorizes the County Council to declare that property is no longer needed for public purposes
22	and also authorizes the County Council to waive advertising and bidding requirements for an
23	individual conveyance of real property upon the request of the County Executive; and
24	
25	WHEREAS, also in accordance with Section 4.201 of the Howard County Code, the
26	County has offered to various County and State agencies the right of first refusal to acquire any
27	or all of the County Property; and

29	WHEREAS, the County Council has received a request from the County Executive to
30	waive the advertising and bidding requirements in this instance for the conveyance of the County
31	Property to the Cornerstone Homes, Inc.

2	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
3	Maryland, this day of, 2012, that the County Property comprising,
4	in total, approximately 18.992 square feet (.436 acres), as shown in the attached Exhibit A, is no
5	longer needed for a public purpose and may be conveyed to Cornerstone Homes, Inc.
6	
7	AND BE IT FURTHER RESOLVED that, having received a request from the County
8	Executive and having held a public hearing, the County Council declares that the best interest of
9	the County will be served by authorizing the County Executive to waive the usual advertising
10	and bidding requirements of Section 4.201 of the Howard County Code for the conveyance of
11	the County Property to the Cornerstone Homes, Inc.
12	
13	AND BE IT FURTHER RESOLVED that, if the County Executive finds that the land
14	may have a further public use and that the County Property should not be disposed of, he may
15	submit his findings and recommendations to the County Council for its consideration without
16	being bound to convey the County Property in accordance with this Resolution.


