13 Members of the Howard County Board of Appeals shall be paid ~~[[\$4,500.00]]~~
14 **\$5,000** per year plus ~~[[\$90.00]]~~ **\$110** per official public session, up to a maximum
15 cumulative total payment of ~~[[\$12,900.00]]~~ **\$16,125** per year. Members of the Board shall
16 receive reasonable and necessary expenses, as may be provided in the budget.

18 **Section 2. And Be It Further Enacted** by the County Council of Howard County,
19 Maryland, that the compensation adjustments in this Act shall take effect beginning on
20 July 1, 2014.

22 **Section 3. And Be It Further Enacted** by the County Council of Howard County,
23 Maryland, that this Act shall become effective 61 days after its enactment.
