1           **WHEREAS**, Section 610 of the Howard County Charter authorizes and empowers  
2 the Howard County Council to make supplementary appropriations from the unexpended  
3 and unencumbered funds set aside for contingencies in the County budget; and

5           **WHEREAS**, because of unanticipated snowfall, the County has incurred  
6 unanticipated expenses for snow removal since the budget for Fiscal Year 2019 was  
7 adopted; and

9           **WHEREAS**, the Department of Public Works is requesting authorization to  
10 transfer \$1,328,700 from the General Fund, Contingency Reserve; and

12           **WHEREAS**, the Department of Public Works has also incurred unanticipated  
13 expenses for road repairs and is requesting authorization to transfer \$350,000 from the  
14 General Fund, Contingency Reserve to cover those costs; and

16           **WHEREAS**, the Director of Finance has certified that the appropriation to be  
17 transferred is not encumbered and is available for transfer.

19       ***Section 1. Be It Enacted** by the County Council of Howard County, Maryland, that the*  
20 *following supplementary appropriation of funds is authorized and approved for the fiscal*  
21 *year beginning July 1, 2018 and ending June 30, 2019, as indicated below:*


