I am writing in strong support of CB42, to increase the school facilities surcharge that developers pay for new residential construction in the County. The Act proposes to raise the school facilities surcharge fee from the current rate of \$1.32/sq. ft. to \$6.80/sq. ft. In my opinion, the current rate of \$1.32 is woefully inadequate, especially given the rapid growth in the County and the great challenges that the County faces in providing enough quality facilities to educate our children at a time of increasing yearly school enrollment. It is beyond time for developers to pay their fair share to ensure that there are enough funds to build and/or renovate the schools for which so many residents move to Howard County in the first place. I have heard press reports that the developer's trade association, the Maryland Building Industry Association, has called the state law that allows the County Council to raise the surcharge "unconscionable." In reality, CB-42 puts Howard County more in line with what most other Md. Counties charge. In my opinion what is unconscionable is that the developers have been able to get away so long with being charged such a low amount of money to ensure there are adequate educational facilities for the households that they have created.

I would also urge the Council to not add amendments to the bill that water it down or give excessive exemptions. The bill already provides relief and exemptions for senior and affordable housing units.

In the last 15 years, the County has approved a minimum of 24,000 new homes. At this rate, the county has forgone nearly \$530 million in school surcharge fees. The three-year average school surcharge fee in 2017 was less than \$5,500, while the cost of building new schools could be a minimum of \$60,000 per new student.

While the proposed fee of \$6.80 is a step in the right direction, I think the fee can be higher. I urge you to raise the fee to \$8 per square foot. I also urge you to provide no exemptions to any developer. No grandfathering of projects.

Raise the fee now so our school system can get the funding it needs to build schools and students can find the resources they need.

Thank you to Councilpersons Christiana Mercer-Rigby and Deb Jung for introducing the legislation.

Members of the County Council:

I am encouraged by the proposal to raise the county's school surcharge fees to \$6.80 per square foot. Developers find it profitable to build homes in Howard County because of its school system. For 15 years, developers have not only profited from building homes, they have also profited from low school surcharge fees.

School surcharge fees are used to partially cover the cost of new school construction. In Howard County this fee was set at an arbitrary value of \$1.00 per square foot and pegged to inflation.

The fee in 2019 is \$1.32 per square foot- a mere 1.7% increase since 2004. According to the 2018 Department of Legislative Services Report the fee in Montgomery County is anywhere from \$23,062 in so-called "yellow" and "green" zones to \$38,087 in "red" zones - an average of \$30,575 per home, which represents a 10% increase since 2004.

While I think the initially proposed fee goes in the right direction, I think the Developers can afford to pay more. This is why I think the fee should be \$8.0 per square foot.

In the last 15 years, the County has approved a minimum of 24,000 new homes. At this rate, the county has forgone nearly \$530 million in school surcharge fees. This does not include the time value of money or the intangible costs due to stress on infrastructure from deferred maintenance, increased class sizes, interest paid on

bonds, etc. While the cost of building new schools could be a minimum of \$60,000 per new student.

This issue is important to Howard County residents. This is why nearly 2400 of them signed a petition to raise the fees to \$8. The list of signatories and their comments is attached.

Opponents of school impact fees have been spreading a lot disinformation.

Property values will not go up if surcharge fees are raised. Property values increase in the county because of the quality of living- mainly its schools. If the quality of life and schools deteriorates property values will tank and those with means – including developers will move to greener pastures. Those left holding the bag won't be able to support the costs to maintain the infrastructure. So if the intent is to let property prices tank, keep the surcharge fees low.

Affordability will not be affected. Howard County has squandered every opportunity to get affordable housing. The exemptions in Maple Lawn, the zero affordable housing in Down-Town Columbia, the fees-in-lieu, which are calculated based on another arbitrary fee have kept housing out-of-reach for many. This is another false argument.

It will not reduce the supply of homes and the county's revenue. County and state leaders need to disabuse themselves of the notion that homes are a source of net revenue. Each home has associated costs: schools, roads, police, fire, hospital, water, sewer, environmental, bike paths, public transportation.

There is an average of 0.5 kids per home in Howard County. It costs \$15,000 per student to run the public school system. At the rate of 0.5 kids per home, it is unrealistic to assume each home contributes \$7,500 for schools alone in addition to roads, police, fire, hospital, water, sewer, the environment, bike paths, public transportation and so forth.

Let's end the practice of corporate welfare by local jurisdictions and get back to managing the taxpayers' dollars responsibly. The welfare of the county's most effective economic engine is at stake.

So please raise the fee to \$8.0 per square foot and absolutely no exemptions and grandfathering of projects.

Thank you to sponsors of the legislation Councilpersons Mercer-Rigby and Jung, and the co-sponsors, Councilpersons Walsh and Jones.

Dear Members of the County Council:

Developers find it p

rofitable to build homes in Howard County because of its school system. For 15 years, developers have not only profited from building homes, they have also profited from low school surcharge fees.

School surcharge fees are used to partially cover the cost of new school construction. In Howard County this fee was set at an arbitrary value of \$1.00 per square foot and pegged to inflation.

The fee in 2019 is \$1.32 per square foot- a mere 1.7% increase since 2004. According to the 2018 Department of Legislative Services Report the fee in Montgomery County is on average \$30,575 per home, which represents a 10% increase since 2004.

In the last 15 years, the County has approved a minimum of 24,000 new homes. At this rate, the county has forgone nearly \$530 million in school surcharge fees. The three-year average school surcharge fee in 2017 was less than \$5,500, while the cost

of building new schools could be a minimum of \$60,000 per new student.

While the proposed fee of \$6.80 is a step in the right direction, I think the fee can be higher. I urge you to raise the fee to \$8 per square foot. I also urge you to provide no exemptions to any developer. No grandfathering of projects.

Raise the fee now so our school system can get the funding it needs to build schools and students can find the resources they need.

Thank you to Councilpersons Christiana Mercer-Rigby and Deb Jung for introducing this legislation.

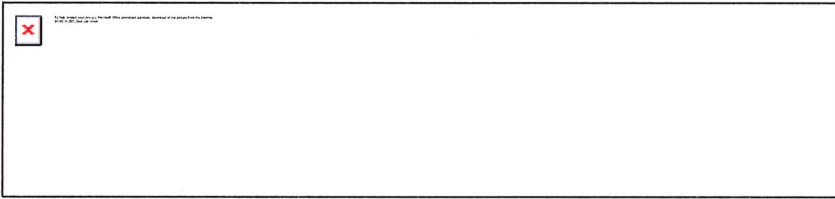

It is clear that HoCo developers have paid far less in impact fees over the years than developers in our neighboring counties - this obviously results in a budget deficit annually for school improvements/renovations, as well as for the critical need for additional schools to be built to ease the current overcrowding in our existing schools. Additionally, as it relates to proposal CR 112, by increasing these much needed school impact fees, those monies could be used more much more productively to support under performing schools and students within them, resulting in the need for fewer students to be moved. I am in full support of of the idea of closing the achievement gap that exists between lower income students and higher income students within the county, but oppose this goal through the proposed method of mass redistricting.

To County Executive Calvin Ball and the Councilmembers on the Howard County Council,

I am writing to express my strong support for the proposed legislation CB42-2019 to increase the school facilities surcharge for developers in our county. This legislation is long overdue and desperately needed to help the county address issues of overcrowding and deferred maintenance. In addition, an increase to the developer surcharge would finally represent a more accurate accounting for the incremental cost of education associated with new residential development in the county. Current rates far underestimate the incremental cost of education of new development and put a significant financial burden and capacity strains on HCPSS.

Howard County attracts a large number of families willing to pay premium real estate prices in return for being able to send their children to HCPSS schools. As a result, developers directly benefit from the great reputation of HCPSS. However, the current developer surcharge does not adequately estimate the incremental cost of education associated with new development. HCPSS is dealing with significant overcrowding issues and deferred maintenance associated with capital funding constraints are a growing problem. Based on current projections and capital planning, these strains are expected to continue to grow and become more pressing in the foreseeable future. The developer surcharge should be covering the brunt of these strains given the direct correlation between increased development and overcrowding in our school system.

The current fee structure and especially the current assumptions on number of children per apartment are inadequate and do not even come close to presenting a realistic estimate of the number of students added to HCPSS as a result of new developments added. It is critical that zoning approvals are based on more accurate estimates of the incremental cost of education put on HCPSS as a result of development approvals granted. The developer surcharge needs to account for the need to build more schools and expand existing schools in order to accommodate additional students added into the system as a result of development activity.

Apart from building the new High School #13, it is critical that the county move forward with the Hammond High School Renovation and Addition and the Talbott Springs Elementary School Replacement projects without further delays (see Superintendent Martirano's FY21 Capital Budget & FY22-FY26 Capital Improvement Plan). The additional revenue from an increase in the developer surcharge would provide the county with much needed funding to support these critical capital projects.

If the county does not adopt the proposed legislation to increase the developer surcharge, the County risks damaging the excellent reputation of our school system as overcrowding continues and worsens and as deferred maintenance issues due to lacking capital budget funding accumulate over time.

I urge the Council to adopt the proposed legislation CB42-2019 or similar legislation that will require developers to cover a larger share of the incremental cost of education that results from newly approved developments. Support our students, teachers, and families by creating a more equitable fee structure.

Dear Councilwoman Rigby:

The topic of school construction, funding, and development has been permeating throughout Howard County for the better part of two years. The subject has impacted the Adequate Public Facilities Ordinance (APFO) resulting in the extremely stringent policy we operate under currently. On August 23, the Council filed CB 42, which if passed, would raise the fee to \$6.80 SF, an increase that would make Howard County the highest in the state and increase the price of an average new housing unit by approximately 4% (\$28K). Proponents will cite the fact Howard County's current fee is significantly less than neighboring counties. What is not stated is that not all counties calculate their funds the same. Some, like Howard County make the assessment on the square footage bases while others on the number of units. Besides the surcharge, Howard County assesses fees for roads and Moderate-Income Housing Units (MIHU) whereas other jurisdictions have lump sum fees.

Beyond fee calculations, the Chamber is concerned that the proposed legislation will impact future development and housing affordability which impacts roads and talent attraction when employees are forced to live a significant distance from work. Specifically, it impacts those in the middle-income housing bracket (\$300K - \$500K) as the average new home in the county is \$700K. This leads to our next concern in that this is a regressive tax that disproportionately increases housing cost for those on the lower end of the cost spectrum.

Previous concerns aside, the Chamber is also concerned in that there has been not been a publicly released fiscal analysis further justifying the \$6.80 fee and the corresponding \$150M anticipated revenue figure.
