In the last 4 years, our numbers have jumped from 6 ensembles totaling around 450 students to this year when we now have 9 ensembles totaling over 600 students, roughly 3/4 of the total school population. We currently only have 1 large and 1 medium sized rehearsal room. We have been forced to utilize the Park and Rec. room but since that technically is not our room, we have to strike the room every day and reset the next morning (which takes away from instruction time) so that Park and Rec. can use the room in the evening. This is just one example across the county and while I know it's not the largest priority, it does emphasize the need.



Dear Council Members:

I am writing to express my dismay over testimony relating to CB42- 2019. I strongly support the long overdue proposed increase of developers' fees, however I have the following concerns.

First I resent having the issue diluted once again with arguments about affordable housing. As a previous founder and director of a nonprofit organization I am as attuned to the needs of the disadvantaged as much as anyone. However, I feel the argument regarding affordable housing has one gaping hole. I hear repeatedly that the objective is to provide housing for those already residing in Howard County who are struggling. Isn't it true that we have nothing in place to guarantee that any affordable units being built (and potentially exempted from the developer fee) have any mechanism to assure that they will not, instead, go to individuals or families NEW to Howard County?

I would like to give you an observation from personal experience. At the North Laurel Senior Center I interact with several residents of a subsidized senior housing project in Emerson. From getting to know four of the residents better I was surprised that the facility appears largely occupied by persons who did <u>not</u> originally reside in Howard County. Two acquaintances had been living previously in the City of Laurel (Prince George's County) and one in Maryland City (Anne Arundel County). The one occupant from Howard County indicated she 'gave' her home in Oakland Mills to her son and then was eligible for supported housing at the Emerson facility. There certainly are seniors resident in surrounding North Laurel and Savage who I believe should have had preference for these units. Without a mechanism to limit occupancy of 'affordable units' (whether low or moderate income) to those currently residing in Howard County, I feel it is disingenuous to continue to use this developer scripted ploy to avoid paying a fair share for adequate public facilities. [I realize that the legislature exempted senior low income units, but this is what I can report from personal experience. If there IS a mechanism for restricting our other forms of "affordable" housing to current residents I'd love to be corrected.]

Why am I not in support of providing "affordable" units with no or reduced builders' fees for newcomers? Simply put, like many I believe one can't always have—or expect-- immediate gratification. When my husband and I were starting out I'd have loved to live and work and raise a family in Montgomery County. It wasn't in our budget so we <u>chose</u> not to struggle with living beyond our means and settled in Prince George's County instead. Over 19 years, employed in public service, we went from a garden apartment to a luxury high-rise to purchasing a town house, then a second, before getting the single family home we desired with the birth of a second child. Later we were able to build our own home in Howard County. During most of this time, while prices and salaries were lower, mortgage rates were MUCH higher, not making today's experience all that different. What is different, is that <u>every</u> unit being built in HoCo is a "luxury" unit involving luxury level costs!

I also bristle at hearing that "increases in developer fees will make housing '**unaffordable**' to more people." If we continue to add more people without greater financial participation from developers toward public facilities, I fear HoCo will become '**unlivable**.' I chuckle when developers threaten that if fees increase, they may stop building in HoCo. Don't they understand that that is exactly what many would like to see happen? We need a slow down to attempt to catch up on infrastructure needs, especially schools and roads.

Howard County has dug itself into a huge financial hole by facilitating development while ignoring public facilities. We simply cannot afford to exempt the fees on 'affordable' housing or to grandfather out developments in the pipeline. It's bad enough that there is not sufficient data to support estimates on the percentage of school attendees generated from new

vs. older housing, nor for that matter justification of how students from new homes are counted. While not perfect, I urge you to pass the bill as written and reevaluate in 2 to 3 years.
