Deb,

I sat down a bit ago to write you about the resolution you cosponsored on trying harder to integrate the schools. By the time I finished I decided to send it to the paper, too. So you may see it more than once. Here it is.

I fully support the intent of the resolution sponsored you have , which is to optimize the educational achievement of all the students in our public schools.

For many reasons I need not list, students do not thrive as well if there is too high a concentration of FARM students in a school, and it is laudable to take reasonable measures to integrate the schools socioeconomically. If there are situations where this cannot be done reasonably, e.g., it would require significant busing or splitting a coherent neighborhood between two schools, then extra resources may need to be devoted to schools with a higher concentration of FARM students.

My concern arises because of the inclusion of the racial integration objective. Racial segregation is no longer legal in the US. Although my neighborhood is predominantly white, I have neighbors of MANY ethnicities, and I see the kids playing together, socializing, and truly integrating. My friends also come from a variety of ethnic and racial backgrounds. I have not seen statistics on the subject, but I suspect that minority children from my neighborhood do as well in school as their white counterparts (although probably not quite as well as the Asian kids do!). I strongly suspect that the disparities in achievement come from socioeconomic differences and not racial ones and that socioeconomic integration should address the issue of achievement. In addition, since socioeconomic level is correlated with race, this would also increase racial integration.

Another difficulty of discussing racial integration in a county like Howard is how we would categorize race and distribute the students. First of all, there are a LOT of mixed-race families in our county. How will we categorize the children? Second, there are MANY races in the county: white, black ...and then it gets complicated. What about a student named Garcia whose family has been here for four generations? And "Asian" certainly is too broad a category. We have a lot of Koreans, Indians, Pakistanis, Chinese, Thai, Vietnamese, and so on. These folks all come from rich and different cultures. How nuanced is this racial classification to go? Are some races more worthy of integration than others?

My conclusion is that we will be able to accomplish more if we try to integrate by socioeconomic level than by color and that by doing the former we will achieve a lot of the latter.

Dear Ms. Jung:

Thank you for all that you do. Please support my effort to have the school board reconsider school reassignments that will be harmful to children on both sides.

My daughters have made wonderful friendships with a diverse group of students that have enriched their lives and educational experiences. These relationships will be harmed if they are required to move. I also believe that changing the schools in the manner proposed fails to address facility utilization, equity, and farm program distribution in an equitable manner. We love our community and want to remain a part of it.

Removing students from CMS and moving others to CMS is not done solely to help utilization. Additionally, CMS has a proposed utilization of 95 percent after adding students from other schools to CMS. This shows that many students could be left at CMS without harming utilization, especially if others are not swapped in.

Changes appear to inequitably reassign CMS students. The test score differential after moving CMS students and Harper's Choice students shows substantially greater disparity than with any other school reassignment by double. Such score differentials will make such transition harmful to both Harper's Choice and CMS students. More importantly, moving a child for the purpose of increasing test scores is unethical.

Please work to find another solution to creating equity in schools that does not require student reassignment and does not move students unethically to increase test scores. I would like to help be part of a solution, but strongly oppose this solution.

Can you and other Ho Co Council members work to change the Md School Rating system?

It can easily be shown that as the percentage of students who live in poverty at a school increases, average school test scores decrease. Unfortunately, children who live in poverty often fall in the academic gap and do not perform as well as students who come from affluent families. This gap has been persistent for 40+ years and, as far as I know, a solution has not been found anywhere in the country. A school is not performing poorly simply because the school has a larger percentage of students who live in poverty.

In my opinion, the current MD School rating system is a form of de facto segregation. I emailed Delegate Eric Ebersole about this issue and he is supportive of the rating system. If education interventions that close the education gap have been identified and proven, a school failing to apply such interventions should be considered poorly performing and should be penalized. My eldest son graduated from WLHS last May and my younger son will be a sophomore there this fall. Wilde Lake High School is not a poorly performing school, yet the MD School rating system labels it as being poorly performing.

Dear Council Member,

As an educator with going on 25-years experience in public education, I wholeheartedly agree with your desire to close the achievement gap between racial and socio-economic groups in Howard County.

I have studied the HCPSS Superintendent's redistricting plan in great detail and have considered all of its aspects.

Although your resolution and his plan have noble, well-meaning goals, I fear that the Superintendent's redistricting plan will not achieve the goals it intends and very well may cause more harm than good.

First of all, the plan will disrupt too many communities, bussing students from their communities to other communities with minor "improvements" in socio-economic disparity. There appears to be an increase in movement (over 7,000 students) to create only a minor increase in socio-economic diversity. See the data in his plan.

In addition, residents I've spoken with who live in communities in and around River Hill and have children who may be redistricted to Wilde Lake fear a loss in their property value, which is an unfortunate but all-too-real concern. Residents I've spoken with in sections of Atholton's district fear the same result as the percentage of FARMs students will grow from 10-25% as a result of the redistricting plan. Again, the loss of property value is an unfortunate, yet highly likely consequence. I'm sure there may be similar concerns in other communities affected by the plan. People who have chosen to live in communities and make 30-year mortgage investments are having their life decisions undermined in one fell swoop by a well-meaning but ill-conceived redistricting plan.

Secondly, there is an assumption that moving low-performing FARMs students to high-performing schools will suddenly improve their performance. The teachers at high-performing schools are no more effective than those in low-performing

schools. I have taught in low and high performing schools and have approached the same energy, attention, and love to all of my students. Unfortunately, the efforts with all of my students did not reap the same results on standardized test scores. I drew and still harbor the conclusion that more resources in and—I cannot understate—out of the school would have helped my students in low-performing schools. Money for community tutoring centers and homework assistance would help greatly.

Furthermore, many FARMs students attend schools that receive Title I funds, which support liaisons, homework assistance, and a myriad of other resources for them. When they move to a high-performing school, they will lose those supports due to a loss of funding. I am certain that supporters of this redistricting plan would not approve of this unforeseen but all-too-real consequence.

I have personally witnessed students experience this unfortunate transition in HCPSS schools, and they find themselves less supported and successful—not as the result of the teachers in their new schools—but as the result of less support due to funding limitations in their new school.

If the County Executive, County Council, Superintendent, and the Board of Education really want to legislate and implement real, effective change for our county's needlest students, they should not disrupt the entire make up of school districting but rather invest even more resources in the schools that need them. The cost in transportation to move students could be best used paying for tutors in the community centers of our needlest children.

Low-performing schools would benefit from community outreach programs that could assist parents as much as students. Parents spend more time with their children than teachers do; however—in my experience—many parents do not have the resources and knowledge to assist and advocate for their children. HCPSS community centers with translators and free or discounted tutors would be an incredible service to our struggling students and their families.

I fear that if the redistricting plan is approved and implemented, our neediest students may very well suffer in their new school communities. As a result of receiving less support, as well as competing against higher-performing students, their academic achievement may suffer and the achievement gap, which we all want to close, will unfortunately widen.

There is potential that high-performing schools' testing, performance, and graduation rate data will also suffer, resulting in low performance in traditionally high-performing schools and the overall performance of the school system as a whole.

Let us certainly do something not only to close achievement gaps but also support our neediest families. Please reconsider your resolution as it will not bring equity but further disparity to our great county.

In the spring of 2019, the Superintendent presented two viable redistricting plans that move less children, address overcrowding issues, and maintain existing school communities. Let us urge him to select one of those plans and then earmark funding for his new plan's increased transportation costs to fund academic and parental resources to the communities that need them.

Please consider my suggestions as an educator, a longtime resident of Howard County, and a taxpayer who would like to see our tax dollars spent to enact effective, not cosmetic, change and help facilitate true equity.

The Superintendent's redistricting plan is an attack on the Howard County education system. If implemented, it will greatly reduce education outcome across the county. Here is how:

The plan will remove many students from the schools closest to their home and send them to the ones much further away. Below are a partial list of the schools that will suffer the most:

Middle Schools:

Lime Kiln MS: More than half of the attendance areas are closer to Clarksville MS/ Hammond MS

Bonnie Branch MS: ~ half closer to Elkridge Landing MS/Oakland Mills MS

Dunloggin MS: ~ half closer to Patapsco MS

Oakland Mills MS: ~ 1/3 closer to Ellicott Mills MS/Dunloggin MS

High Schools:

Atholton HS: > half closer to Hammond HS

Wilde Lake HS: > 2/3 closer to River Hill HS/Centennial HS/Glenelg HS

River Hill HS: > 1/3 closer to Atholton HS/Reservoir HS

This will increase the education barrier for numerous students across the county by greatly increasing their travel distance and time between school and home, and will hurt their education outcome in multiple ways.

First, the redistricting plan will force many students waste more time on the road. For example, my home is only 5 minutes away from River Hill HS. The Superintendent's plan will send my kids to Wilde Lake HS. The travel time will be at

least 30 minutes by bus. For each of my two children, that's a 5-hour increase in bus time just for attending school each week. For each after hour event in school that they need to attend, both parents and children will have to waste another hour on the road.

The Superintendent's plan will harm students across the board regardless of their family income. But those receiving Free And Reduced Meals (FARM) will suffer disproportionally more, even though the Superintendent claims the plan is intended to help them. This is because they too will have to face the increased education barriers created by increased travel distance between home and school, but it will be more difficult for their families to find the time and resources needed to overcome such barriers. Therefore it will be especially difficult for these students to attend after hour activities in school, which typically requires parent support.

The redistricting plan will force the county to spend more money on school buses to cover increased travel distances between home and school across the county. Given a fixed budget for the county's education system, the increased school bus cost will have to come from funds that would otherwise be available to support real education programs.

Howard County has an excellent education system. Our students, teachers, and the schools have done a great job towards achieving the education outcome the county enjoys today. However, if our students are forced to spend more time on the road and hence less time for study, and the county has to spend more money on school buses and hence less for education programs, our education outcome is doomed. This is exactly what the Superintendent's redistricting plan will lead to. It must be killed before the harm is done.

Ms. Deb,

I am an incoming freshman at River Hill High School, and I would like to express my disappointment towards the new redistricting plan. I believe that simply shuffling students around schools will not solve the issue of segregation in schools, and will instead negatively impact the students' daily lives.

In the area where I live, it takes approximately five minutes to drive to my current school. However, if I were redistricted to Wilde Lake High School, it would be five times the length. This would result in me having to wake up much earlier to catch the bus and spending more time getting to and from school, which could lead to sleep deprivation. I would also have less time to study and do any other extracurricular/after school activities I am doing. And as a person who is already deeply involved with activities outside of class, this would make it much more difficult to have an efficient schedule. Plus, this would limit the number of after school clubs I can join because my parents would have to drive 25 minutes just to pick me up.

Being forced to transfer schools after only one year can affect my education and my personal life. I would be separated from the friends I made and would have to adapt to a completely different school environment. For many kids, moving to a new school can be terrifying and extremely challenging. It does not make sense to put them through this whole experience another time when they could be attending the school they have already adjusted to.

I understand the reasoning behind this plan, but I think that it is not the way to solve the problem. In order to give students an equal chance at a good education, more money should be put towards improving the quality of all students' learning experiences, rather than moving them around in circles. By sending kids to different schools, it is improving some students' schooling, but also getting rid of other kids' opportunities for higher education at the same time.

I would like take a moment to introduce myself. My name is Micah Hart, I was born at Howard County General Hospital, have lived in Howard County my entire life, and work in Howard County. I went to Jeffers Hill Elementary School, Owen Brown Middle School (now Lake Elkhorn Middle School), and Oakland Mills High School. I have 3 children that go to Howard County Schools, my daughter Carly (7th grade), my son Max (4th grade), and my son Ace (1st grade). Growing up in Howard County, we never had this threat of redistricting. Now, it seems like this is something that happens without any thought to the communities that it is affecting. My daughter has gone to 3 different elementary schools, and now she is at threat to go to 2. different Middle Schools, and the High School she is now being presented to go to would include less than 1% of the students that she has been going to school with for the past 5 years. My daughter, Carly Hart is very shy, and I am afraid these potential moves could cause long lasting mental and emotional damage to her, and to the thousands of other children that would be affected by Dr. Martriano's plan. Mental health of our children needs to be the top priority, and sadly it hasn't been. I am a great example of the types of relationships that can be built when communities aren't torn apart. I have 2 best friends that live nearby in Howard County. All 3 of us went to Jeffers Hill ES, Owen Brown MS, and Oakland Mills High School together. I can promise you, we wouldn't be best friends to this day if our community was torn apart, like the current redistricting plan is presenting.

Our community, Chapel Woods, but you refer to it as polygon 1185, is .6 miles from River Hill HS, with almost no traffic. Our Elementary School is Clarksville Elementary, which isn't being redistricted, but shares an entrance with River Hill High School. If there were adequate sidewalks, we would be considered walkers to River Hill HS and Clarksville Elementary School. Chapel Woods is at threat to be moved to Wilde Lake HS, which is almost 6 miles away, and the way to get there is loaded with traffic and stop lights. Kids wake up too early as it is to get to High School, and now we are at threat to have to wake our kids up 30 minutes earlier to bus them into another city and community to go to school. It makes no sense. If we have all of this extra

money to bus children around, maybe we could use the funds to send High Schoolers to class an hour later. These later start times have proven success in increasing test scores and increasing graduation rates.

We eat, shop, and socialize in the Clarksville and River Hill community. Our 3 kids are very active in sports and afterschool activities. With 2 parents and 3 kids, and significantly increased commuting times projected in the future, I can guarantee that our children's participation in these activities will decrease. I can only imagine the hardship you would be placing on single parent households that don't have a lot of discretionary time to commute to these activities, or extra income to spend on gas and car maintenance.

Chapel Woods "Polygon 1185" doesn't have a lot of students in it. We have 26 students at Clarksville Elementary, 22 students at Clarksville Middle School, and 22 students at River Hill High School. All 3 schools were underutilized during the most recent feasibility study. Given these facts, being .6 miles from River Hill HS, and the items above, can you please remove "Polygon 1185" from the area's being redistricted?

As a school system, we need to help all children. If in helping 2000 kids, we hurt 5000 kids, nobody's goals are accomplished. We need a plan that helps everyone!

Thank you for all that you do. Please support my effort to have the school board reconsider school reassignments that will be harmful to children on both sides.

My daughters have made wonderful friendships with a diverse group of students that have enriched their lives and educational experiences. These relationships will be harmed if they are required to move. I also believe that changing the schools in the manner proposed fails to address facility utilization, equity, and farm program distribution in an equitable manner. We love our community and want to remain a part of it.

Removing students from CMS and moving others to CMS is not done solely to help utilization. Additionally, CMS has a proposed utilization of 95 percent after adding students from other schools to CMS. This shows that many students could be left at CMS

without harming utilization, especially if others are not swapped in.

Changes appear to inequitably reassign CMS students. The test score differential after moving CMS students and Harper's Choice students shows substantially greater disparity than with any other school reassignment by double. Such score differentials will make such transition harmful to both Harper's Choice and CMS students. More importantly, moving a child for the purpose of increasing test scores is unethical.

I also encourage you to be involved with the school system's public input process. Here's more information:

The Board of Education is scheduled to hold three public hearings to gather feedback from the community. Members of the public may only attend the session associated with the region in which they live based on the School Locator. Members of the public who wish to testify but cannot attend a public hearing may submit testimony via email or USPS mail.

On June 13, 2019, the Board of Education voted to suspend electronic registration for the redistricting public hearings only. Community members will need to call the Board Office at 410-313-7346, 1584 or 7194, or appear in person at the Board Office (10910 Clarksville Pike, Ellicott City, M-F, 8 a.m.-4:30 p.m.) to pre-register to speak. Note, **registration to speak will not be permitted at the meetings**. The Board also recommends organizing into groups to allow for all communities to be heard. An officer/leader of a group may register up to five individuals to provide testimony on behalf of their organization/community.

As of September 9, the Board has added additional spaces for students who wish to testify. (Student slots previously were limited to 10 per hearing.) Students will be permitted to testify at the beginning of the public hearing, followed by members of the general public in order of registration.

All public hearings will be held in the Boardroom at 10910 Clarksville Pike, with satellite rooms available for overflow. The order of community members will be posted on BoardDocs the day of the meeting. Speakers are to check in at the registration area to receive further direction regarding the process for the evening.

I'm writing this letter to express my extreme disappointment over the proposed school redistricting plan by the School Superintendent. The proposal is not just flawed but completely misses the mark by focusing on the wrong goal. The goal of any public school is to improve educational opportunities and outcomes for students. However, this proposal, by focusing on FARM numbers, does not create equality of opportunity, but rather redistributes it. By sending children from River Hill High School to Wilde Lake High School, you effectively remove the opportunity that many families relied on when they moved to this area. Not only does the redistricting remove opportunity, but it also increases the commute for students. For many families being redistricted, the drive to River Hill takes less than five minutes. Under this proposal, they will be forced to drive 20-25 minutes to Wilde Lake. This increased drive time will deeply impact after school learning opportunities for children and generate work-life balance issues for the parents who take them to school.

Some will make this proposal, and any associated protest about race and thrive on dividing our community and county. I hope that doesn't happen, as this is not about race or about denying underprivileged children a great education: it is about uprooting families and denying certain opportunities to some while giving them to others. A better way to address these issues would be to add resources to other schools or share what River Hill School has to offer- without uprooting existing families.

Howard County's school system has been a primary driver for families to move to this area. This proposal will achieve limited gains at best to improve educational opportunity but will cause much unnecessary damage in the process. I hope we can avoid this. I request you to shelve this proposal and start again, but this time with the right goal.

Dear Councilmen and Councilwomen:

I am writing to you in opposition to CR112-2019.

I know some people has been having private conversations with Superintendent Martirano and some of the council members, as well as County Executive, thinking that there is a MYTH regarding why some of Howard County schools performs better than the others even though all of our schools provide the same resources.

If this is really a MYTH to those people, then let me explain. Most kids from better-performing schools not only work on homework assigned by the school teachers, they work on extra homework assigned by their parents and usually on above-grade subjects. They seek more challenging learning experience outside of what our public schools are offering with the guidance of their parents.

The performance of a school is simply a reflection of the average of the students performances, how much effort they've put into learning, and how much effort their parents have spent on their kids' education. There is no MAGIC from the schools! Even if you mix up the students to accomplish the same FARM rates and made the school average appear the same, that doesn't mean the FARM students have been lifted up individually. It would only mask the problems and needs from those FARM students.

Instead of spending more BOE budget on busing kids around, and adding more commute to our kids' daily lives, wouldn't it be more efficient to encourage the parents to spend more time on their kids' education at home? Perhaps pay for a learning program such as IXL, which by the way only costs \$25 a year per student or have the kids visit a free learning website, such as Khan Academy, to do some extra homework like the other hard-working students.

I grew up in southwest area of China, one of the poorest provinces called Guizhou. I did not go to fancy schools that have great resources. My family did not own cars when I grew up. My parents did not go to college either due to the notorious Culture Revolution in the 70s. But my parents have always made time to help me with my schoolwork with their best abilities, and taught me to earn the things I want in life through hard work and perseverance. They did not try to bus me to a better school in the city. Yet I made it to the best university in China.

My point is that it's not the county government or the so-called "wealthier kids" who can help lift the FARM students, it's the PARENTS!

Personally, I don't mind having FARM students in my kids' schools, but not at the expense of busing kids around and breaking up the communities we live in. I did a little research by studying Howard County's Zoning map and history. It's not news that roughly 60 percent of land in Howard County is dedicated, protected for rural uses, which is located on the Western Tier of the county. That leaves the remaining 40 percent of the county lands shifting over time from suburban to focused, mixed use nodes, that are mostly the Eastern portions. I wondered why there is such a clear divide in zoning. So I found out about the Agricultural Preservation Program to the Western Tier for agricultural preservation, leaving the Central (Columbia/Ellicott City) and Eastern portions in a priority service area for denser development. Then, County wanted affordable housing. Where can we put them? Of course, only in the Central and Eastern portions of the land. Then what does that to the schools in these areas? Overcrowding, high percentage in FARM students and etc.

It looks to me the problem was created due to years of poor planning by the county council and the planning board, how is it fair for the county council to rely on BOE to solve the problem by busing kids around? With already limited budget this year not meeting the demand, the council expects BOE to spend more money on school buses and cut other educational programs?

The better solution should be to look into the future planning and zoning strategies, and mix up and spread out developments better and not concentrate certain types of dense development all in one place.

CR112 is certainly not the solution! Please vote Nay to CR112-2019. Thank you!

If you are curious with some background information as to why the Superintendent has disregarded HCPSS's 2019 feasibility study (https://www.hcpss.org/f/schoolplanning/2019/2019-feasibility-study.pdf) with the Attendance Area Adjustment Options, and came to their own drawing board to balance the FARM students, you can look at the 1-min video attached with a speech from Larry Walker at Celebration Church recently. For the record, here is the text of his speech:

"I served on the superintendent's Attendance Area Committee. I sat privately with the Superintendent. And as a committee, we said we need to make some tough decisions that bring about equity to our school system. We have a handful of schools that are overcrowded with challenging circumstances. And yet we have other schools that have a whole lot of empty seats and a whole lot of folks that have resources to provide the kind of resources to provide the kind of educational benefits and training for their children. So my challenge to the superintendent was: make some tough decisions, move some of these kids, spread it around to more schools and allow them to get the kind of support that is available in all the schools because all of our schools are great schools. Let's get rid of the myth that certain schools are better than the others. So I put together a sheet of action items, I am asking Celebration Church to join me in. We have a partnership with the school system and the superintendent is looking for brown people to show up and put our voices behind this plan that he came up with, which is a bold plan and the community is hating him right now. So he needs some allies."

The Attendance Area Committee was hand picked by the Superintendent this year instead of going through a public interviewing process like two years ago. It is so disturbing for me to find out that the Superintendent just made this kind of school boundary recommendations based on one group of people's interest alone. I am also shocked that they could just do this behind closed doors.

As I stated before, he is mistaken when thinking some schools provide more resources to their kids. It's the Parents, not the schools. If any schools are provided with more public resources than the others, I believe it's the schools that have higher FARM rates that receives more funding and resources.

If balancing FARM students becomes a required factor in the future school redistricting, Dr. Martirano's plan is just a preview of what's going to happen in the future redistricting process if CR112-2019 passes. I can give you many examples of polygon moves that make no sense from his plan. But I don't want to crowd this email. Discussing any particular polygon moves is not my purpose here. I hope the County Council look at a broader picture. The zoning map has contributed to such segregation in our school systems. Agricultural Preservation Program is a major factor to the current zoning ordinance and helped to concentrate the development to the Eastern Portion of the county. To force spreading FARM rates will definitely trigger major busing operation throughout the county. Even CB42-2019 will not cover any future BOE budget shortfall.

Even though you sponsored CR112, I hope you give it a second thought after you consider all these factors.

Hi Alice, Thanks for reaching out to me with your concerns and ideas. The County Council is not directly involved in the decision-making of reassigning individual polygons. I completely agree with you that there are many examples of polygon moves that do not make immediate sense. The Council does not have the background information as to why certain polygons were moved.

Your recommendation for FARM students to access at-home resources is a good one and is already a component of learning supports at most schools. In this case, the solution is probably multi-faceted. You also raise a good point about busing. How much will it cost to bus kids and how will that affect the overall school budget? The Council has not yet been provided that information from the School System but it is an important component.

The intention of the resolution is to address increasing disparity in the County that cannot be resolved through land use and zoning decisions alone. Ideally it will result in better coordination and communication between the two government bodies (the County and the School System). I don't think we've reached that point yet.

While Dr. Martiranos plan is just one iteration of a lengthy process, I have faith in our Board of Education to consider the feedback of all who choose to provide input, and to do what is best for the children of Howard County. I encourage District 4 residents to keep an open mind, be involved in the process, and work towards civility and understanding of the various factors involved in the School Board's decision-making process

Regardless whether one believes that the stated goal of leveling FARM scores across the county schools is going to remediate systemic geographic housing and income disparities somehow improving educational outcomes for lower socioeconomic students, the specific plan for the FES to LWES Assignment Area (AA) change is both fatally flawed and in violation of the HCPSS' own stated policy (Policy 6010).

As you will see in the attached slides that I presented to well over 100 angry Maple Lawn residents on the evening of August 27th, 2019, an objective review of the Superintendent's proposed FES to LWES AA change relative to HCPSS Policy 6010 Section IV Standards reveals:

- Subsection A: An AA change consideration is warranted but only for FES due to overcrowding.
- ▶ Subsection B1 (Facility Utilization): The proposed AA change violates efficient utilization standard by creating overcrowding at LWES without ultimately reducing overcrowding at FES. One overcrowded school becomes two overcrowded schools.
- ▶ Subsection B1 (Facility Utilization): The proposal violates the fiscal responsibility standard by increasing facilities cost at LWES without counterbalancing cost reductions at FES and increasing transportation costs.
- ▶ Subsection B2 (Community Stability): The proposal fails <u>all three</u> stability factors (feed percentages, contiguous attendance areas, move frequency) and creates a new "island" school at LWES.

- ▶ Subsection B3 (Demographics): The proposal's own predictions show it does nothing to improve performance on racial composition, academic performance, or ESOL metrics.
- ▶ Subsection B3 (Demographics): The proposal predicts only a marginally improved FARM score at LWES which won't substantively change the socioeconomic makeup of the school.
- ▶ Subsection B3 (Demographics): The Superintendent's proposal results in 140 FES students uprooted from their neighborhood school, worse facilities utilization, worse transportation costs, worse community stability yet impacts demographics at LWES so minimally as to have no effect on student outcomes at LWES as evidenced by the Superintendent's own predictions.

I would posit that the Superintendent's proposal will be a failure for the HCPSS countywide with deeply negative political implications for the BOE, the Superintendent and any other elected official trying to foist this scheme upon the homeowners of Howard County. The BOE should not be carrying the water for the Howard County Council's failure to reign in developers run amok over the last 20 years by trying to paper things over with HCPSS FARM scores. Therefore, I implore you to contact the HCPSS BOE to let them know that your constituents think that it is advisable for them to reject the Superintendent's Attendance Area Adjustment Plan at both the preliminary and final decision votes on November 18th and 21st 2019 respectively.





Councilwoman Jung,

I am writing to express my extreme displeasure with the portion of the Superintendent's redistricting plan related to Maple Lawn Polygon 1256. You may not have heard a lot about discontent in Maple Lawn so far, and that is not because we like the plan. It's also not because we don't care. We had hoped to differentiate ourselves from the rest of the county because it appears a lot of those conversations are becoming toxic.

I DO NOT want to focus on the value of FARM equity. I also DO NOT want to discuss why if every HoCo school is excellent, then there is a need to balance FARM scores rather then spending time, money and resources on specific needs at specific schools. That is not our focus.

My focus is that Maple Lawn is unlike a lot of other sections of HoCO that contain several polygons. It's a single community, approved by the Howard County Planning Board as such, and we live day to day as a unified community literally surrounding the school. We share mailboxes, green spaces, playgrounds, community center, and a walking path to the schools. This plan cuts out a portion of this tight-knit community to be redistricted away, isolating Maple Lawn children from each other.

My focus is also on the illogical distances. There are eight closer schools to Polygon 1256. We would become an island 5.4 miles off shore. Our commute time will triple, and opportunities to participate in activities at our children's school would significantly decrease. Maple Lawn children would pass by several other Elementary Schools as they travel over two highways to Laurel Woods. Maple Lawn children would pass former schoolmates traveling west, as we travel east on route 216 on a daily basis. The children they pass are from polygons also with 0% FARM.

My focus is also on capacity. The superintendent's plan related to polygon 1256 has my children leaving one overcrowded school, to stuff another school to 115% capacity. That hurts my children, other Maple Lawn children, but

more importantly, the children at Laurel Woods. All of a sudden, their classes go from 20 children, to 30+. Is that fair to them?

My focus is also on the goals from the AAC, Community Sessions, and Online Responses from slide 9 of the Superintendent's presentation. Each one stressed "Neighborhood schools, walkable distances" or "Limit student travel time." My children cannot walk 5.4 miles across two highways. They could walk, and have walked the approximate mile to our current neighborhood schools. Travel time increases tremendously for my children and for my family when participating in school related functions. "Boundary continuity" is also not achieved. Our boundary with Fulton Elementary is broken. The boundary option to the north of 1256 is ignored. The boundary immediately to the east is ignored. The boundary next to the east is ignored. All in favor of a school farther then 8 closer Elementary schools.

My focus is on the metrics set forth in School Board Policy 6010. My children move from one majority minority school to go to another majority minority school. No improvement. My children go from one overcrowded school to another overcrowded school. No improvement. My children go from a neighborhood school with a short travel time to a school many neighborhoods away with a travel 3x to 4x farther. Worsened. Fulton Elementary and Laurel Woods Elementary go from two schools in areas made of contiguous communities to one school made up of contiguous communities, as Laurel Woods becomes an island school. Worsened. Frequency in which a student is reassigned attempting to not move a student more then once in 5 years is NOT achieve for my children in this plan. Worsened. FARM % at LW decreases from 63% to 49%. Improved.

The harms far outweigh the perceived good. I have personally found numerous alternative solutions to address the capacity at Fulton Elementary School, while also addressing the high FARM % at LWES. These solutions eliminate the countless harms created in the polygon 1256 portion of the superintendent's plan.

In order to present these plans, my Maple Lawn neighbors and I need to know the metrics used by the superintendent and his Ohio consulting firm when devising this plan. What is most important? Is it FARM numbers above all else? If so, we can achieve that. Is it capacity? We can achieve that too.

What are next important? Feeds? Distances? Community stabilization? Walkability? Bussing costs? Boundary continuity? Are these goals, or others weighted? If, so, what weights for each? What is the FARM % you want at LWES? They are currently at 63%. Does is have to be below 50? Do you ever want it below 40%? If below 40%, they may no longer receive Title 1 funding. Is that okay with you? Is 53% okay if it means LW children do not have to be moved?

Please tell me. At least tell me what your goals are. We are working hard to develop solutions, but we don't know what our elected officials want.



Additionally, the portion of Maplelawn falling into polygon 1256 is closer to 8 other schools that to the school proposed in the superintendent's plan. 

I am confident that you have heard from numerous Howard County residents about redistricting, but I write only to ensure that you are aware that Maple Lawn's Polygon 1256--which is only one of four Maple Lawn polygons--is set to be redistricted from Fulton ES to Laurel Woods ES in Dr. Martirano's proposed plan. If you are not aware, I hope this email puts you on notice. I do not want to take much of your time, but please, regardless of equity concerns (which I do not intend to debate) I implore you to use whatever influence you have on the Board of Education to ensure that Maple Lawn does not become a divided community. The move of Polygon 1256 is truly an anomaly - it is one of only a few "islands" in the redistricting plan that literally splits the Maple Lawn neighborhood into 2 separate school districts. But, also importantly, it splits the Laurel Woods ES community into 2 separated geographic districts. In that regard, the children of Polygon 1256 will not only be isolated from their neighborhood, but they will be isolated from the Laurel Woods community as well. Moreover, moving the Polygon 1256 children from Fulton ES, which is currently at 120% capacity, to Laurel Woods ES will simply move them from one overcapacity school to another, as Laurel Woods would go from being under capacity to 115% overcapacity. Please, regardless of equity considerations, the proposal as to Polygon 1256 is simply too illogical and does a disservice to both the Polygon 1256 children as well as the Laurel Woods community. Good Afternoon, Ms. Jung

I was on vacation with my family when news broke that my children would be moved from Fulton Elementary to Laurel Woods Elementary in the fall of 2020. I live in Polygon 1256 and ask for you to vote no on this proposal.

My name is Meredith Dombroski and I have two young children who would be affected if this proposal goes through. This is my story.

In August of 2018 my family relocated to Fulton from Baltimore City, where school choice is offered. Despite living in a wonderful tight knit community with a public and charter school, my husband and I made the decision to send our daughter, Emily, to an out of zone public school across the city that we thought was a better fit. Our son, Owen, who is two years younger, followed shortly after for pre-k.

I was heavily involved in our old neighborhood, Bolton Hill, acting as VP of the nursery school board and lead chair for the annual festival that takes place each October. I attended community meetings and volunteered whenever needed. So you can imagine that when we chose to go to an out of zone public school versus investing in one of the schools in our community, we received backlash from neighbors and lost friends because they feared they would lose our investment and involvement to another neighborhood. And in some cases, they were right.

Bolton Hill connects neighbors through the nursery school, charter and public schools, churches, parks and playgrounds, and the neighborhood swim club. The summer following my daughter's kindergarten year, it became clear how much we disconnected from our community the first time we went to the pool. The children who attended the schools in the neighborhood socialized with ease as my children sat uncomfortably feeling

like strangers in the place they grew up in. In time we adjusted, but the pattern repeated the following year after a long stretch of investing in another neighborhood.

Emily and Owen were adored by teachers, administrators, and friends at their school in Locust Point. I was a very active parent in PTA and at one point took on a contract position working at their school doing marketing, outreach, and enrollment. While we had a large impact in the school and made many new friends, we were still outsiders in the Locust Point community. We missed out on last minute playdates or alley parties, not for being unwanted, but for not being remembered to reach out to because we weren't a block away, or a few houses down to call.

When we made the decision to leave Baltimore City I had one agenda - to find a perfect community where there were many children and a community center and focal point for neighbors to connect and a place where our children would go to the same school as every child in the neighborhood. After looking at houses throughout Howard County for months, we drove through Maple Lawn on a whim and knew we had found the place we wanted to call home.

I have lived in Maple Lawn for little over a year now. In that time I've become active in the PTA, two boards in the neighborhood, and have made many friends who I can call on any time for help. Our children met their first friends at school, in the back alleys, on playgrounds, and the neighborhood swim team. Our friends come from every polygon that feeds into Fulton Elementary and my biggest concern with this proposal is us 1256'ers losing the connection that makes our neighborhood so special and unique.

I know from my own experience what it is like to try being part of two separate communities. You are unable to be as active as you hope in either, you miss opportunities to be more involved, friendships dissolve, and you are never able to have one "home".

We are not just 1256. We are Maple Lawn, a community we chose to live in so our children could grow up with lifelong friends and neighbors. I ask you to reconsider this proposal and allow the children of 1256 to go to school with their neighbors.

I am a resident of the Maple Lawn Community in Fulton, MD. I am writing to oppose the proposed redistricting of my neighbors in polygon 1256 and any plan to redistrict more polygons out of Maple Lawn in the future.

The superintendent's current plan breaks my community in half and results in an unnecessary, long commute that sends those children across 29 and I-95. This Plan was apparently designed to advance equity by equalizing FARM distribution ratio across schools. Instead of directly addressing resources and capacity issues at certain schools, this Plan calls for massive student swaps, relocating students away from their close, nearby communities in an unprecedented scale – over 30-40% of student population in certain polygons. This Plan fails to address the real issues in our county's public education.

Equalizing FARM ratio by transporting children from one school to another does not help the students who are in need. This Plan will significantly increase student's commute time, discourage students from attending extracurricular activity, discourage parental involvement in school activity, tear apart our communities, traumatize both parents and students, particularly those underaged students. This Plan will also double or triple bus transportation cost, divert public resources which otherwise could be invested in schools that are in need.

While we all agree achieving equity is important in public education, it should be done in a thoughtful, prudent, and morally sound way. It should not be done recklessly, as this plan is, at the expense of our communities and schools, our students and parents, and furthermore, without even knowing the actions taken will help those students and schools that are really in need. **Transporting a student in need from a high FARM ratio school to a low FARM ratio school does not help to address the educational challenges the student faces.**

Subject: Opposition to County Council Resolution No. 112-2019

Dear Howard County Council Members,

I am standing here to oppose the proposed County Council Resolution No. 112 (or "CCR 112"), not as a disgruntled parent whose children will be impacted by Superintendent Martirano's Attendance Area Adjustment Plan, "incidentally" released in conjunction with CCR 112, but as a proud American who feels it is his civic obligation to speak against it. I acknowledge this resolution has a good intent to achieve equity in education, however, the ideology and political motivation behind it are simply false. As one Councilmember said, "the resolution is aspirational and not prescriptive." Nevertheless, it is intended to put political pressure on the Board of Education when it deliberates over the Superintendent's Plan.

First on Diversity. I am offended by accusations that we do not have diversity in our schools. Diversity was the very goal on which Columbia, the home of James Rouse, was founded 50 years ago. When we moved to Maryland about one year ago, we decided to live in the River Hill Village of Columbia for the very reason of its diversity, its tradition in honor of civility and openness, and its top-rated public schools. Diversity is far beyond seeing the world in the lenses of two colors. Diversity is about embracing different races, ethnicities, cultures, religions, political briefs, socioeconomic status. Diversity is about accepting coexistence of different opinions, experiences and backgrounds. The truth is River Hill is a diverse, multi-race, and multi-culture community. My children go to River Hill schools and every day learn from their peers of all colors, ethnic and cultural identities. But I also acknowledge that diversity today is a journey not a destination. There is certainly more we can and should do with this respect.

Second on Equity in Education. Prejudice is appalling when people living in the River Hill community are being called "wealthy" or "rich" people. As far as I know, most of my friends and neighbors, including myself, are hard-working middle class or professionals, who work hard to support our families, pay our mortgage and property tax, and make every effort to ensure our children have a quality life and education. As an immigrant and a citizen, I embrace and cherish the American values that emphasize equal opportunity for prosperity and success, as well as an upward social mobility for everyone, all achieved through hard work.

Socioeconomic disparity among different schools may exist in Howard County like everywhere else in terms of household income gaps, but this is a result of years of negligence and mismanagement with community planning and housing development. Achieving equity in education is a noble cause, but our children should not pay the price. There is no justice or moral high ground to achieve equity at the expense of others, let alone children. Instead, equity in education should be achieved in progressive, prudent and thoughtful ways. Equity will never be achieved through redistribution. Social engineering with the goal to achieve socioeconomic equity only creates the monster of its own inequality. Most part of the 20th century saw this type of social engineering started and failed in other parts of the world.

Thirdly, the right to choose which community to live in and which neighborhood school to go to is a common sense and a fundamental civil rights issue. School redistricting, as outlined in the Superintendent's Plan, calls for massive students swaps between school polygons – forcibly taking 7,400 students away from their neighborhood schools and sending them miles away, doubling or tripling bus transportation time. This is a classic example of social engineering and governmental overreach, and infringement upon individual civil rights.

Finally, the underlying assumption of CCR 112 is that socioeconomic disparity in the school system contributes to increasing achievement gaps and lower graduation rates for students who participate in the FARM program. It was proclaimed in the news release that "numerous academic studies indicate that diverse, integrated classrooms lead to better academic outcomes for all students, while increased segregation leads to greater achievement gaps for low-income students and students of color".

While the correlation between socioeconomic disparity and school achievement disparity exists, this may not be a direct, causal relationship. Several important factors other than income level may influence or determine school performance, such as community environment, family environment, parental involvement, cultural perspective, and personal accountability. A forced separation of children from their neighborhood schools and putting them on a long bus commute will make closing school achievement gap even more difficult. In an ideal world, every child should have equal access to every opportunity in a wonderful school with equally wonderful outcome. But that only exists in utopia.

Instead of making a political statement, the County Council should work closely with the Board of Education to take realistic and effective actions to advance equity in education. While this testimony is not intended to offer alternate solutions, a few considerations may apply: 1) expand voluntary participation programs, such as Jumpstart, and provide bus transport so that more FARM students will have the opportunity to participate in high-performing schools at their will; 2) create or expand magnet programs or create a magnet or charter school in Howard County so that all students, regardless of their income or polygons, will be attracted to attend together; 3) invest in schools that are desperately in need of infrastructure upgrade or special programs to help the students in need; 4) build more affordable housing so that more low-income family students will have access to high-performing schools, and do so while keeping a hard fiscal discipline with respect to school funding.

With that, I respectfully implore Councilmembers Ms. Rigby, Dr. Jones and Ms. Jung to withdraw County Council Resolution No. 112. I respectfully implore the County Council to vote against this resolution.



I am confident that you have heard from numerous Howard County residents about redistricting, but I write only to ensure that you are aware that Maple Lawn's Polygon 1256—which is only one of four Maple Lawn polygons—is set to be redistricted from Fulton ES to Laurel Woods ES in Dr. Martirano's proposed plan. If you are not aware, I hope this email puts you on notice. I do not want to take much of your time, but please, regardless of equity concerns (which I do not intend to debate) I implore you to use whatever influence you have on the Board of Education to ensure that Maple Lawn does not become a divided community. The move of Polygon 1256 is truly an anomaly - it is one of only a few "islands" in the redistricting plan that literally splits the Maple Lawn neighborhood into 2 separate school districts. But, also importantly, it splits the Laurel Woods ES community into 2 separated geographic districts. In that regard, the children of Polygon 1256 will not only be isolated from their neighborhood, but they will be isolated from the Laurel Woods community as well. Moreover, moving the Polygon 1256 children from Fulton ES, which is currently at 120% capacity, to Laurel Woods ES will simply move them from one overcapacity school to another, as Laurel Woods would go from being under capacity to 115% overcapacity. Dear Howard County Board of Education,

I am writing to voice my concern over the proposed redistricting of polygon #1256 (part of Maple Lawn). I share Dr. Martirano's goals of diversity and equity, but I believe those goals can be achieved in a better way, and I've listed several alternative options below.

Basis for My Opposition to the Redistricting of Polygon #1256: Maple Lawn is One Community, One Village

I live in Maple Lawn in an adjacent polygon to the one being redistricted, but the move affects me because Maple Lawn is all one community, one village. I moved to Maple Lawn 5 years ago because I wanted a diverse, intentional community where my kids could make life long friends and I could have a supportive village to help raise them. That's exactly what I got, but the proposed redistricting plan now threatens that.

The racial and ethnic diversity in Maple Lawn is phenomenal. As a snapshot: my neighbors directly to the right are from India, directly to the left are from China, two doors down are from Africa, across the street are from Columbia, and behind us are African American with the wife being one of the original families to move to Columbia back in the day. We ourselves are Jewish and my husband is from Russia. Together, we've celebrated each others Jewish, Christian, Muslim and Hindu holidays. The part of Maple Lawn being redistricted is similarly diverse and part of the beautiful mosaic that is Maple Lawn. My older son's best friend who lives in polygon 1256 is Chinese and Korean and my younger son's best friend who lives in Polygon 1256 is African American. On my older son's bookshelf is an Egyptian flag he got from a close Egyptian friend who lives in Polygon1256 at last year's Fulton Elementary School International Night where an astonishing number of different countries were represented.

Maple Lawn was designed as an "intentional community"-- a mix of condos, townhomes and single family homes with very small backyards so that people would need to use the shared playgrounds and green spaces. The concept works-our playground is hopping every evening with packs of neighborhood kids running around together while the parents catch up. These close social bonds that the kids and parents have formed have a very practical side too in that they serve as the basis for tight knit support system that we all regularly call upon to help raise our children. We and most of the families we know in Maple Lawn have two full-time working parents-- you can't afford not to. I'm managing director at a clean energy non-profit and I love what I do, but balancing a 50+ hour/week job with 4 children when my husband also works full time in a very demanding job isn't easy. We pull it off thanks to our Maple Lawn village. We have several carpools set-up with neighbors (including our Polygon 1256 neighbors) to get to and from school and various activities. When a single mom friend in Polygon 1256 had a work conflict last week and couldn't make it to our kids' back to school night, I filled her in afterwards and brought her the materials she'd missed. When I went into labor last month at 1am and 2 weeks early with our 4th child and had to rush quickly to the hospital, I just had to make one call to set off a chain reaction of neighbor help to make sure we were all set with sleeping/ feeding/ school drop-off/ pick-up for our older ones. This is what I mean when I say that Maple Lawn is one community, one village. Redistricting Polygon 1256 severs a large piece of that community, hurting not only the people in that Polygon but also the rest of us in Maple Lawn who rely on them.

Better Alternatives

As I always tell my kids, don't just complain about what you don't like, figure out a solution. So what are the possible solutions that would help achieve the goals of diversity and equity without dividing Maple Lawn? There are at least 3 solutions that I'd suggest:

- 1. **Redistrict Differently:** I've seen alternative redistricting proposals that keep Maple Lawn together while helping achieve greater socio-economic diversity at each school. For example, the proposal that Howard County Indivisible recently proposed would keep Maple Lawn together at Fulton Elementary School (FES) but make other adjustments that would increase the FARMS numbers at FES from less than 5% today up to 25%. While I do not know enough about the proposal to formally endorse it, I can say that in concept I would be fine with a solution that increases the FARMS % at FES and keeps Maple Lawn together at its community school.
- 2. **Create Voluntary Options:** You can catch more flies with honey than vinegar. Instead of forcing kids to go to different schools, the county could create voluntary options for making schools more socio-economically diverse. For example, the county could create special programs within different schools and let people opt into them (eg. a special Spanish or Chinese immersion program at Laurel Woods Elementary School or a special STEM AP program at Wild Lake High School).
- 3. Work with the County on a Holistic Solution: The socioeconomic geographic stratification that we're seeing today has a lot to do with housing development decisions that have been made over the past several decades and what appears to be a general lack of planning for school capacity needs in high growth areas like Fulton. The school system should be working with the county executive and council to evaluate housing development decisions and planning for the future so that the school system isn't forced to shoulder the burden of fixing a problem that is much larger than itself.

Whichever of these or other solutions the school board chooses, I'd recommend forming a committee to fully vet and develop these ideas and take the time to get community input. The rest of the state and even the country have their eyes on Howard County now. Let's get it right so that we can be an exemplary model and not a cautionary tale.

Councilwoman Jung,

I am writing to express my extreme displeasure with the portion of the Superintendent's redistricting plan related to Maple Lawn Polygon 1256. You may not have heard a lot about discontent in Maple Lawn so far, and that is not because we like the plan. It's also not because we don't care. We had hoped to differentiate ourselves from the rest of the county because it appears a lot of those conversations are becoming toxic.

I DO NOT want to focus on the value of FARM equity. I also DO NOT want to discuss why if every HoCo school is excellent, then there is a need to balance FARM scores rather then spending time, money and resources on specific needs at specific schools. That is not our focus.

My focus is that Maple Lawn is unlike a lot of other sections of HoCO that contain several polygons. It's a single community, approved by the Howard County Planning Board as such, and we live day to day as a unified community literally surrounding the school. We share mailboxes, green spaces, playgrounds, community center, and a walking path to the schools. This plan cuts out a portion of this tight-knit community to be redistricted away, isolating Maple Lawn children from each other.

My focus is also on the illogical distances. There are eight closer schools to Polygon 1256. We would become an island 5.4 miles off shore. Our commute time will triple, and opportunities to participate in activities at our children's school would significantly decrease. Maple Lawn children would pass by several other Elementary Schools as they travel over two highways to Laurel Woods. Maple Lawn children would pass former schoolmates traveling west, as we travel east on route 216 on a daily basis. The children they pass are from polygons also with 0% FARM.

My focus is also on capacity. The superintendent's plan related to polygon 1256 has my children leaving one overcrowded school, to stuff another school to 115% capacity. That hurts my children, other Maple Lawn children, but more importantly, the children at Laurel Woods. All of a sudden, their classes go from 20 children, to 30+. Is that fair to them?

My focus is also on the goals from the AAC, Community Sessions, and Online Responses from slide 9 of the Superintendent's presentation. Each one stressed "Neighborhood schools, walkable distances" or "Limit student travel time." My children cannot walk 5.4 miles across two highways. They could walk, and have walked the approximate mile to our current neighborhood schools. Travel time increases tremendously for my children and for my family when participating in school related functions. "Boundary continuity" is also not achieved. Our boundary with Fulton Elementary is broken. The boundary option to the north of 1256 is ignored. The boundary immediately to the east is ignored. The boundary next to the east is ignored. All in favor of a school farther then 8 closer Elementary schools.

My focus is on the metrics set forth in School Board Policy 6010. My children move from one majority minority school to go to another majority minority school. No improvement. My children go from one overcrowded school to another overcrowded school. No improvement. My children go from a neighborhood school with a short travel time to a school many neighborhoods away with a travel 3x to 4x farther. Worsened. Fulton Elementary and Laurel Woods Elementary go from two schools in areas made of contiguous communities to one school made up of contiguous communities, as Laurel Woods becomes an island school. Worsened. Frequency in which a student is reassigned attempting to not move a student more then once in 5 years is NOT achieve for my children in this plan. Worsened. FARM % at LW decreases from 63% to 49%. Improved.

The harms far outweigh the perceived good. I have personally found numerous alternative solutions to address the capacity at Fulton Elementary School, while also addressing the high FARM % at LWES. These solutions eliminate the countless harms created in the polygon 1256 portion of the superintendent's plan.

In order to present these plans, my Maple Lawn neighbors and I need to know the metrics used by the superintendent and his Ohio consulting firm when devising this plan. What is most important? Is it FARM numbers above all else? If so, we can achieve that. Is it capacity? We can achieve that too.

What are next important? Feeds? Distances? Community stabilization? Walkability? Bussing costs? Boundary continuity? Are these goals, or others weighted? If, so, what weights for each? What is the FARM % you want at LWES? They are currently at 63%. Does is have to be below 50? Do you ever want it below 40%? If below 40%, they may no longer receive Title 1 funding. Is that okay with you? Is 53% okay if it means LW children do not have to be moved?

Please tell me. At least tell me what your goals are. We are working hard to develop solutions, but we don't know what our elected officials want.

School Busing Didn't Work. And to Say So Isn't Racist.

Ted Van Dyk is the author of Heroes, Hacks and Fools, University of Washington Press, 2007, a memoir of national politics from 1960 onward. He served as assistant to Vice President Humphrey in the Johnson White House and was a senior policy advisor to Democratic national candidates and his party over a 40-year period. He still writes frequently on national issues.

Both the headline and content of Jason Sokol's August 4th piece about Vice President Joe Biden and the 1970s busing debate do a disservice to Biden and distort what really was happening in the Democratic Party during the period. Sokol has selective facts right. But he has overall truth wrong.

Principal 1960s civil-rights leaders, including my boss at the time, first Senate Whip and later Vice President Hubert Humphrey, sponsor of the 1964 Civil Rights Act, were dubious from the beginning about compulsory school busing as a tool to advance civil rights and improve education for minorities. The "neighborhood school," contrary to Sokol's depiction, was a cornerstone of American public

education. It has provided the principal basis for community and neighborhood solidarity in towns, cities and rural areas since the advent of public education in the United States.

Following passage of the Civil Rights Act and 1965 Voting Rights Act, and attendant Great Society legislation aimed at upgrading minority skills and education, Democratic leaders of all races and ethnicities searched for ways to break patterns of de facto segregation. Neighborhood structures, both North and South, had resulted in neighborhood-school segregation even after legal segregation had ended. Moreover, black families were slow to move into previously all-white neighborhoods. Widespread neighborhood diversity would come only later.

If black kids were not living in mostly white school areas, the thinking went, they should be transported to such areas rather than stay in mostly or all-black neighborhood schools. This would serve the cause of desegregation and, also, provide better quality education to African-American kids enrolled in what often were academically inferior schools.

Legislative initiatives and court rulings resulted in busing. In many places, like in Boston as Sokol describes, there was raw racism involved in protests against busing. In many other places, however, there was non-racist consternation based mainly on parents' concern for the wellbeing of their children.

This was the case even in liberal Washington, D.C. My wife and I had two sons enrolled in a Northwest Washington elementary school when busing began in the city. School buses would deliver black kids from Southwest D.C. at the Janney School front door at the morning bell. The same buses picked up the same kids, immediately at the end of classes, and took them back to Southwest. They did not participate in any pre- or after-school activity. No black parents took a bus or drove from Southwest to attend evening PTA meetings or to otherwise participate in school-related activity. The quality of classroom instruction fell off markedly. Fourth- and fifth-grade neighborhood students, for instance, were repeating material learned in earlier grades because teachers found their bused classmates had not yet received it. Not surprisingly, parents from the neighborhood began looking for private schools for their kids or moved to Maryland or Virginia suburbs—not because of racism but because their neighborhood school no longer was working.

To varying degree, the same thing was happening in other places where busing had been instituted. Elected officials—even those strongly in favor of civil rights—began to conclude that busing was a well-meant mistake. Presidential candidate George McGovern, in 1971, proposed to his advisers, of which I was one, that he would straightforwardly take an anti-busing position. We prevailed on him not to do so because we believed that the issue then was so emotion-laden that busing proponents would misunderstand his opposition.

This was the environment in which then-Sen. Joe Biden and other Democrats began to say out loud what their colleagues were already saying privately: Busing was not working. The emphasis should be on improving neighborhood schools, wherever people lived, rather than forcing kids daily to take buses, often quite far from their neighborhoods, distant from their parents and neighbors.

During the period in question I served not only Humphrey and McGovern but represented in Washington, D.C. the Southern Elections Fund, then headed by Julian Bond, which raised money for local-level black candidates in Southern states. I traveled to Mississippi to assist Charles Evers in his gubernatorial campaign. I was in daily contact with Democratic national and congressional leaders and several times served as principal author of the Democratic national platform. From the mid-1970s onward, there was a growing consensus within the party that neither civil rights nor education were being served by busing. Joe Biden represented that consensus; he was not some reactionary outlier.

To Democratic alumni of the civil rights and Great Society era, present debate about civil rights and

racial justice seems to have wandered far off-track. The cornerstone of our thinking, back then, was that important court cases and national legislation, such as the Civil Rights and Voting Rights Acts, would destroy legal bases for discrimination on the basis of race, gender, religion or ethnicity. Tangible programs to lift the educations, skills, health, nutrition and housing opportunities of minorities, in particular, would bring them a more equal chance at the starting line.

Yet the emphasis now is not on such initiatives but on real and imagined grievances against a "white establishment," denunciations of local police, focus on race-based violence (which has diminished markedly in recent years) and on the labeling as "racist" anyone not buying completely into the current politically correct talking line. The most visible black spokespersons, on the Democratic side, are nothing like Martin Luther King Jr., Thurgood Marshall, or even authentic Selma march hero Rep. John Lewis. They are Al Sharpton and Jesse Jackson, who use race as a wedge issue to generate attention and income for themselves.

I have no doubt what brave leaders of the civil-rights revolution would be saying as they witnessed today's so-called dialogue about race. It would go something like this:

We did not see how hard it would be to truly free black Americans. No more talk please of white racism by anyone or denunciations of past and present political leaders by folk who never risked anything in a tough period when it counted. Let us get on with the work. What good does it do if we have a black president, black attorney general, black judicial, execuctive, and legislative leaders at al levels, successful black leaders in business, labor and the arts if black communities, North and South, are plagued by high black-on-black murder and violent crime rates, narcotics dealing and use, horrific school dropout and incarceration rates, high unemployment, and broken or non-existent families? All Americans need to get on this now with tangible, practical initiatives. Enough grandstanding, self-righteous talk. Time to separate the talkers from the doers.

Dear Council Member Jung:

Five years ago my family moved to Maryland from Indiana and we specifically chose to purchase a home in Maple Lawn in Fulton due, not only the excellent reputation of Howard County Schools, but because of the sense of community and diversity that Maple Lawn offers. Currently, Superintendent Martirano has proposed a redistricting plan that adversely impacts this established, cohesive community and also violates several other elements of Board of Education policy. I am writing to oppose Dr. Martirano's redistricting plan.

The proposal calls for polygons #256 (which has one school-aged child) and #1256 to be redistricted from Fulton Elementary School to Laurel Woods Elementary School, creating an isolated island that is not contiguous with the current or proposed district boundaries. This effectively splits the Maple Lawn neighborhood across 2 separate school districts (Fulton ES and Laurel Woods ES) and also splits the Laurel Woods ES community into 2 separated geographic districts.

Capacity utilization is rightfully of concern. However, this proposal results in a 115% capacity at Laurel Woods ES and thus does not achieve a meaningful improvement in school capacity for students in polygons #256 or #1256. Also, according to the projections presented in the superintendent's proposal, the disruptive redistricting of a portion of Maple Lawn does not result in a meaningful improvement in any achievement gaps existing at Laurel Woods ES and arguably increases their burden by crowding their classrooms.

The proposal also refers to the Attendance Area Boundary Review Survey and prioritization of Policy 6010 elements. When the community was surveyed, the overwhelming top 3 priorities were:

- 1. Keeping feeds of students together from one school to the next (Policy 6010 IV.B.2.a) 65.95%
- 2. Maintaining contiguous communities or neighborhoods (Policy 6010 IV.B.2.b) 59.59%
- 3. Transportation considerations (e.g. walkers, bus routes, etc.) (Policy 6010 IV.B.1.d) 42.64% For reference, the next highest priority only received 25.88% of responses.

In relation to these top priorities, the proposal for polygons #256 and #1256 results in a very small feed from Laurel Woods ES to Lime Kiln MS (10.6%) whereas Fulton ES represents 48.4% of Lime Kiln MS. Policy 6010 refers to "avoiding feeds of less than 15% at the receiving school".

The proposal also does not maintain a contiguous community or neighborhood for Maple Lawn (Policy 6010 IV.B.2.b). As the proposal was completed by a consultant group based in Ohio, I would like to emphasize that Maple Lawn is not merely a collection of streets in close proximity to one another; it is a planned community built specifically with a variety of homes and retail close together so that residents could easily build community. We are a diverse, engaged, tight-knit community in which families frequently interact (community center, festivals, activities, etc.) and both children and adults have established support networks. This is all intentional. Rightfully considering Maple Lawn as a community in school district proposals would sustain the community and its collective contribution to their school.

In addition to the adverse impacts of separating the community, the proposal greatly increases the transportation distance (over 400%) for students redistricted from Fulton ES to Laurel Woods ES. There are 8 elementary schools closer to polygon #1256 than Laurel Woods ES, with Fulton ES being the closest. In addition, the transportation distance and disconnected polygons in the superintendent's proposal provide unfair challenges for before and after school care, whether at a center or using neighbor/family support.

Furthermore, friendships are vital to school-age children's healthy development and can improve their approach to school and academic performance. For young children, these friendships are strengthened by geographic convenience where they live and play. Neither a divided Maple Lawn neighborhood, nor a divided Laurel Woods ES geographic community, facilitates this otherwise likely opportunity.

Dr. Martirano previously asserted that removing barriers and individualizing supports improves equity. His redistricting proposal, however, contradicts these equity concepts by placing geographic barriers for the proposed Laurel Woods ES districts. Regarding individualized support, the elementary students residing in Maple Lawn are equally deserving of individualized support by attending school within their neighborhood and not being isolated from their community, neighbors, and friends.

Boundary continuity is of utmost importance to achieve the priorities declared by the superintendent and the community, as well as the needs and fair treatment of the students. I would like to strongly advocate for a revised plan with reasonable boundary continuity and consideration of Maple Lawn as a contiguous community neighborhood and hope that you will also join this effort. Dear Council Woman Jung,

Thanks for writing back to me, and sorry it takes me so long to provide a response. After reading your email, I had to spend a good amount of time to digest and think through your reasoning for supporting this CR.

I would like to begin by stating that, as a long-time democrat, I support your intention of achieving equity, narrowing achievement gaps, and help every student in the county to achieve the best they can be. While you intend to achieve these goals by aspiring BOE to act through redistricting to based on socioeconomical quotas, I still cannot support this resolution because redistricting is the wrong way to solve these problems.

You stated that this CR is only "aspirational and not prescriptive". It would seem that your intention is simply making a statement about the need to integrate and be inclusive when conducting redistricting, then I must inform you that per HCPSS Policy 6010, section IV, B3b, "The socioeconomic composition of the school population as measured by participation in the federal FARMS program" is already included as one of the consideration factor when conducting redistricting. So it begs the question, is your intention of this CR calling the BOE to adopt socioeconomical criterion as the only factor to use when conducting redistricting? If so, I would like to tell you that from my personal experience and observation, even when schools are integrated forcefully based on socioeconomical factor, the students are never truly integrated. You see, when I went to high school in San Francisco in the late 90s, where the schools were actively integrating the students from various parts of the neighborhood. My school is located in a middle class neighborhood but had a FARM rate of over 60%. I lived close to my school where I walked, but many students took the bus as well. Looking back, none of my close friends were supported by FARM program, and they are all living closely to school. Why is that? Because the friends I made were mostly involved in same after-school activities as I do, and this happened not by choice, but by circumstances. Many after-school clubs and activities, like the debate team and band, needed students to be heavily involved after school and during the weekends. I believe many students, who needed to ride half to an hour bus to get to school, would have challenges in participating. Please keep in mind, this is SF, where the public transportation system is one of the most reliable and robust in the nation. My experience is echoed by many from our school, as it is evident during school reunions, that the ones are still in touch after many years are the ones who live close to school and who have built a strong sense of community surrounding the school. It is these after school activities and socializing that fostered the friendship and interactions between the students, not by simply sitting together in classrooms. I think you would understand that true integration can only happen when the students, families, and communities come together

willingly.

As you have acknowledged, the current problem with concentrated FARM rate at certain of our schools are largely due to poor urban planning. It is a problem created by decades of poor management and over-development under the misguidance of the county council, and we elected you to solve these issues. Rather than calling for using school redistricting as a tool to solve socioeconomic problems, it would be more reasonable and sensible to focus on solving the root of these socioeconomic problems, instead of dividing the communities and supporting forced busing which would cause undue financial burdens on the schools. Need I remind you that we have a ~50 million funding gap in our schools and many of our para-educators and teachers were let go or reduced in hours this year. Our schools and renovations are delayed or putting on hold due to funding constraints. Not only I do not see the council making any meaningful way to address the funding issue, you are over burdening school by asking them to spend more to bus kids in and out of their neighborhoods. Our schools need more of your support, not empty political statements from you! This resolution is like Trump's border wall, it only makes an empty political statement, while achieves nothing in addressing the root of the socioeconomical problem, at the expense of our kids, community cohesion and much needed resources. I object this resolution for the same reasons I hate the wall. It is useless, pointless, costly and misguided. As your one time supporter, I urge you to WITHDRAW your support for this resolution!

As you are aware, along with Councilmembers Jones and Mercer Rigby, I cosponsored a resolution that encourages HCPSS to rebalance schools based on socioeconomic factors. District 4 is a microcosm of the issues facing the County as a whole. Many of our Columbia schools have a higher concentration of poverty than the County average due, in part, to land-use policies made by previous administrations and councils. Redistricting presents an opportunity to build long-term success for the entire county, but I do have concerns about the current plan and its disproportionate impact on District 4.

It is important to understand that CR 112-2019 is aspirational and not prescriptive. The Roman orator, Cicero used to ask 'Cui Bono' (who stands to gain?) when trying to uncover a truth. He knew when asking this that another issue would quickly come to light: 'who will be made scapegoat'?

If history teaches us anything – it is that you have the opportunity not to repeat the mistakes of the past and maturely consider alternate options.

As someone who came from a very modest background and has personally lived in two highly segregated societies, it is incredible that I need to write a letter of protest against the proposed plans lead by Dr. Martirano.

Data

As educators, leaders and parents you understand that data never lies.

- Segregation How is it possible that although our own state and county data reaffirms that HoCo does not have a segregation issue, it is blithely ignored?
- Feasibility report How can this report that offers a path forward get set aside wholesale?
- FARM –if FARM rates / even distribution thereof is your goal, then what do you say to the fact that shifting 7,500 students will produce minimal impact but major societal upheaval?

When someone ignores data, common sense, experienced professionals and parents alike one must reasonably ask: cui bono? I'll get to that later.

Policy

As educators, leaders and parents you understand that good policy must also be just.

- What is just? policy that is impartial, evenhanded, reasonable, ethically and morally correct and in perfect harmony with the rights of others. As the data runs counter to the proposal, the policy fails the 'just' bar. Curious.
- Joined up thinking when all of you (including HoCo executive members) are challenged about the current absurdity, your response is: 'not my area, this is BOE' etc. Choosing to absent yourself from engaging in clear public policy conversations (make no mistake this is broader than education) demonstrates a lack of moral courage.
- Social engineering Having lived this before, this poorly thought out, conflated 'policy' is uninformed social engineering and a headline for some one. Under what circumstances would you choose to tear the basic social fabric of a community by forcing children out (in both directions) and have them disconnected from their neighborhoods, their sporting and social lives and visit distress upon them?

Again, cui bono?

Leadership, politics, economics

When the data is clear but the policy and its supporting motivations are unclear what does that suggest?

- Your role a leader attracts followers when they share a compelling future state that connects intellectually and emotionally. In this case no-one is following. Certainly no parents.
- Gerrymandering will anyone in a leadership position who can impact this policy proposal be personally affected? Will they 'benefit' in any way? For example, is there anyone whose children will from a 'lower' performing school to a 'higher' performing school e.g. Wilde Lake HS to RiverHill HS; will their property prices be positively affected? Anyone?
- Politiking when BOE members put out statements (and offers political cover for one's colleagues in parallel) it suggests a final decision is already made. Confidence in the 'process' is clearly shot.
- Economics when poor policy is implemented it has real consequences. In your state of the county address Mr Ball, you reference concern about any loss of HoCo triple A rating. Well let's keep it simple: assume that all homes off Shepherd (current sale price c. 1.2m and in the RiverHill HS area) take a 20% hit (conservative), in one fell swoop you just destroyed property value by c. \$60m. If there is no benefit living here with your young family then you won't buy and you certainly wont want to pay the associated property taxes. Just like Fairfield County in Connecticut witnessed, a quick erosion of the economic base follows. I can assure you that I will sell up.

To all of these questions I ask: Cui bono?

Impact & analysis

When you don't ask the right question, you get the wrong solution.

- Solution break out of your silo's, work in concert with governmental partners and agencies and create a holistic plan for HoCo. Don't grab the first facile solution that presents itself. It is already based on flawed logic.
- Lead creating community wide havoc to give the appearance of action is lazy leadership. If the proposed approach has no material impact, then why bother?
- Me as someone who grew up in a deprived community, I know better than most what it takes and how it feels. Through dedication, hard work and personal accountability I did everything to achieve my aspirations. Everyone has attitudinal and behavioral choice these are the few things in our full control. I have been blessed and fortunate to live where I live and give my kids a better life. Who are you to decide upon a social experiment to mess around with their lives, their community, their security? I did not work hard and teach my children what it means to be of service to others only to be arbitrarily penalized for my 'success' by a flawed, lazy process. Would you wittingly send your children to a lower performing school? No, I didn't think so. Why? Because it takes years and years for school performances to come up.

To everyone in this email YOU MUST GET INVOLVED. What is being proposed is a profound social policy shift that has real consequences – political, social, emotional and economic and no benefits.

Cui bono? Not me nor anyone else I know. Can you?

This article from May 2019 talks about proposed cuts. From what I understand there were teacher positions cut for math and reading support for students needing remedial help. These are just the teachers needed for the low performing schools and FARM students, yet this very year positions were cut and teachers moved to other positions where there were openings. For example, I understand the 'paraeducators' were cut. If this is the case there does not seem to be any real intention to help those students especially in need. I believe the paraeducators at Title 1 schools were exempted. See Title 1 list below.

'Other proposed cuts include reducing the number of Gifted and Talented teachers at the elementary level from 79.5 to 42 and at the middle school level from 60 to 20. Also, cutting elementary school paraeducators from 216 to 132. However, Martirano is still recommending to increase the number of kindergarten paraeducators from 84.5 to 97 positions.'

Additionally, Dr Martirano is citing the number of schools being moved out of certain FARM and PARCC ranges. What the actual analysis shows is that there are meager improvements in the scores made by the proposed redistricing. Taking the elementary schools as an example and using a MATH PARCC school score of less than 65% as 'in need' there are 22 schools with weak performance 2 have no change with the redistricing, 6 have low single digit changes in the wrong direction, meaning the scores get worse with the redistricting, 14 schools have a single digit change, of those 5 schools have no change (0% change).

The plan is very disruptive, what it purports to do is not supported by its own data. And, as we know moving students around does not help their academic success, only changes numbers. All this while there are budget issues and paraeducators were cut for this school year.

I will be sending this information in as testimony but thought it may be of interest to your group as well. Please see the attached spreadsheet for the analysis of the ES, MS and HS PARCC score changes. The base and proposed figures are from the county. I've added the Change and Comment columns.

Dear Board of Education Members - The text shown below is included in the WORD attachment. The Excel file attachment shows the analysis of the PARCC changes from base to proposed.

The proposed redistricting moves more than 7,000 students among Howard County's 82 schools to accomplish insignificant change in the face of clear need for greater improvements. For example:

- · Improvements in reading scores of 5%, or less, quite a few 0%, 1% or 2%, for 11 elementary schools with weak base scores (59% or less for purposes of this discussion). Several schools with low base scores actually deteriorate. Several have no change. One elementary school that starts with a base reading score of 65% falls to 48% 17% points in the wrong direction putting this school in a significantly weaker situation.
- · The statistics are similar to the above scores for reading and math for elementary and middle/high schools.

The improvement for the majority of the schools with the greatest need will be almost imperceptible.

The results for Atholton High are particularly disturbing. Atholton is a diverse school with solid base reading score (73%) and math score that could be stronger (57%), and both scores take a big hit. The base math score starts at 57% and goes down 16%. Interestingly, Mt Hebron also starts at a 57% base math score and goes up 3%. What is the point?

FARM figures present a similar picture. This redistricting creates maximum student dislocation for minimum improvement in educational performance, the primary reason for an education system. I encourage HCPSS to find creative approaches in all schools that address in place the reading and math deficiencies of the students most in need. As others have called for, intense focus in the early years of school, particularly from kindergarten through 3rd grade, is imperative. Moving students does not accomplish what is needed, even the data supplied by HCPSS does not contest this.

I share virtually all of their values and am living my life and career accordingly. However, I am looking at the data through a far more informed lens in terms of mapmaking and demographic data. I am deeply concerned that the plan does far more harm than good, particularly when measured

(through deep quantitative analysis) against exactly those progressive values which its proponents and I share. It fails by the more specific measures which supposedly drove the specific design choices behind its creation - FARM diversification and school utilization - unless one cherry-picks facts to make it sound supportive of these factors. However, it does seem to support continued high-end real estate development in areas where school utilization would otherwise prevent new development. In addition to the changes in the schools themselves, the new real estate development this plan would allow will magnify existing inequities in the geographic distribution of wealth in our county.

The animated scatterplots attached to this email shows how the superintendent's plan would change each school in FARM % and utilization (Capacity %). The dotted lines show the average FARM % and 100% utilization. If the plan had an overarching positive effect on FARM distribution, you would see the markers move toward the dotted horizontal line. If the plan had an overarching positive effect on school utilization, you would see the markers move toward the dotted vertical line. If the plan were significant at improving both FARM distribution and school utilization, most of the numbers would move toward the intersection of the dotted lines.

I saw "most" because there are, of course, other considerations. For example, planned expansions and new schools should be taken into consideration, so a few points may move strangely in anticipation of new capacity (which is not guaranteed). Similarly, one may want to consider that a 39.9% school does not receive the Title 1 benefits which a 40.1% school receives, so there is some benefit to keeping a school just above 40% if it would otherwise be just below. We see far stranger movement than should be expected from such causes.

We should also be particularly wary of schools which move toward the top right corner (overcrowded and high FARM) and those which move toward the bottom left (under capacity and low FARM).

Leet's look more specifically at my own family's situation - both because I care deeply about my own children and because it's an example of the sort of egregious things that are happening under the hood of this plan. We live in Polygon 1256. My children would be amongst the 140 students split off from the rest of the tightly knit and walkable Maple Lawn community (which includes Fulton ES within the bounds of Maple Lawn) and would be driving across four elementary school districts to go to the ninth closest elementary school to where we live. If this advanced the values which the map purports to uphold, I would not only understand, but I would be supportive of this move. Instead, this move reduces overcrowding at Fulton ES (a ≤5% FARM school which already has the extra trailers and teachers) exclusively by creating a drastic jump to significant overcrowding at Laurel Woods, a Title 1 elementary school which will need to deal with going from 91% utilization to 115% utilization over a single summer while still having a 49% FARM enrollment after this move. I have no idea how any school, let alone a school managing the specific challenges of families with significant financial challenges, can prepare the requisite number of teachers and trailers in a single summer without significant disruption to the psychological wellbeing and educational progress of its students.

On the Fulton ES side, the move brings the school to exactly 105%. There are no other significant changes to Fulton ES it is receiving no polygons and demographic percentages remain fixed. This 105% should jump out at any informed citizen as the new threshold above which new residential development is not allowed. That is, in order to allow new high-end developments with sustain the concentration of poverty in our county, we are putting a school that is serving the least fortunate families in an untenable situation.

Much has been made of Fulton ES being the largest school in the county and now being over 1,000 students, but it also has the highest capacity rating of 826 students, and is not the most overcapacity in terms of percentage. It has the trailers and teachers in place. It is obvious that this "overcrowding" is an issue - and is being addressed in this plan - to allow for even more high-end residential real estate, at the expense of all measures of this plan's success.

For my own family, this map is untenable. Due to our move to Howard County and other factors, the redistricting would mean our twins would be attending their sixth school in 3.5. years - or else be split from those of friends (e.g. our immediate neighbors who would be moved to Laurel Woods. Both my wife and I work long hours and we will not compromise on our ability to participate (PTA, extracurriculars, beforecare/aftercare) in a neighborhood school that is

less than a 20 minutes round trip to where we live. The fourth meeting of the AAC included discussion of how some families may choose home schooling or private school as a result of this plan. We are deeply committed to having our children in a diverse public school, as they are now. I do not know what we will do if the map goes forward unchanged, but I know it will be incredibly painful for us and will achieve the opposite of what it is supposed to achieve for many of the schools affected by the map, including Fulton ES and Laurel Woods ES.

This plan redistricts 140 students from Polygon 1256 from Fulton Elementary School to Laurel Woods Elementary School (LWES). Please see my attached letter of concern, which describes why this plan is illogical, splits an established community, and how it negatively impacts my family and Maple Lawn as a whole.

I regret that I am unable to join your meeting today at 4:15 p.m. with the Families for Education Improvement (www.hoco-fei.org) due to a prior commitment during the same time. I am a member of FEI and I stand with the group in opposition to the current draft of CR 112 but in support of equity in our schools done the right way. While your intention of achieving equity in our schools is a good one, the current draft of the resolution is problematic for several reasons. I am confused about the many references to racial relations and the history of slavery in the resolution when your stated intent is to achieve socio-economic diversity.

Let's not forget who sold the slaves and how did the salesman got the slaves; so stop the finger pointing. Slavery was abolished years ago; we need to look ahead.

So please do not make this conversation about race especially when Howard County is already incredibly racially diverse and we should be proud of it and not shamed by the language in the resolution. Next, I do not believe that uprooting children from their communities through redistricting of schools does anything to help the children in need. How would these children cope with a new and stressful environment when no one has provided them with the additional resources that they need to succeed?
