Rigby: The County has a role to play in helping areas that experience flooding, particularly when flooding is related to new development. New regulations on developing upstream from areas that already flood can help prevent increased flooding conditions. However, once the development has occurred, the County should help residents with ways to mitigate the impact of flooding. I am writing in strong support of CB38 - The Patapsco Lower North Branch Bill.

This is a bill that is decades overdue. Having been a Howard County resident for more than 48 years, I have watched as valuable pieces of our forest, stream buffer and steep sloped land have inexplicably disappeared in favor of a steady march of development. The result has undoubtedly led to stormwater surges into our streams and rivers, loss of forest diversity and vitality, and an increase in flooding in special places like historic Ellicott City.

Now, we have an opportunity to bring about smarter, more environmentally sound development practices to the county. Given that we are densely developing the downtown Columbia area, this should be coupled with a much stricter guidance for developing on or near our ecologically valuable forests and lands in the county. CB38 would do just that, putting a much higher bar on where and how we gain approvals for clearing the limited remaining forests in the county. It would also eliminate the "fees in lieu" of compliance, which in our business of energy development are known to result in much lower quality forested areas than the original.

We urge the Council to vote in favor of this bill, and to resist and vote against any weakening amendments to this forward-looking legislation.

Hello Ms. Walsh & Council Members,

We were at the county council meeting tonight and we were sitting behind the group wearing yellow t-shirts. I must say, it was a true experience, but a confusing experience. We really don't know if we can go ahead to get the permit to do the sunroom in place of our deck, as you mentioned in the email thread below. I have a few questions below that my builder needed to know.

1) Was the amendment passed tonight, to allow building on 1,500 sq. ft on any properties in the watershed area? It seemed that it passed.

2) If the bill with that amendment was voted down, which it seemed to be, does it mean that the amendment is still in action as is without that amendment. It appeared that the 1,500 sq.ft. amendment passed only to be later voted down. We are confused and now wonder whether or not to proceed with seeking our permit.

3) Is a deck an impervious surface as well as a sunroom?

As I mentioned before, my home (4080 Choctaw Dr,) is 34 years old and I have been a resident of Ellicott City since 1985. The The Woods of Tiber Branch development and The Woods of Tiber Branch II development were built within the last 15 years with more than 80 houses built altogether off Old Columbia Road! On the other side of Old Columbia Road, quite a few new homes were built on Sears House Court. We thought that this was the type of development that the moratorium was meant for.

So please, help me understand if I can go ahead and with the sunroom as your message below said and provide answers to my questions above. Looking forward to hearing from you.

Hi Wetteraus: Thank you for your note! And good news: Amendment No. 1 (here: <https://apps.howardcountymd.gov/olis/GetFile.aspx?id=25779>) confirms that homeowner projects like yours would be exempted from the Protect-This-Watershed bill!

That said, so long as your intended project doesn't increase net impervious surface on your property (which it doesn't sound like your conversion would), you should be able to get that building permit right now. Here's the bill for establishing the moratorium (CB56-2018); the exemption you're looking for is at Section 6(D)(2), p. 7: <http://apps.howardcountymd.gov/olis/GetFile.aspx?id=%2015766>

Yes, major builders of condos, shopping centers, and communities of homes which need extensive amount of land to do their construction should be slowed down and take into account what effect the construction would have on the environment! It's sad the number of trees that have been cut down and the green space that has been covered over by the builders to fulfill their purpose.

All,

I appreciate your diligence on these bills and on the County Resolutions. Although I testified in person, I want to reinforce one last time that we need an extension on the Moratorium for two reasons- to get the new proposed stormwater standards in order and to get better data about waivers granted to environmental protection laws by DPZ. Since that data seems to be inconsistent and since DPZ seemed unprepared at the work session (or purposely stonewalling your work), I think it would be prudent to take a moment to allow DPZ to get its house in order before returning them to business as usual when it comes to waivers and watersheds. This will also give the County Executive time to introduce his new Forest Conservation bill and have it voted upon by the Council and in place for subdivisions not yet in process when the moratorium lifts.

I am not a hair-on-fire kind of person... but this is one of those moments that need our urgent attention. There is nothing more pressing than our changing climate, and the ever-increasing life-threatening flood events. Our number one super power for both of these is trees. A simple, basic, solution.

I'm asking for a pause on waivers and on development in our floodprone watersheds until we can reset our waiver practices so that they are hard to get, and as equally as expensive as working to develop and save our priority forests- so that builders who work in a speculative industry- aren't rewarded for doing the least, and so that we know that DPZ - or whomever is tasked with granting waivers- is doing what is best for the citizens.

Our pie charts are upside down. Waivers denied should be the big piece of the pie and waivers granted should be the smaller slice. Remember- state law says that waivers are not meant to subvert the intent of our laws.

Dear Chairwoman Rigby,

I apologize it has taken longer than I hoped for me to send you the attached DPZ Exemptions Analysis. I hope you and your colleagues are able to take a look and consider this data in your decision making for CB38 and CB42.

Since the 2016 flood DPZ has approved **238 Environmental & Stormwater Protection Waivers** (codes 16.115, 16.116, 16.121, 16.1201, 16.1202, 16.1205 and a subset of 16.120). There were a total of **5 denied applications** over the same period – that works out to a 98% approval rate. To be clear, the fact that even after being faced with the impact of the 2016 flood our department of Planning and Zoning continues to approve these applications at these rates is a clear indication the system is broken.

For far too long developers have been calling the shots by investing in Howard county politics and making a killer ROI doing it. Unfortunately, it is now all too clear this return came at the expense of our environment, our public facilities and our fiscal stability. Far from paying for itself, unchecked development has led us on a path to overcrowded schools, budget deficits, and a frail ecology. Developers deserve to be heard out like the rest of us, however we can no longer afford to allow special interest investments in our political system lead to privatized project profits that transfer the majority of the project costs to the public.

Tonight is a pivotal moment and one that many residents of this county are hoping will mark a departure from this model of governance that has brought us to the point we are in today. I hope you and your colleagues are able to find the courage required to stand up to special interests and make the right decisions for the county and its citizens as a whole. While there are clear divisions that linger in the county, the support for these bills are broad based and unifying. We are all watching and hoping this new council represents a new way of doing business in the county – a sustainable way. Please vote as our children's future is on the line, because it is.

Protection of Howard County citizens, its visitors, and our natural resources is a primal calling of any great legislative body. After a series of devastating floods, we all know the county cannot afford to continue to operate business as usual. This is why I am very encouraged by this legislation and I hope that you represent the people of Howard County and put the interests of the residents before those of special interests when you vote on this legislation tonight.

As I understand it, this legislation aims to primarily accomplish two things: One - Improve environmental protections and storm water mitigation requirements to ensure further development in the watershed does not exacerbate an already bad situation by making potential future floods more catastrophic, and Two – Making sure we actually follow these rules.

Strengthening storm water and related environmental management standards would demonstrate Howard County leadership at a time when other Maryland counties and communities far beyond are also grappling with similar issues centered on climate change and development. We have an opportunity to show that as a county we understand the huge return on investment of making smart development choices, and inversely, avoiding bad ones. We are currently talking about spending over \$140 million of taxpayer money (not including interest on any bonds needed) in part to fix mistakes of the past. Given we now know full well how sensitive the watershed is, lets commit to protect it and ensure we don't dig ourselves into an even deeper hole. Lets make sure that the rules meant to protect downstream communities are followed every time, not just when convenient for developers.

Fees in lieu sound like a good idea in principle, but our history shows they are rarely used as intended, only making the issues they are supposed to address worse. DPZ exemptions have been the norm in Howard County, and we've all witnessed the consequences such actions have had on exacerbating flooding, socioeconomic segregation, traffic, etc. As we tragically know, flash flooding can be a life and death issue, and this legislation codifies there are circumstances where such exemptions simply can no longer be allowed.

You might hear a doom and gloom scenario about the impact this will have on development in the watershed. The reality is this legislation will simply serve to filter out projects that should not be moving forward in the first place. Projects that will likely cost taxpayers more than the benefit they would generate. I urge all council members to stand with the community and show a united front. Please stop taking expert advise from special interest. When floods happen, the citizens of this county will be looking to see what you have done to enhance protections to our environment. Developers take a risk when buying property in the watershed just like other residents who have bought from these developers now suffer the consequences of poor development decisions. 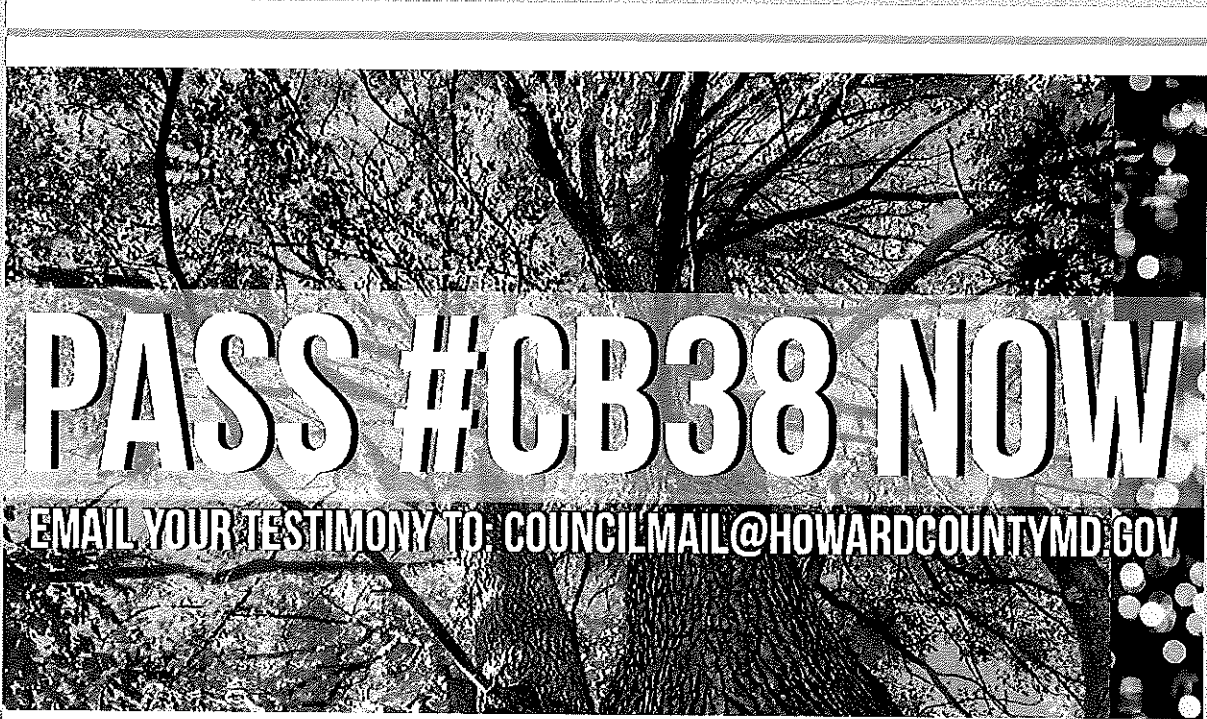

I would like to express the Housing Commission's appreciation for the open and insightful discussion of Council Bill 38 at the work session on Friday. The Council is clearly working through a very difficult set of issues.

As we stated in our original testimony on the bill, the Commission is strongly supportive of efforts to mitigate flooding in Ellicott City and other parts of the County. Climate change is worsening flooding in many parts of the world as storms become stronger and more damaging. The Council should be applauded for addressing the issues head on.


Unfortunately, CB 38, even as amended, would likely halt two housing developments with about 120 units for lower-income County residents. These two developments are bringing approximately \$30 million of scarce low-income housing tax credits and other State funds into the County, along with an additional \$13 million of other funds, to help solve the County's on-going affordable housing crises.

As we have noted on numerous occasions, there is currently a shortage of about 5,000 homes for County households earning \$50,000 or less annually. A stable, affordable home is the first step to improving income, self-reliance, furthering education, and a host of other desirable outcomes.

While there are many objectives to balance in moving the County forward, mitigating flooding should not make our housing problems worse. Without an exception for affordable housing, this is exactly what CB 38 will do. There are ways to achieve both County goals – to reduce the impact of future storm events and to further the creation of housing for Howard County's lower-income households.

Thank you very much for your help with this matter and your thoughtful approach to balancing the needs of the County. We look forward to working with you on CB 38 and other legislation.

Notes on CB- 38-2019 and Amendments 1 -- 9 to CB 38-2019

Major Points

1. Page 11, line 21- Public Stormwater Management Infrastructure

I recommend that the word Public be deleted so that Private ponds, which are built to the same standards as public ponds and which reduce current runoff by at least 10% and which are designed with the minimum environmental impact necessary to achieve that 10% reduction, also be considered eligible for the same variance as public ponds. For example, it doesn't take much imagination to understand that that T-1 will need variances and waivers to be built in the stream channel, in the floodplain, in wetlands, and their buffers, in steep slopes and will require the clearing of forest in order to create enough storage volume to protect Ellicott City from flooding. The goal is safety; to provide flood protection and whether public or private should not matter.

2. Page 4, Line 23, 50 foot setback from steep slopes

This provision anticipates that steep slopes are natural and that they adjoin flood plains and streams. Often times a small area of steep slopes can exist in an isolated location completely removed from environmental areas. One existing house with a walk out basement would cause you to have steep slopes. For example, some properties could have steep slopes (10 vertical feet at 25%) that comprises an area of 200 (10 ft x 20 ft) square feet in the middle of the site. This Bill would require the owner to set aside a 50-foot perimeter around the 200-foot steep slope area. This area would be 110 ft x 120 feet or 13,200 SF. So, you have 200 SF of steep slopes, and you lose the ability to uses 13,200 SF of your property.

You could lose the ability to utilize your property because of 200 SF of steep slopes that are completely isolated from environmental areas.

3. If you were to approve Bill 38 as amended along with the changes suggested above and below, will the Bill merely accomplish the flood protection goals of CB 123?

By the time you align this Bill with the CB 123 storm water criteria, eliminate the enhanced Open Space requirement, restore necessary disturbance and floodplain disturbances for SWM, remove the enhanced forest conservation requirements, restore consideration of scenic road waivers, and extend some relief to residential infill, what is left are the possibilities for unintended consequences.

I recommend that you measure what might be achieved by this Bill with what will be accomplished by CB 123.

Other Points

1. Page 3, lines 2 and 3, infrastructure damaged by flood and Page 18, lines 12 through 16, Subsection E, Redevelopment

By deleting the waiver provision on Page 3, the Bill would not allow for waivers for the reconstruction of infrastructure damaged by floods. This could apply to damaged roads and rights of way like Main Street, for example.

The language in 18.910 (E) would similarly restrict redevelopment road and rights of way repairs resulting from flood damage.

I recommend that both provisions be tempered by an exception for improvements to existing public roads and rights of way.

2. Page 7, lines 23-24, Open Space and Page 14, lines 17-18, Fee in Lieu of afforestation or reforestation

Several of the proposed amendments appear to offer relief to minor subdivisions from some of the Bill's requirements but these two provisions remain.

The Open Space requirement for a two lot subdivision of a 1 acre property would yield an Open Space lot of 6/100 of an acre. It would likely be non-contiguous with any other Open Space, would not meaningfully fulfill any of the goals for Open Space, require the creation of an HOA, and merely operate as an extension of the backyard of one of the two lots.

At 6/100 of an acre, the Open Space would be too small to meet the minimum requirements for a forest; 10,000 square feet with a minimum depth of 35 feet. And, because forest cannot be located on a lot smaller than 3 acres, most minor subdivisions could only hope to achieve the forest obligation on Open Space- already determined to be too small.

I recommend that both of these provisions be eliminated from the Bill.

3. Page 12, Lines 8 and 10, Forest Conservation, Critical Root Zones and Hubs and Corridors on adjoining properties

These provisions of the proposed delineations involve adjoining properties where a developer has no right of entry for delineation or surveys. And they suggest that these offsite features may in some way be protected when those property owners may disturb the trees, hub and, corridor with impunity.

I recommend that the delineations be confined to the property proposed for development.

Collette - Please forward this to Councilwoman Mercer Rigby. I know from our past email thread and her concerns voiced at the work sessions that she has well-founded reservations over this Bill and its purposes. I've enclosed another copy of my testimony, which was previously submitted and included in the "written testimony" files attached to Bill 38.

Any measures taken in the greater Patapsco Watershed are not going to make any difference in the 2016/2018 type top-down flooding. Hydraulically, it can't. There are technical reasons for this, but I won't try to explain in this email. There will be some theoretical benefit for the bottom-up variety but only theoretical. **The real benefit to the Main Street area is fully covered by CR 123**, and the planned flood mitigation projects. These two measures won't solve all future flooding problems for a town unfortunately built in a floodplain, they should proceed.

CB 38 however, will not add any incremental flood prevention benefits for Historic EC. However, CB 38 will curtail reasonable development in the greater Patapsco Watershed.

If all the Amendments are adopted, CB-38 is more tolerable. As amended, the primary effects would still be::

- Establishing severe SWM design criteria for the entire HC Patapsco watershed that will make SWM systems more costly, while not helping the Main Street flooding in any material way
- Prohibiting waivers to any Forest Conservation requirements, including that needed to remove any 30"+ diameter trees. These are the so-called "specimen trees". Virtually all wooded sites have at least one specimen tree in the otherwise developable part of the site. Once you eliminate the floodplain, wetlands, wetland buffers, streams, stream buffers, steep slopes, scenic road buffers, perimeter buffers, and any historic set-aside areas, the remaining land is at times sprinkled with these larger trees. There has to be a way to remove some of these trees or a property could be rendered undevelopable. That's why it is allowed under state law and current county law, subject going through a justification process (i.e. a waiver).
- Elimination of the fee-in-lieu for SWM in the Patapsco watershed. I don't feel strongly about the FIL since I can't remember one time in 34 years we have used it on one of our projects.
- Creates a supplemental setback for the LOD from wetlands, waterways and steep slopes which would, in most cases, be in excess of what is already required. For small sites, it could be very difficult and limiting. For larger sites, it may not be as problematic, but effectively increasing the wetland buffer from 25' to 100' is a huge change for any sized property. There is also a glitch in the "Necessary Disturbance" provisions being authorized for the existing list (16.116.D(1)) but not the additional setbacks being proposed for the Patapsco watershed. For example, you could have a situation where the Necessary Disturbance is authorized for a

portion of the regular 25' wetland buffer but DPZ is not authorized to make the same determination for the newly added 75'. An example of this would be a sewer outfall connecting to an existing sewer running through the floodplain. Also, the proposed limitations on a Necessary Disturbance finding by DPZ would be too restrictive for real life situations (e.g. a pathway, sewer outfall, or SD outfall)

- Increases the checklist requirements for a Forest Conservation Plan. Not sure why these are being added. Don't like surprises.

In conclusion, CR 123 is all that is needed in the way of regulation changes. CB 38, even as amended, has over-reaching requirements that will not produce the hoped-for results of abating future flooding on Main Street. Please vote against CB 38.

Good evening

I am a professional engineer and a partner in an engineering firm that is very involved in Howard County. We help create a variety of projects in the county, including residential, commercial, industrial, and public. Many of these projects have floodplains, and all have stormwater facilities.

In college, I specialized in hydrology, floodplain analysis, and stormwater management, and have been involved in these fields ever since.

CB 38 appears to be about the Patapsco floodplain, and the so-called bottom-up flooding of lower Main Street in historic Ellicott City. As you must know, the 2016 and 2018 floods were of the top-down variety, and therefore not due to the backwater effect of the Patapsco.

I can assure you that the severe regulation of the Howard County half of the watershed will not make a material difference in the periodic flooding of the Patapsco. The remaining developable land, compared to the watershed size, is simply not enough to make a difference.

What CB 38 will do is render certain properties undevelopable, either in a practical sense, or in the case of properties defined as “Infill”, in an absolute sense. This extreme regulation will affect all types of development, and severely impact the shelter industry from providing much needed housing. The population is growing, and each person needs a roof over his or her head.

In addition to its unnecessary severity, CB 38 has flaws and unintended consequences. Please do not enact this Bill.

The Rockburn Land Trust was formed in 1989, and one of its primary purposes, as delineated in the Articles of Incorporation, is to promote for the benefit of the general public the preservation, protection and balanced use of natural resources principally in, but not limited to, the general area bounded by Ilchester Road, Landing Road, Montgomery Road, Route One and the Patapsco River... This area is completely within the Patapsco Lower North Branch Watershed as specified in CB38-2019.

From the perspective of RLT, CB38, through its elimination of many “waivers” and “fees in lieu of”, restores the strength of existing county regulations in protecting a particularly sensitive region of Howard County from increased storm water runoff and, simultaneously, preserves our forests for our enjoyment as well as for carbon capture. Any amendments to CB38 which, for example, might largely grandfather existing lots while still requiring some storm water management, will not substantially reduce the overall very positive impact of this bill.

At the same time, we acknowledge the pressure of economic development and the oft-repeated but seldom, if ever, quantified concern of the negative impact of environmental regulation. RLT promotes “think globally; act locally” and “think long-term; act short-term”. I support stronger legislation to protect the Old Ellicott City watershed, specifically in the form of CB 38. Allowing Beazer Homes to cram 79 units - nearly double the 44 units originally proposed - onto a 7-acre plot that's been squeezed amid other development that has occurred on Montgomery Road in recent years is a terrible idea that could result in life-threatening consequences for persons and property downstream.

While controlling runoff must be the priority, I have another bone to pick. How can another 160 vehicles be sent out onto a road that is already an F-minus in traffic flow anyway? The light at the entrance to Long Gate Shopping Center already functions poorly, and that's an major understatement.

I know another lane is coming to Route 103 between Long Gate Shopping Center and Old Columbia Pike, but even that improvement could never atone for the original, fatal mistake of building the Long Gate Shopping Center in such a way that only eastbound traffic can exit the center onto Route 100 and the rest of the traffic must use Route 103 to get to Route 29.

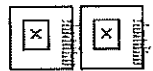

This testimony sent by email is a supplement to my testimony given orally and by email on September 16, 2019.

Email testimony from three people at 3819 Mulligan's Hill Lane expressed the view that a 20 unit development above their home had failures which contributed to damages to two homes on Mulligan's Hill Lane. As the president to the Taylor Properties Community Association responsible in part to maintain the storm water management for the 20 unit Autumn Overlook development on College Avenue, I want to advise you that the claims made in these three email testimonies are not founded in fact. There has never been any failure of any stormwater management facility at Autumn Overlook, even in the two terrible floods of 2016 and 2018. This development was approved prior to the 2016 flood and all required stormwater management features are included.

The facts of this development are similar to those of other parts of the Taylor Properties Community Association:

- The stormwater management facilities are maintained according to county standards.
- Less water and better water quality leave the developed property than had the area been left undeveloped.
- The properties abut areas maintained forever as forest conservation.
- The open space of the properties abut the state park which abuts the railroad tracks before any runoff heads to the Patpasco River.
- The properties preserved over 50% of open space and forested lands as well as steep slopes.
- This development and other parts of the Taylor Properties Community Association are beneficial, not harmful to Ellicott City and Howard County. It provides environmentally sensitive homes. It contributes to the County tax base. Its residents provide welcome diversity and workforce for the County and community.

The two major floods created significant rainfall which damaged many properties in and of itself, regardless of any runoff reaching other properties. It is unfair to say that these modern developments with proper stormwater management caused any damage to these homes and that future developments should be stopped. Older development, prior to the 1980's, of College Avenue and the homes around it, with next to no stormwater management, along with the direct impact of the storms themselves, contributed to the damages.

As I noted in my testimony previously, no extension of time is needed for the moratorium of CB 56 already on extension. The moratorium has been bad for Ellicott City in that it has delayed projects which will help flood management and the economy while forever preserving sensitive environments. CB 38, if enacted in any form, will hurt not help Ellicott City and many other parts of the County.

In summary, we urge you to vote against CB 38 & CB 40 which will have a negative impact on Ellicott City, the County and its residents.

My name is Burnet Chalmers. I live at 6560 Belmont Woods Road, Elkridge, MD 21075. I'm a lifelong resident of Howard County.

Please – all council members – support CB-38 or a slightly amended version as may be needed so that you can support it.

Our zoning process has evolved to the point where waivers, fees in lieu of and various exceptions seem to be common practice. Exceptions and waivers should be occasional, not a matter of course. Fees in lieu of should be extremely rare or, perhaps, non-existent.

In 1972 Hurricane Agnes caused extreme flooding in our area. It inflicted extensive damage in the Patapsco River Valley, including Ellicott City and Elkridge. After Agnes, Howard County took a strong leadership position developing storm water laws and regulations. One of my daughters is a wetlands specialist with Vermont Department of Natural Resources. She told me that Vermont and several other states modelled their laws and regulations after those developed here after Agnes. She asked what went wrong that allowed such intensive development in our area that contributed to devastating flooding of Ellicott City twice in recent years. My answer was that, very sadly, many years of waivers, fees in lieu of and various other exceptions took the teeth out of our laws and regulations. One example is the apparent disregard of Maryland's Forest Conservation Act by Howard County DPZ.

The word radical means return to basics or roots. A dictionary example is "a radical overhaul of the existing regulatory framework." Once far off course, radical action is needed to return to basics or roots.

You are a fresh group of new County Council Members.

- Please take a fresh look at the mess you have inherited in our DPZ process.
- Please work together to resolve it by supporting CB-38 or an amended version as you deem necessary.
- Please get Howard County back to basics; back to its roots of good stewardship.
