Dear Council Chair Rigby and Council Members:

I am writing to address three of the six amendments that have been proposed to CB 42. The Commission would like to extend its appreciation to the Council for its thoughtful consideration of the impact of CB 42 on housing for people with lower incomes in the County – its retail workers, health care workers, police officers, fire fighters, and others who do not earn enough to find decent and affordable housing in their county. Some of the proposed amendments will help in solving the housing affordability crises while others do not go far enough.

<u>Amendment 1</u>: Reducing the surcharge for MIHUs in excess of the minimum number will certainly not hinder additional production, however, it is unlikely to help. Very few developments contain more than the minimum number of MIHUs. The lower rate would not seem to be an adequate incentive for the creation of more units. We would prefer to see the amendment go further and keep the surcharge for all MIHUs at the existing \$1.32 rate. Otherwise, the County will be increasing the tax on affordable units and therefor on those who can least afford it.

<u>Amendment 2</u>: We very much appreciate that the amendment will reduce the increase of the surcharge on affordable units. This is certainly better than the full amount, however, we continue to strongly believe that any increase in the surcharge will result in a reduction in the number of affordable units that will be created in the County, adding to the housing affordability crises rather than assisting in its resolution. As we have noted previously, the higher surcharge will be paid with County and State funds that would otherwise go to the production and preservation of affordable housing. In effect, this would shift funding from assisting people with low incomes to paying for schools in one of the wealthiest County's in the Country. We respectfully request that the surcharge be maintained at \$1.32 for affordable housing units.

<u>Amendment 3</u>: The Commission fully supports Amendment 3. This amendment maintains the existing \$1.32 surcharge for affordable housing projects that are underway and ensures that developments such as Artists Flats (Toby's) and Robinson Overlook will move forward.



The Commission is not taking a position on the remaining three amendments.

FINANCIAL IDEA - How about quantifying every exemption you need, for example affordable units, and take that amount and add it to the market unit increase? Otherwise, we will keep robbing Peter (literally here) to pay Paul. :)

REGIONAL NEED - We should be charging different rates per region, and for different types of development. The need for regional labels to apply to project forecasts was proven by the example of River Watch which was done for other reasons, which then proved the forecast wrong, and higher. The answer there is that when you do a review of a particular project it is off, but the county average of the type of unit is okay? Then why aren't we charging regional fees? Building is crowded areas should cost more. Traffic remediation requirements are done by specific need. We need to define regional education impact to be fair.

MATH -

Hopefully, using 42% will get a decent increase derived. Putting a lot of stock in this configuration though, is dangerous without changing how it is derived. We know many data analysis problems exist there. Please request that the school system provide regional averages, and not per unit information that are by definition countywide averages. Please insist there be alterations for 2 and 3 bedroom units, or define them as separate types of units. An "apartment" is not enough of a label, when 2 and 3 bedrooms are practically more units.

How much data do you need to know this common sense situation? More bedrooms mean more students, there is no question, likely close to the exact multiplier, three bedrooms, three times more kids, and if there aren't many of those, there are certainly still plenty of two bedroom apartments.

Thank you for verifying with Renee Komen how the chart is derived to estimate student enrollment from resales. She pretty much confirmed that the resale number is inflated, so 42% is NOT an underestimate at all, given after ONE year (I was previously told two), is no longer "new".

Given that label change, how on earth could development produced student NOT decrease every year, regardless of the truth? They also do not take the same students from that originally "new" and keep them labeled as "new" when going forward to do these snapshots. The students were brought from new development, and go forward, mostly, to grade 12, relabeling them doesn't change that.

AFFORDABLE -

Thank you for separating the protection of current project financing with grandfathering, and on-going projects that need to have rates established and known, and not just exempted. Having the rate of impact fee much HIGHER than the fee-in-lieu of providing affordable housing DOES give incentive to

PROVIDE them countywide, versus the opposite opinion that was stated. Thank you for your careful attention to the fees in lieu and not create incentives that conflict, and addressing alternative compliance as a factor to address.

Please consider again the regional aspect of what you want to do with affordable incentives, as we don't want to continue to concentrate and in the most crowded schools as well.

If you are going to compare what Montgomery County does with exemptions please remember they charge the highest rates in the state overall.

GRANDFATHERING -

You are trying to amend a serious problem in the School System. You have goals to fix several problems in the School System. Predictability is always considered for developers. It has become an issue in the County that many are upset about individual homeowners not having that same consideration. County officials have taken a strong stand that this is something to be sacrificed when we have to implement important County goals. Maybe we should think about having a little more room on the side of less profit, to fund our school system, and grandfather at permit granting, after all, we should be in this all together, developers included. I was told by an attorney that the last step in MD law is construction beginning not permit granting.

PHASE-IN - that would be entirely inappropriate. Predictability is one thing, but we have been working on this for so very long, and all who are in this situation, have been expecting this for a very long time. We have allowed woefully low fees for so long, figuring out grandfathering is enough of a safeguard to financial fairness, we should not even consider phasing in of the increased fee.

Thank for the extensive amount of time you devote to your elected "part time" positions.

I implore you to NOT make a bad situation in Howard County even worse. Please table or not approve CB-42 and CB-50.

I believe there is a simple and understandable calculation that MUST be done and discussed, but which I never hear/read "publically" promoted:

Total enrolled HCPSS students/ Total Ho. Co. housing units.

Whenever I "play with numbers" I get a result close to 0.50.

That is, for every household, the "yield" is ½ student.

Thus, for every 4 households, the expected yield is 2 students (doesn't matter if this is 2 kids in one family or 1 kid in 2 families).

Following from that, when "we" add 2000 housing units, Ho. Co. should be planning (and funding) 1000 new school seats...yes, each year.

The existing housing base "is what it is" and taxes from all household (and businesses) support ALL operating costs and MOST capital costs.

Both the "matching principle" and "specific identification" principle of accounting lend support to charging new development for NEW school seats.

School seats are a "step function", not an average cost curve.

"Portables" (or whatever name might be used now) should be the "flex factor" within each "step"; they are not the LT answer. Yet they have been overused by Ho. Co. during the past 20 years.

By not collecting appropriate development impact fees for schools (and then leveraging the additional debt capacity created) to build brick and mortar schools in a timely manner, "we" have created the dire situation HC/HCPSS finds itself in. We are where we are in large part BECAUSE we have not collected sufficient fees. "We" survive, but unhappily so, with thousands of kids in less than ideal classrooms in parking lots and on playgrounds and many schools running beyond the 90-110% capacity "sweet spot."

"We" MUST collect school impact fees that approximate the fees that our "close neighbors", Montgomery County and PG county collect.

The fees in CB-42 (<\$7/sq.ft.) and the many exemptions are dangerous!

It is irrelevant that "the percentage increase is too high." This is a MISTAKE of prior years that MUST be fixed NOW. IMO, developers know a good thing when they see it/have it. They are certainly behaving in their economic self-interest to want to keep fees low. They know "HC is on sale." (Note, I am not saying it is "for sale.") OF COURSE they want to build in HC—it is so much cheaper and therefore better for their bottom line. The "amenity" of HCPSS makes building here a compelling "value proposition."

Are material costs to build in Fulton vastly different than material costs across the Patuxent River in Burtonsville? Even if land costs – and fees – are more in Mont. Co., that difference in CGS (cost of goods sold) SHOULD NOT be "financed" by Ho. Co., in part, through drastically lower impact fees here.

I am not against all development. I am for good development that covers the incremental costs that it brings to Howard County. We do need any "new" tax base to help pay for overall operating funds.

I discussed these points last Wed. 10/30 with my D1 Council Rep., Liz Walsh. I am happy to provide further comments. Carolan Stansky

"Replacement schools" have the benefit of lower cost due to existing land, but come with high constructions costs YET low number of "new" seats when existing school buildings reach the end of usefulness—whether due to age or "early obsolescence" due to construction decisions (eg. WLHS)/wear (eg. EMMS)/community issues (eg. TSES; was WLMS in all 3?). The general Ho. Co. tax base supports ALL annual operating costs of all schools—and county government, ALL capital costs (repairs/renovations) of existing schools and county buildings, and ALL capital costs of replacement schools and county facilities. Thus, given the huge (and frankly, now unaffordable) CIP "wish list", Ho. Co. MUST BEGIN to collect substantial funds from ANY and ALL new construction. PLEASE set development fees closer to our neighboring counties. No one has justified what Howard County is "on sale" to developers of new housing. Note 3: Each student eventually needs 3 seats from a capital cost perspective—one ES, one MS, then one HS. I would be happy to charge "just" the cost of an ES seat (which is much cheaper than a HS seat!)

Note 4: I read the Urban Analytics report this summer and was appalled by the assumptions and thus the conclusions!

PTA Council of Howard County Legislative Update On CB-42 - Setting the school surcharge rate.

On September 3, 2019 the PTA Council voted unanimously to support the following position.... "The PTA Council of Howard County is reaffirming its position among the delegates of the 2019-2020 school year to support legislation to provide appropriate and accurate mitigation from additional household construction to sustain capital projects to accommodate enrollment growth impacts with permanent school facilities for each grade level within the county."

The position above shows an endorsement of CB-42 in principle if the rates set are accurate to completely mitigate the impacts of additional new construction at whichever rate it occurs. The decisions implemented in CB-42 are critical to the immediate and long-term ability to provide education in Howard County without a decline in service quality.

Information provided in various work sessions indicated that the capital improvement plan used in formulas does not provide the capacity necessary to accommodate growth and some formulas rely on assumptions that the school system will not perform redistricting, which is also actively in process. These combined with other factors may lead toward a less accurate setting of one-time rates which could negatively affect the intent.

On Thursday, October 31st 2019, six amendments were filed to be considered in a vote by the county council scheduled for the evening of November 4th 2019. These include surcharge rate reductions for specific construction types and delayed implementation of the rates set by CB-42.

Regardless of the concerns about the calculation of the base rate per square foot which need to be addressed, the working assumption has been that the base rate initially set in CB-42 would be sufficient to meet the impact of new development. Each amendment which lowers or delays setting base surcharge rates results in a definitive net loss by design of capital project revenue to meet minimum goals to provide adequate educational capacity.

The PTACHC has not yet declared a position on the intent to provide affordable housing incentives, business predictability or Downtown Columbia development goals set forth in new amendments, but the term "accurate" in PTACHC's position statement clearly denotes that any additional rate reductions for initiatives require proportionately higher base school surcharge rates to meet the cumulative capacity needs of growth. Otherwise, these additional amendments are not supported for inclusion as a detriment to the declared goal and intent of the legislation.

All PTACHC members, families and educational support staff are directly impacted by systemic capacity shortcomings and redistricting efforts to adjust capacity utilization. It is with this in mind that we respectfully request consideration of the described factors to deliver a demonstrable result which completely resolves a specific capacity problem fully within the Howard County's authority to implement. PTACHC delegates representing all school districts will convene the same night as the council vote on November 4th to discuss and review the outcome, budgetary impact to education and responses.

It is apparent that the county council is trying to avoid voting on CB-42, and are looking for reasons to continue with the delay to the continued benefit of housing developers. Howard County schools have been shortchanged by the developers for years, with the educational adequacy falling farther and farther behind as a result. Developers fees need to be increased now, not next year or later. The county council should be working on behalf of the residents of the county, to maintain the features that make Howard County a desirable place to live. Instead, overcrowding of the route1 corridor, with inadequate support structures has continued as the fees to increase these structures (schools, fire, police...) has continued, only to benefit the builders who pay fees that are below what they need to be.

Howard County staff and leadership:

I urge you to reconsider the proposed school facilities charge. As a builder that has been active in Howard County for years, Toll Brothers has admired the willingness to work with and support the building industry.

The proposed increase to the surcharge is excessive. These costs cannot simply be borne by builders. In time, they will be passed on to your future residents and landowners, further impacting affordability in a market that is already struggling to provide attainable housing. At the very least, any consideration like this should include all stakeholders and the leadership in Howard County should listen carefully. If no grandfather clause is adopted, then builders will bear the burden of 100% of this new cost in the near to mid-term. This is in stark contrast to the careful and thoughtful partnership that has existed for years.

I understand why the charge is being proposed and the need, but just ask that you consider a more measured approach that includes some form of a grandfather clause, a delay in the imposition of the new fee, a scaled up fee over a set number of years or some combination of all 3.

In the end, its not just the new fee structure, but the way its being considered, and the <u>lack of certainty</u> related to the future, that will cause builders and landowners to be more leery of Howard County.
